## A BILL TO BE ENTITLED 1 AN ACT 2 relating to the creation of and funding for the Texas 3 Entrepreneurship Network. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 4 5 SECTION 1. Subtitle F, Title 4, Government Code, is amended by adding Chapter 490 to read as follows: 6 7 CHAPTER 490. TEXAS ENTREPRENEURSHIP NETWORK Sec. 490.001. DEFINITIONS. In this chapter: 8 (1) "Fund" means the Texas Entrepreneurship Network 9 10 fund. 11 (2) "Network" means the Texas Entrepreneurship 12 Network. (3) "Entrepreneur" means an individual who has a 13 14 business or an idea for a business, who registers with the Network. Sec. 490.002. ESTABLISHMENT OF NETWORK. (a) The Texas 15 16 Entrepreneurship Network is established to develop and diversify the economy of this state through: 17 18 (1) the provision of programs and services to facilitate the growth and success of entrepreneurs; and 19 (2) The statewide, results-driven collaboration of 20 21 public and private entities to create jobs and energize sustainable 22 local economies through the development of entrepreneurs in this 23 state. (b) The Office of Rural Community Affairs shall administer 24

## 1 the Fund.

2 (c) By agreement with the Office of Rural Community Affairs, 3 the Texas Center for Rural Entrepreneurship will create and operate 4 the Network according to the provisions of this Act taking into 5 consideration all reasonable and customary oversight measures 6 required by the Office of Rural Community Affairs.

7 (d) The Texas Center for Rural Entrepreneurship shall 8 establish an advisory board to guide and advise the operations of 9 the Network. The advisory board shall have representation from each of the founding members of the network listed in Section 10 490.003(a), and at least one member from the private sector. The 11 12 initial board shall adopt provisions to define board member term, term staggering, and other provisions necessary to administer the 13 board. The members of the board shall participate without 14 15 compensation other than reimbursement for reasonable and customary travel expenses for meetings related to the Network. 16

## Sec. 490.003. MEMBERS OF NETWORK. (a) The founding members of the network are: (1) the Texas Cooperative Extension of the Texas A&M

1	(7) the Texas Center for Rural Entrepreneurship; and
2	(8) the Texas Economic Development Council.
3	(b) An institution of higher education, chamber of
4	commerce, economic development corporation, business, or
5	organization with an interest in promoting entrepreneurship may
6	join the network. Organizations other than the founding members
7	specified in Section 490.003(a) do not automatically have seats on
8	the advisory board. Additional seats may be created on the board
9	only by a 2/3 majority vote of the board.
10	Sec. 490.004. GENERAL DUTIES AND GOALS. (a) The network
11	shall train and refocus existing State and local resources to build
12	a more prosperous, dynamic, and sustainable economy throughout this
13	state by:
14	(1) Providing coordinated training and services that
15	enhance the value of the State's existing infrastructure
16	investments and make them more available to entrepreneurs;
17	(2) developing a statewide network of
18	entrepreneurship developers and entrepreneurship centers to
19	organize and to support entrepreneur associations;
20	(3) developing a comprehensive network of knowledge,
21	leadership, and financial capital resources accessible through the
22	Network's entrepreneurship developers and entrepreneurship
23	centers;
24	(4) educating entrepreneurs and generating awareness
25	of the network and its programs;
26	(5) identifying the most promising ventures through
27	activities, including business-plan competitions, and assisting

1	the ventures' potential for job and wealth creation;
2	(6) developing evaluation methods to measure the
3	effectiveness of the network and impact of entrepreneurship on
4	local and regional economies;
5	(7) developing best practices for successful
6	entrepreneurship and applied research regarding critical success
7	factors for entrepreneurial businesses to provide a strategic
8	competitive advantage for businesses in this state;
9	(8) collaborating with existing local, state, and
10	federal agencies and economic development professionals to use the
11	strengths and assets of the agencies and professionals.
12	(b) The network shall work locally, regionally, and
13	statewide with educators, agencies, organizations, networks,
14	businesses, economic developers, consultants, communities,
15	researchers, or other persons to develop and support strategies to
16	assist entrepreneurs and improve the environment for
17	entrepreneurial development in this state.
18	Sec. 490.005. ENTREPRENEURSHIP SERVICES. (a) The network
19	shall develop a statewide association of local individuals who are
20	entrepreneurship developers trained to analyze, evaluate, and
21	develop business plans and help local entrepreneurs start, grow, or
22	develop their businesses.
23	(b) The network may establish local entrepreneurship
24	centers in every county practicable at which entrepreneurs may
25	access necessary support and online resources and programs
26	developed and provided by the network. In establishing the
27	entrepreneurship centers, the network shall use existing

1	infrastructure, public and private organizations, and other
2	resources, including chambers of commerce, universities and
3	community colleges, County Extension offices, Texas Workforce
4	Commission offices, and local business offices.
5	(c) The network shall adopt requirements for
6	entrepreneurship centers. An organization must meet the
7	requirements adopted under this subsection before hosting an
8	entrepreneurship center.
9	(d) A group of individuals who have services, resources, or
10	expertise to offer entrepreneurs may agree to provide services
11	through the network as part of an entrepreneurship force.
12	Sec. 490.006. NETWORK PROGRAMS. The network may develop:
13	(1) Programs for:
14	(A) business plan development, competitive
15	enhancement, and management skills development;
16	(B) entrepreneurship best practices training;
17	(C) entrepreneurship education in primary and
18	secondary schools and community colleges;
19	(D) expanding entrepreneurship in workforce
20	development programs;
21	(E) accessing sources of start-up and growth
22	capital; and
23	(F) training and assisting entrepreneurship
24	agents who facilitate and assist entrepreneurial efforts; and
25	(G) community readiness preparation and
26	evaluation, and community planning.
27	(2) methods for helping entrepreneurs access other

1	loan, guarantee, and grant programs;
2	(3) necessary policies and regulations; and
3	(4) collaborations with other entities.
4	Sec. 490.007. TEXAS ENTREPRENEURSHIP NETWORK FUND. (a)
5	The Texas Entrepreneurship Network Fund is an account in the
6	general revenue fund.
7	(b) The following amounts shall be deposited in the fund:
8	(1) any amounts appropriated by the legislature for
9	the fund; and
10	(2) gifts, grants, and other donations received for
11	the fund.
12	(c) The fund may be used only for network purposes, subject
13	to Section 490.008.
14	(d) The network may solicit and accept gifts and grants for
15	the fund from public and private universities and all other public
16	and private entities.
17	Sec. 490.008. USE OF FUND. (a) Money appropriated to the
18	fund by the legislature shall be used for:
19	(1) programs related to local entrepreneurship
20	centers, training, and entrepreneurship developers;
21	(2) curriculum development, infrastructure, data
22	management, and research; and
23	(3) technology and economic development research
24	centers of excellence;
25	(4) the network's overhead expenses; and
26	(5) other activities necessary to accomplish the
27	mission of this chapter.

1	(b) The amount of money appropriated to the fund by the
2	legislature that remains after being used as provided by Subsection
3	(a) shall be distributed as enhanced funding for existing
4	entrepreneurship programs of the universities affiliated with an
5	entity included as a network member under Section 490.003(a).
6	SECTION 2. This Act takes effect September 1, 2005.
