5	SECTION 1. Section 43.851, Local Government Code, is
6	amended by adding Subdivision (2-a) to read as follows:
7	(2-a) "Affected unincorporated area" means the
8	unincorporated area located within the circumference of a circle,
9	the center of which is the intersection of State Highways 87 and 12
10	in Newton County, and the radius of which is six miles.
11	SECTION 2. Sections 43.852, 43.853, and 43.854, Local
12	Government Code, are amended to read as follows:
13	Sec. 43.852. ANNEXATION PROCEDURES. Notwithstanding
14	Section 43.052(h), an affected municipality may not annex all or
15	part of <u>an affected unincorporated</u> [ <del>the</del> ] area [ <del>located within the</del>
16	Mauriceville boundary] unless the affected municipality:
17	(1) includes the <u>affected unincorporated</u> area in its
18	municipal annexation plan; and
19	(2) complies with:
20	(A) Sections 43.052(a)-(g) and (i)-(j);
21	(B) Section 43.853; and
22	(C) other provisions of law relating to
23	annexation.
24	Sec. 43.853. NOTICE: INCLUDING AREA IN PLAN. (a) An

affected municipality that adopts or amends its municipal 1 2 annexation plan to include all or part of an affected area [located within the Mauriceville 3 unincorporated [the] 4 boundary] must comply with this chapter and all other requirements 5 of law relating to the adoption or amendment of a municipal 6 annexation plan.

Before the 90th day after the date an affected 7 (b) 8 municipality adopts or amends its municipal annexation plan to 9 include all or part of the affected unincorporated area [located within the Mauriceville boundary], the municipality shall post a 10 notice of the proposed annexation in at least three public places 11 within the affected unincorporated area [Mauriceville boundary]. 12 The notice must remain posted for at least seven consecutive days. 13 14 The first day of posting must occur before that 90th day.

15 (c) On or before the 90th day after the date an affected 16 municipality adopts or amends its municipal annexation plan to 17 include all or part of the affected unincorporated area [located within the Mauriceville boundary], the municipality shall publish a 18 notice of the proposed annexation in at least two newspapers of 19 general circulation within the affected unincorporated area 20 21 [Mauriceville community]. The municipality shall publish a second notice in the same manner not less than 7 days and not more than 14 22 days after the first notice is published. 23 If the affected 24 unincorporated area is located within the Mauriceville boundary, the municipality shall publish the notice as provided by this 25 26 subsection in at least two newspapers of general circulation within the Mauriceville community. 27

Sec. 43.854. NOTICE: REMOVING AREA FROM PLAN. (a) An affected municipality that adopts or amends its municipal annexation plan to remove all or part of <u>an affected unincorporated</u> [the] area [located within the Mauriceville boundary] must comply with this chapter and all other requirements of law relating to the adoption or amendment of a municipal annexation plan.

7 (b) Before the 90th day after the date an affected 8 municipality adopts or amends its municipal annexation plan to remove all or part of the affected unincorporated area [located 9 within the Mauriceville boundary], the municipality shall post a 10 notice of the removal in at least three public places within the 11 affected unincorporated area [Mauriceville boundary]. The notice 12 must remain posted for seven consecutive days. The first day of 13 14 posting must occur before that 90th day.

15 (c) On or before the 90th day after the date an affected 16 municipality adopts or amends its municipal annexation plan to 17 remove all or part of the affected unincorporated area [located within the Mauriceville boundary], the municipality shall publish a 18 notice of the removal in at least two newspapers of general 19 circulation within the affected unincorporated area [Mauriceville 20 21 community]. The municipality shall publish a second notice in the same manner not less than 7 days and not more than 14 days after the 22 first notice is published. If the affected unincorporated area is 23 24 located within the Mauriceville boundary, the municipality shall 25 publish the notice as provided by this subsection in at least two 26 newspapers of general circulation within the Mauriceville 27 community.

SECTION 3. Section 43.855(a), Local Government Code, is
amended to read as follows:

3 (a) Except as provided by Subsection (b), if an application
4 or petition to incorporate all or part of <u>an affected</u>
5 <u>unincorporated</u> [the] area [within the Mauriceville boundary] is
6 filed with the county judge:

7 (1) a community may be incorporated within the
8 <u>affected unincorporated area</u> [Mauriceville boundary] under the
9 procedures prescribed by law; and

10 (2) the county judge shall order an incorporation11 election under the procedures prescribed by law.

SECTION 4. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2005.
