NOTICE: INCLUDING AREA IN PLAN. 1 (a) An 2 affected municipality that adopts or amends its municipal 3 plan to include all or part of an affected unincorporated [the] area [located within the Mauriceville 4 5 boundary] must comply with this chapter and all other requirements 6 of law relating to the adoption or amendment of a municipal 7 annexation plan.

- (b) Before the 90th day after the date an affected municipality adopts or amends its municipal annexation plan to include all or part of the <u>affected unincorporated</u> area [located within the Mauriceville boundary], the municipality shall post a notice of the proposed annexation in at least three public places within the <u>affected unincorporated area</u> [Mauriceville boundary]. The notice must remain posted for at least seven consecutive days. The first day of posting must occur before that 90th day.
- municipality adopts or amends its municipal annexation plan to include all or part of the <u>affected unincorporated</u> area [located within the Mauriceville boundary], the municipality shall publish a notice of the proposed annexation in at least two newspapers of general circulation within the <u>affected unincorporated area</u> [Mauriceville community]. The municipality shall publish a second notice in the same manner not less than 7 days and not more than 14 days after the first notice is published. <u>If the affected unincorporated area is located within the Mauriceville boundary, the municipality shall publish the notice as provided by this subsection in at least two newspapers of general circulation within</u>

the Mauriceville community.

- Sec. 43.854. NOTICE: REMOVING AREA FROM PLAN. (a) An affected municipality that adopts or amends its municipal annexation plan to remove all or part of an affected unincorporated [the] area [located within the Mauriceville boundary] must comply with this chapter and all other requirements of law relating to the adoption or amendment of a municipal annexation plan.
 - (b) Before the 90th day after the date an affected municipality adopts or amends its municipal annexation plan to remove all or part of the <u>affected unincorporated</u> area [located within the Mauriceville boundary], the municipality shall post a notice of the removal in at least three public places within the <u>affected unincorporated area</u> [Mauriceville boundary]. The notice must remain posted for seven consecutive days. The first day of posting must occur before that 90th day.
 - municipality adopts or amends its municipal annexation plan to remove all or part of the <u>affected unincorporated</u> area [located within the Mauriceville boundary], the municipality shall publish a notice of the removal in at least two newspapers of general circulation within the <u>affected unincorporated area</u> [Mauriceville community]. The municipality shall publish a second notice in the same manner not less than 7 days and not more than 14 days after the first notice is published. If the affected unincorporated area is located within the Mauriceville boundary, the municipality shall publish the notice as provided by this subsection in at least two newspapers of general circulation within the Mauriceville

- 3 amended to read as follows:
- 4 (a) Except as provided by Subsection (b), if an application
- 5 or petition to incorporate all or part of an affected
- 6 <u>unincorporated</u> [the] area [within the Mauriceville boundary] is
- 7 filed with the county judge:
- 8 (1) a community may be incorporated within the
- 9 <u>affected unincorporated area</u> [Mauriceville boundary] under the
- 10 procedures prescribed by law; and
- 11 (2) the county judge shall order an incorporation
- 12 election under the procedures prescribed by law.
- SECTION 4. This Act takes effect immediately if it receives
- 14 a vote of two-thirds of all the members elected to each house, as
- 15 provided by Section 39, Article III, Texas Constitution. If this
- 16 Act does not receive the vote necessary for immediate effect, this
- 17 Act takes effect September 1, 2005.
