## A BILL TO BE ENTITLED

1 AN ACT

- 2 relating to the transfer of powers and duties over railroads from
- 3 the Railroad Commission of Texas to the Texas Department of
- 4 Transportation.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Effective October 1, 2005, Article 6445, Revised
- 7 Statutes, is amended to read as follows:
- 8 Art. 6445. POWER AND AUTHORITY. (a) Power and authority
- 9 are hereby conferred upon the Texas Department of Transportation
- 10 [Railroad Commission of Texas] over all railroads, and suburban,
- 11 belt and terminal railroads, and over all public wharves, docks,
- 12 piers, elevators, warehouses, sheds, tracks and other property used
- in connection therewith in this State, and over all persons,
- 14 associations and corporations, private or municipal, owning or
- operating such railroad, wharf, dock, pier, elevator, warehouse,
- shed, track or other property to fix, and it is hereby made the duty
- of the said  $\underline{\text{department}}$  [Commission] to adopt all necessary rates,
- 18 charges and regulations, to govern and regulate such railroads,
- 19 persons, associations and corporations, and to correct abuses and
- 20 prevent unjust discrimination in the rates, charges and tolls of
- 21 such railroads, persons, associations and corporations, and to fix
- 22 division of rates, charges and regulations between railroads and
- other utilities and common carriers where a division is proper and
- 24 correct, and to prevent any and all other abuses in the conduct of

- 1 their business and to do and perform such other duties and details
- 2 in connection therewith as may be provided by law.
- 3 (b) All powers and duties of the Railroad Commission of
- 4 Texas that relate to railroads and the regulation of railroads are
- 5 transferred to the Texas Department of Transportation.
- 6 (c) A reference in law to the Railroad Commission of Texas
- 7 that relates to railroads and the regulation of railroads means the
- 8 Texas Department of Transportation.
- 9 SECTION 2. (a) On October 1, 2005:
- 10 (1) all powers, duties, obligations, rights,
- 11 contracts, leases, records, assets, property, funds, and
- 12 appropriations of the Railroad Commission of Texas that relate
- 13 primarily to railroads and the regulation of railroads are
- 14 transferred to the Texas Department of Transportation;
- 15 (2) all rules, policies, forms, procedures, and
- 16 decisions of the Railroad Commission of Texas that relate primarily
- 17 to railroads and the regulation of railroads are continued in
- 18 effect as rules, policies, forms, procedures, and decisions of the
- 19 Texas Department of Transportation, until superseded by a rule or
- 20 other appropriate action of the Texas Department of Transportation;
- 21 and
- 22 (3) any investigation, complaint, action, contested
- 23 case, or other proceeding involving the Railroad Commission of
- 24 Texas that relates primarily to railroads and the regulation of
- 25 railroads is transferred without change in status to the Texas
- 26 Department of Transportation, and the Texas Department of
- 27 Transportation assumes, without a change in status, the position of

- 1 the Railroad Commission of Texas in any investigation, complaint,
- 2 action, contested case, or other proceeding that relates primarily
- 3 to railroads and the regulation of railroads involving the Railroad
- 4 Commission of Texas.
- 5 (b) The transfer of the powers and duties of the Railroad
- 6 Commission of Texas that relate primarily to railroads and the
- 7 regulation of railroads to the Texas Department of Transportation
- 8 does not affect the validity of a right, privilege, or obligation
- 9 accrued, a contract or acquisition made, any liability incurred, a
- 10 permit or license issued, a penalty, forfeiture, or punishment
- 11 assessed, a rule adopted, a proceeding, investigation, or remedy
- 12 begun, a decision made, or other action taken by or in connection
- 13 with the Railroad Commission of Texas.
- 14 SECTION 3. (a) As soon as possible after the effective date
- of this Act but before October 1, 2005, the Railroad Commission of
- 16 Texas shall determine and report to the Texas Department of
- 17 Transportation on:
- 18 (1) which obligations, contracts, records, assets,
- 19 and property of the Railroad Commission of Texas relate primarily
- to railroads and the regulation of railroads; and
- 21 (2) which employees of the Railroad Commission of
- 22 Texas perform duties that relate primarily to railroads and the
- 23 regulation of railroads.
- 24 (b) After the Texas Department of Transportation receives
- 25 the report required under Subsection (a) of this section, the Texas
- 26 Department of Transportation shall determine before October 1,
- 27 2005, whether an employee of the Railroad Commission of Texas that

- 1 performs duties primarily related to railroads and the regulation
- 2 of railroads shall:
- 4 (2) be required to reapply for an employment position
- 5 with the department; or
- 6 (3) be terminated.
- 7 SECTION 4. Except as provided by Section 1 of this Act, this
- 8 Act takes effect immediately if it receives a vote of two-thirds of
- 9 all the members elected to each house, as provided by Section 39,
- 10 Article III, Texas Constitution. If this Act does not receive the
- 11 vote necessary for immediate effect, this Act takes effect
- 12 September 1, 2005.
