4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subchapter A, Chapter 161, Health and Safety
6	Code, is amended by adding Section 161.0052 to read as follows:
7	Sec. 161.0052. IMMUNIZATION OF ELDERLY PERSONS BY HOSPITALS
8	AND ONGOING CARE FACILITIES. (a) In this section:
9	(1) "Elderly person" means a person who is 65 years of
10	age or older.
11	(2) "Hospital" has the meaning assigned by Section
12	241.003.
13	(3) "Ongoing care facility" means a health care
14	facility that provides ongoing medical care to elderly persons,
15	including:
16	(A) a physician's office;
17	(B) a public health clinic;
18	(C) a hemodialysis center;
19	(D) a hospital specialty-care clinic; and
20	(E) an outpatient rehabilitation center.
21	(b) The executive commissioner of the Health and Human
22	Services Commission by rule shall require a hospital to inform each
23	elderly person admitted to the hospital for a period of 24 hours or
24	more that the pneumococcal and influenza vaccines are available.

If the elderly person requests a vaccine, the hospital must make the 1 2 vaccination available to the person before the person is discharged 3 from the hospital. 4 (c) The executive commissioner of the Health and Human 5 Services Commission by rule shall require an ongoing care facility to offer, to the extent possible as determined by the facility, the 6 7 opportunity to receive the pneumococcal and influenza vaccines to 8 each elderly person who receives ongoing care at the facility. If 9 the facility decides it is not feasible to offer the vaccine, the 10 facility must provide the person with information on other options 11 for obtaining the vaccine. 12 (d) Rules adopted under this section must require that: (1) a hospital or ongoing care facility: 13 14 (A) offer the influenza vaccine in October and 15 November, and if the vaccine is available, December; and 16 (B) offer the pneumococcal vaccine year-round; 17 and 18 (2) a person administering a vaccine: 19 (A) ask whether the elderly person is currently vaccinated against the influenza virus or pneumococcal disease, as 20 21 appropriate; 22 (B) administer the vaccine under institution-approved or physician-approved protocols after making 23 24 an assessment for contraindications; and

(e) In adopting rules under this section, the executive
