- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 4 SECTION 1. Section 87.022, Election Code, is amended to

- 6 Sec. 87.022. TIME OF DELIVERY: GENERAL RULE. Except as
- 7 provided by Section 87.0221, <u>87.0222</u>, 87.023, or 87.024, the
- 8 materials shall be delivered to the early voting ballot board under
- 9 this subchapter during the time the polls are open on election day,
- 10 or as soon after the polls close as practicable, at the time or
- 11 times specified by the presiding judge of the board.
- 12 SECTION 2. Subchapter B, Chapter 87, Election Code, is
- amended by adding Section 87.0222 to read as follows:
- 14 Sec. 87.0222. TIME OF DELIVERY: BALLOTS VOTED BY MAIL. (a)
- 15 Notwithstanding Section 87.024, in an election conducted by an
- authority of a county with a population of 100,000 or more or
- 17 conducted jointly with such a county, the jacket envelopes
- 18 containing the early voting ballots voted by mail may be delivered
- 19 to the board between the end of the ninth day before election day
- 20 and the closing of the polls on election day, or as soon after

- 4 (c) At least 24 hours before each delivery, the early voting

- 6 nominee on the ballot of the time the delivery is to be made.
- 7 SECTION 3. Section 87.027, Election Code, is amended by
- 8 amending Subsection (i) and adding Subsection (l) to read as

The signature verification committee shall compare the 10 signature on each carrier envelope certificate, except those signed 11 12 for a voter by a witness, with the signature on the voter's ballot application to determine whether the signatures are those of the 13 14 same person. The committee may also compare the signatures with the 15 signature on the voter's registration application to confirm that the signatures are those of the same person but may not use the 16 17 registration application signature to determine that signatures are not those of the same person. Except as provided by 18 Subsection (1), a [A] determination under this subsection that the 19 signatures are not those of the same person must be made by a 20 majority vote of the committee's membership. The committee shall 21 place the jacket envelopes, carrier envelopes, and applications of 22 23 voters whose signatures are not those of the same person in separate
