including roads and related infrastructure, for a faculty office

building at The University of Texas Health Science Center at San

Antonio, to be financed by the issuance of bonds in accordance with

15 this subchapter, including bonds issued in accordance with a

systemwide revenue financing program and secured as provided by

that program, in an aggregate principal amount not to exceed \$20

19 (b) The board of regents may pledge irrevocably to the

20 payment of the bonds authorized by this section all or any part of

the revenue funds of an institution, branch, or entity of The

University of Texas System, including student tuition charges. The

abrogated while the bonds for which the pledge is made, or bonds
