2 relating to funding for the continuing education of certain peace

- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 772.006, Government Code, is amended by 6 adding Subsection (d) to read as follows:
- 7 (d) The criminal justice division shall administer a grant 8 program under which grants are awarded to support local law
- 9 enforcement agencies in this state in providing for the continuing
- 10 <u>education of persons licensed under Chapter 1701, Occupations Code.</u>
- 11 Amounts awarded under this subsection:
- (1) shall be based on need, as determined by the
- criminal justice division; and
- 14 (2) are in addition to amounts reimbursed under
- 15 Section 1701.157, Occupations Code.
- SECTION 2. Sections 1701.157(a) and (b), Occupations Code,
- 17 are amended to read as follows:
- 18 (a) Not later than March 1 of each calendar year, the
- 19 comptroller shall allocate money deposited during the preceding
- 20 calendar year in the general revenue fund to the credit of the law
- 21 enforcement officer standards and education fund account for
- 22 expenses related to the continuing education of persons licensed
- 23 under this chapter as follows:
- 24 (1) 20 percent of the money is allocated to [all] local

- 1 law enforcement agencies in this state that meet the eligibility
- 2 requirements described by Subsection (b) in equal shares; and
- 3 (2) 80 percent of the money is allocated to [all] local
- 4 law enforcement agencies in this state that meet the eligibility
- 5 requirements described by Subsection (b) in a share representing a
- 6 fixed amount for each position in the agency, as of January 1 of the
- 7 preceding calendar year, that is reserved to a person who:
- 8 (A) is licensed under this chapter;
- 9 (B) works as a peace officer on the average of at
- 10 least 32 hours a week; and
- 11 (C) is compensated by a political subdivision of
- 12 this state at least at the minimum wage and is entitled to all
- 13 employee benefits offered to a peace officer by the political
- 14 subdivision.
- 15 (b) To be eligible for an allocation of money under
- 16 <u>Subsection (a), a [Not later than November 1 of each calendar year,</u>
- 17 <u>each</u>] local law enforcement agency must [shall] report to the
- 18 comptroller not later than November 1 of the preceding calendar
- 19 <u>year:</u>
- 20 <u>(1)</u> the number of agency positions described by
- 21 Subsection (a)(2) reserved as of January 1 of the [that] year
- 22 covered by the report;
- 23 (2) the number of agency positions described by
- 24 Subsection (a)(2) filled as of January 1 of the calendar year
- 25 covered by the report;
- 26 (3) the percentage of any money received by the agency
- 27 under Subsection (a) in the calendar year covered by the report used

- by the agency during that year;
- 2 (4) the number of training hours received through the
- 3 use of any money received by the agency under Subsection (a) in the
- 4 <u>calendar year covered by the report; and</u>
- 5 (5) that the agency has complied with all applicable
- 6 laws regarding the use of any money received by the agency under
- 7 Subsection (a) in the calendar year covered by the report.
- 8 SECTION 3. (a) If funds are available for that purpose, the
- 9 criminal justice division of the governor's office shall award the
- 10 first grants under Section 772.006(d), Government Code, as added by
- 11 this Act, in the state fiscal year beginning September 1, 2005.
- 12 (b) The changes in law made by this Act to Section 1701.157,
- Occupations Code, apply to allocations made on or after January 1,
- 14 2006, for expenses incurred by local law enforcement agencies
- 15 during calendar year 2005.
- 16 SECTION 4. This Act takes effect September 1, 2005.
