3	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
4	SECTION 1. Subchapter E, Chapter 54, Education Code, is
5	amended by adding Section 54.5343 to read as follows:
6	Sec. 54.5343. STUDENT UNION FEE; THE UNIVERSITY OF TEXAS AT
7	TYLER. (a) If authorized under Subsection (b), the board of
8	regents of The University of Texas System may impose on each student
9	enrolled at The University of Texas at Tyler a student union fee for
10	the purpose of providing revenue for financing, constructing,
11	operating, maintaining, renovating, improving, or equipping a
12	student union building for the university. The fee may not exceed:
13	(1) \$100 per student for each semester or each summer
14	session of more than six weeks; or
15	(2) \$50 per student for each summer session of six
16	weeks or less.
17	(b) The board of regents may not impose a student union fee
18	under this section unless imposition of the fee is approved by a
19	majority of the university's students voting in a general student
20	election called for that purpose. The board of regents may not
21	increase the amount of the student union fee under this section by
22	more than 10 percent from one academic year to the next unless the
23	amount of the increase is approved by a majority of the university's
24	students voting in a general student election called for that

2 (c) The fiscal officer of The University of Texas at Tyler shall collect the fees imposed under this section and shall credit 3 4 the money received from the fees to an account known as The 5 University of Texas at Tyler student union fee account. The money 6 in the account may be used only for the purposes provided by Subsection (a) and shall be placed under the control of and subject 7 8 to the order of the Student Union Advisory Committee. The committee shall annually submit to the president of the university a complete 9 and itemized budget accompanied by a full and complete report of 10 all activities conducted during the preceding year and all 11 12 expenditures made in connection with those activities. The president shall submit the budget to the board of regents as part of 13 the institutional budget. The board of regents shall make the 14 15 changes in the budget as the board considers necessary before approving the budget and shall impose the fees in an amount 16 17 sufficient to meet the budgetary needs of the student union, subject to Subsection (b). 18

19 (d) The board of regents may pledge revenue from the fees
20 imposed under this section to pay obligations issued for authorized
21 purposes pursuant to the revenue financing system of The University
22 of Texas System.

(e) A student union fee imposed under this section is in
 addition to any other fee the board of regents is authorized by law
 to impose and may not be considered in determining the maximum
 student services fee that may be imposed under Section 54.503(b).

SECTION 2. Section 54.5343, Education Code, as added by

1 this Act, applies only to fees imposed for a semester or other 2 academic term that begins on or after the effective date of this 3 Act.

4 SECTION 3. This Act takes effect immediately if it receives 5 a vote of two-thirds of all the members elected to each house, as 6 provided by Section 39, Article III, Texas Constitution. If this 7 Act does not receive the vote necessary for immediate effect, this 8 Act takes effect September 1, 2005.
