- 8 PLANS. (a) In this section, "pharmacy benefit manager" has the
- 9 meaning assigned by Section 4151.151.
- 10 (b) A pharmacy benefit manager who administers pharmacy
- 11 benefits under a coverage plan under this chapter may not refer a
- 12 participant in the group benefits program to a mail order
- prescription plan that is owned by the pharmacy benefit manager.
- 14 (c) A pharmacy benefit manager who violates Subsection (b)
- is subject to sanctions as provided by Chapter 82.
- 16 SECTION 2. Subchapter D, Chapter 1575, Insurance Code, is
- amended by adding Section 1575.169 to read as follows:

- 19 PLANS. (a) In this section, "pharmacy benefit manager" has the

- 6 PLANS. (a) In this section, "pharmacy benefit manager" has the
- 7 meaning assigned by Section 4151.151.
- 8 (b) A pharmacy benefit manager who administers pharmacy
- 9 benefits under a coverage plan under this chapter may not refer a
- 10 participant in the program to a mail order prescription plan that is
- owned by the pharmacy benefit manager.
- (c) A pharmacy benefit manager who violates Subsection (b)
- is subject to sanctions as provided by Chapter 82.
- 14 SECTION 4. This Act applies to health benefit plans
- 15 provided under Chapters 1551, 1575, and 1579, Insurance Code,
- 16 beginning with the 2005-2006 plan year.
