- 4 SECTION 1. Section 701.051, Insurance Code, is amended to

- 7 day after the date the person makes the determination or reasonably
- 8 suspects that [A person who determines] a fraudulent insurance act
- 9 has been or is about to be committed in this state, the person:
- 10 (1) shall report the information in writing to the
- insurance fraud unit of the department, in the format prescribed by
- 12 the fraud unit or by the National Association of Insurance
- 13 <u>Commissioners; and</u>
- 14 (2) may also report the information to another [or an]
- 15 authorized governmental agency [not later than the 30th day after
- 16 the date the person makes the determination].
- (b) A report made to [one authorized governmental agency or]

- 6 Sec. 701.109. REQUEST FOR INVESTIGATION BY INSURER. (a)
- 7 An insurer who conducts [must complete] an independent
- 8 investigation of suspected insurance [claim] fraud is not required
- 9 to complete that investigation [and draft a report of the insurer's
- 10 **findings**] before requesting that the commissioner conduct an
- 11 investigation.
- 12 (b) When requesting the commissioner to conduct an
- 13 investigation, the [The] insurer shall draft a report of the
- 14 insurer's findings and [must] submit the report and any [the]
- 15 related investigation file to the commissioner <u>as soon as</u>
- 16 <u>practicable on the conclusion</u> [as part] of the insurer's
- 17 <u>independent</u> [request that the commissioner conduct an]
- 18 investigation.
- 19 SECTION 3. Section 701.052(f), Insurance Code, is repealed.
