H.B. No. 2402

A BILL TO BE ENTITLED

1 AN ACT

2 relating to erecting an off-premise sign adjacent to and visible  
3 from certain roads.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. Section 391.252(a), Transportation Code, is  
6 amended to read as follows:

7 (a) A [~~Subsequent to the effective date of this subchapter,~~  
8 ~~a]~~ person may not erect an off-premise sign that is adjacent to and  
9 visible from:

10 (1) U.S. Highway 290 between the western city limits  
11 of the city of Austin and the eastern city limits of the city of  
12 Fredericksburg;

13 (2) State Highway 317 between the northern city limits  
14 of the city of Belton to the southern city limits of the city of  
15 Valley Mills;

16 (3) State Highway 16 between the northern city limits  
17 of the city of Kerrville and Interstate Highway 20;

18 (4) U.S. Highway 77 between State Highway 186 and  
19 State Highway 44;

20 (5) U.S. Highway 281 between State Highway 186 and  
21 Interstate Highway 37;

22 (6) State Highway 17 between State Highway 118 and  
23 U.S. Highway 90;

24 (7) State Highway 67 between U.S. Highway 90 and

1 Farm-to-Market Road 170;

2 (8) Farm-to-Market Road 170 between State Highway 67  
3 and State Highway 118;

4 (9) State Highway 118 between Farm-to-Market Road 170  
5 and State Highway 17;

6 (10) State Highway 105 between the western city limits  
7 of the city of Sour Lake to the eastern city limits of the city of  
8 Cleveland;

9 (11) State Highway 73 between the eastern city limits  
10 of the city of Winnie to the western city limits of the city of Port  
11 Arthur;

12 (12) State Highway 21 between the southern city limits  
13 of the city of College Station and U.S. Highway 290; [~~or~~]

14 (13) a highway located in:

15 (A) the Sabine National Forest;

16 (B) the Davy Crockett National Forest; or

17 (C) the Sam Houston National Forest; or

18 (14) any segment of one of the following highways in  
19 Bandera County:

20 (A) State Highway 16;

21 (B) State Highway 46;

22 (C) State Highway 173;

23 (D) Farm-to-Market Road 187;

24 (E) Farm-to-Market Road 337;

25 (F) Farm-to-Market Road 470;

26 (G) Farm-to-Market Road 1077;

27 (H) Farm-to-Market Road 1283;

- 1                    (I) Farm-to-Market Road 2107;
- 2                    (J) Farm-to-Market Road 2828;
- 3                    (K) Farm-to-Market Road 3240; or
- 4                    (L) Park Road 37.

5                    SECTION 2. This Act takes effect September 1, 2005.
