## A BILL TO BE ENTITLED

1	AN ACT
2	relating to the regulation of on-site sewage disposal systems and
3	the maintenance of those systems; imposing administrative and
4	criminal penalties.
5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Section 366.0515, Health and Safety Code, is
7	amended by amending Subsection (g) and adding Subsections (h), (i),
8	and (j) to read as follows:
9	(g) The owner of a single-family residence located in a
10	county with a population of less than 40,000 shall maintain the
11	system directly or through a maintenance contract. If the owner
12	elects to maintain the system directly, the owner must obtain
13	training in system maintenance from the authorized agent or the
14	installer. The commission shall adopt rules governing:
15	(1) the training in system maintenance to be provided
16	to an owner who elects to maintain the system directly; and
17	(2) the maintenance of a system by the owner of the
18	system.
19	(h) If, under Subsection (b), an authorized agent or the
20	commission conditions approval of a permit for an on-site sewage
21	disposal system using aerobic treatment on the system's owner

contracting for the maintenance of the system, the order,

(1) inspect the system at specified intervals;

- 1 (2) submit a report on each inspection to the
- 2 authorized agent or commission; and
- 3 (3) provide a copy of each report submitted under
- 4 Subdivision (2) to the system's owner.
- 5 <u>(i) A maintenance company that violates a provision of an</u>
- 6 order, resolution, or rule described by Subsection (h) is subject
- 7 to an administrative penalty. The commission may recover the
- 8 penalty in a proceeding conducted as provided by Subchapter C,
- 9 Chapter 7, Water Code, or the authorized agent may recover the
- 10 penalty in a proceeding conducted under an order or resolution of
- 11 the agent. Notwithstanding Section 7.052, Water Code, the amount
- of the penalty for the first violation of that order, resolution, or
- 13 rule is \$200, and the amount of the penalty for each subsequent
- 14 violation is \$500.
- (j) If a maintenance company violates an order, resolution,
- or rule described by Subsection (h) three or more times, the
- 17 commission, in the manner provided by Subchapter G, Chapter 7,
- 18 Water Code, may revoke the license or registration of the
- 19 maintenance company or any person employed by the maintenance
- 20 company issued under:
- 21 (1) Section 26.0301, Water Code;
- 22 (2) Chapter 37, Water Code; or
- 23 (3) Section 366.071 of this code.
- SECTION 2. Section 366.071(a), Health and Safety Code, is
- 25 amended to read as follows:
- 26 (a) A person who constructs, installs, alters, extends,
- 27 services, maintains, or repairs an on-site sewage disposal system

- or any part of an on-site sewage disposal system for compensation
- 2 must hold a license or registration issued by the commission under
- 3 Chapter 37, Water Code.
- 4 SECTION 3. Subchapter E, Chapter 7, Water Code, is amended
- 5 by adding Section 7.1735 to read as follows:
- 6 Sec. 7.1735. VIOLATION RELATING TO MAINTENANCE OF SEWAGE
- 7 DISPOSAL SYSTEM. (a) A person commits an offense if the person
- 8 knowingly violates an order or resolution adopted by an authorized
- 9 agent under Section 366.0515, Health and Safety Code.
- 10 (b) An offense under this section is a Class C misdemeanor.
- 11 SECTION 4. Section 366.071(d), Health and Safety Code, is
- 12 repealed.
- SECTION 5. (a) The changes in law made by this Act apply
- only to a violation committed on or after the effective date of this
- 15 Act. For purposes of this section, a violation is committed before
- 16 the effective date of this Act if any element of the violation
- 17 occurs before that date.
- 18 (b) A violation committed before the effective date of this
- 19 Act is covered by the law in effect when the violation was
- 20 committed, and the former law is continued in effect for that
- 21 purpose.
- 22 SECTION 6. The Texas Commission on Environmental Quality
- 23 shall be prepared to accept applications for licenses or
- 24 registrations described by Section 366.071(a), Health and Safety
- 25 Code, as amended by this Act, not later than December 1, 2005.
- SECTION 7. (a) Except as provided by Subsection (b) of this
- 27 section, this Act takes effect September 1, 2005.
