A BILL TO BE ENTITLED

1 AN ACT

- 2 relating to the presentation of state flags to survivors of certain
- 3 deceased honorably retired peace officers.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 615.105(a), Government Code, is amended
- 6 to read as follows:
- 7 (a) This section applies only to:
- 8 (1) an individual elected, appointed, or employed as a
- 9 peace officer by the state or a political subdivision of the state
- 10 under Article 2.12, Code of Criminal Procedure, or other law; or
- 11 (2) an honorably retired peace officer [individual]
- 12 who formerly held a position described by Subdivision (1) and
- 13 voluntarily terminated employment with a law enforcement agency of
- 14 this state or a political subdivision of this state.
- 15 SECTION 2. Section 191.025(f), Health and Safety Code, is
- 16 amended to read as follows:
- 17 (f) The department shall require that the form for the
- 18 registration of deaths must include the question, "Was the decedent
- 19 [ever] a peace officer or an honorably retired peace officer in this
- 20 state?".
- 21 SECTION 3. Section 651.409, Occupations Code, is amended to
- 22 read as follows:
- Sec. 651.409. NOTICE TO NEXT OF KIN OF DECEASED PEACE
- 24 OFFICER. A funeral director who prepares a deceased peace officer

- 1 for burial or other disposition shall make every effort to advise
- 2 the next of kin of the officer that the next of kin of a person who
- 3 <u>at the time of death</u> was a peace officer or <u>an honorably retired</u> [a
- 4 former] peace officer who voluntarily terminated employment with a
- 5 law enforcement agency of this state or a political subdivision of
- 6 this state [at the time of death] is eligible on request to receive
- 7 a state flag from the Commission on Law Enforcement Officer
- 8 Standards and Education at no cost to the next of kin.
- 9 SECTION 4. Section 1701.161(a), Occupations Code, is
- 10 amended to read as follows:
- 11 (a) If the next of kin of a deceased peace officer requests a
- 12 state flag, the commission shall:
- 13 (1) provide a state flag, at no cost to the next of
- 14 kin, if the peace officer was:
- 15 <u>(A)</u> a current [or former] peace officer at the
- 16 time of the officer's death; or
- 17 (B) an honorably retired peace officer who
- 18 voluntarily terminated employment with a law enforcement agency of
- 19 this state or a political subdivision of this state; and
- 20 (2) notify the office of the governor of the death of
- 21 the peace officer.
- 22 SECTION 5. The Department of State Health Services is not
- 23 required to implement Section 191.025(f), Health and Safety Code,
- 24 as amended by this Act, until the next time at which the department
- 25 is otherwise requiring a revision to the form for the registration
- of deaths.
- 27 SECTION 6. This Act takes effect September 1, 2005.
