- 6 district that adopts a safety or security code, policy, or manual
- 7 may not be sued for noncompliance with that code, policy, or manual.
- 8 SECTION 5. Subchapter D, Chapter 62, Water Code, is amended
- 9 by adding Section 62.121 to read as follows:
- 10 Sec. 62.121. CONTRACTS WITH POLITICAL SUBDIVISIONS IN
- 11 COUNTIES ADJACENT TO DISTRICT. (a) A district may contract with
- 12 any person in a county adjacent to the district or with a county
- 13 adjacent to the district to exercise a district power for any
- 14 district purpose.
- 15 (b) As part of a contract under this section, a district
- 16 <u>may:</u>
- 17 (1) issue bonds, including bonds secured by ad valorem
- 18 taxation; and
- 19 (2) use proceeds from bonds issued by the district to
- 20 finance a project that serves a district purpose in a county
- 21 <u>adjacent to the district.</u>
- 22 SECTION 6. This Act takes effect September 1, 2005.
