## A BILL TO BE ENTITLED

3	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
4	SECTION 1. Chapter 43, Parks and Wildlife Code, is amended
5	by adding Subchapter S to read as follows:
6	SUBCHAPTER S. MIGRATORY AND UPLAND GAME BIRD STAMPS
7	Sec. 43.651. DEFINITIONS. In this subchapter:
8	(1) "Migratory game bird" means any bird listed in
9	Section 64.021 and includes any other species of migratory bird

- n d that the commission by rule designates as a migratory game bird. 10
- (2) "Upland game bird" means any bird listed in 11 12 Section 64.001.
- Sec. 43.652. MIGRATORY OR UPLAND GAME BIRD STAMP REQUIRED. 13 (a) Except as provided by Subsection (b), a person may not hunt a 14
- migratory or upland game bird in this state unless the person 15
- possesses the appropriate migratory or upland game bird stamp, as 16
- applicable, issued to the person by the department. The commission 17
- 18 by rule may adopt requirements relating to possessing a stamp
- required by this subchapter. 19
- (b) The commission by rule may exempt a person or class of 20 21 persons from the stamp requirement of this section.
- Sec. 43.653. HUNTING LICENSE REQUIRED. The possession of 22
- either a migratory or upland game bird stamp does not authorize a 23
- person to hunt a migratory or upland game bird: 24

- 1 (1) without possessing a hunting license as provided

- 3 (2) at any time or by means not otherwise authorized by
- 4 this code.
- 5 Sec. 43.654. DESIGN AND ISSUANCE OF STAMPS. (a) The
- 6 department may issue a migratory or upland game bird stamp to any
- 7 person on payment to the department of \$7 per stamp, or an amount
- 8 set by the commission, whichever amount is greater.

- 9 (3) contracts, donations, and grants under Section

- 11 (b) The department shall use the net proceeds from the

- 13 migratory birds in this state.
- 14 Sec. 43.657. DISPOSITION OF UPLAND GAME BIRD STAMP NET
- 15 PROCEEDS. (a) The upland game bird stamp net proceeds shall be
- deposited to the credit of the game, fish, and water safety account
- under Section 11.032 and may be used only for the purposes specified
- 18 in Section 43.658.
- 19 (b) Net proceeds from the upland game bird stamp consist of:
- 20 (1) proceeds from the issuance of upland game bird
- 21 stamps;
- (2) the amount allocated by the department from the
- 23 net proceeds of a combination license if upland game bird stamps are
- issued as part of a combination license under Chapter 50;
- 25 (3) proceeds from the sale of collector's editions of
- upland game bird stamps, if issued under Section 43.654(b);
- 27 (4) payments, including royalty payments, received

- 1 for the use of the upland game bird stamp image authorized under
- 2 Section 43.654(c); and
- 3 (5) interest and other earnings from the investment of

- 15 (2) acquisition, lease, or development of upland game
- 16 bird habitats; and
- 17 (3) contracts, donations, and grants under Section
- 18 43.659.
- 19 (b) The department shall use the net proceeds from the
- 20 upland game bird stamp in a manner that addresses the needs of
- 21 upland game birds in this state.
- 22 <u>Sec. 43.659. CONTRACTS, DONATIONS, AND GRANTS. As allowed</u>
- 23 under state and federal law, the department may make money
- 24 available in advance or by reimbursement to appropriate state,
- 25 regional, national, and international governmental and nonprofit
- 26 organizations through contracts, donations, and grants. The money
- 27 may be used to acquire, develop, and maintain migratory and upland

- 1 game bird habitat areas in the United States, Canada, Mexico, or
- 2 another country that provides migratory habitat for the Central
- 3 Flyway.
- 4 Sec. 43.660. REFUSAL TO SHOW STAMP OR PROOF OF EXEMPTION
- 5 ELIGIBILITY. A person hunting a migratory or upland game bird who
- 6 refuses on demand of any game warden or other peace officer to show
- 7 the applicable stamp, or proof that the person is exempt under
- 8 Section 43.652(b), is presumed to be in violation of Section
- 9 43.652.
- 10 Sec. 43.661. RECIPROCAL AGREEMENTS RELATING TO MIGRATORY
- 11 BIRDS. As provided by Chapter 41, the department may negotiate a
- 12 reciprocal agreement with a state that shares a common boundary
- 13 with this state if the neighboring state has a similar migratory
- 14 game bird stamp requirement and fee. The reciprocal agreement may
- 15 permit a resident of the state with which the reciprocal agreement
- 16 <u>is made to hunt a migratory game bird in this state without a stamp</u>
- issued under this subchapter if the person possesses a stamp issued
- 18 by the other state.
- 19 Sec. 43.662. USE OF MONEY FROM ISSUANCE OF WHITE-WINGED
- 20 DOVE STAMP. (a) Any money deposited from the net receipts from
- 21 white-winged dove stamp sales under former Subchapter B deposited
- 22 <u>in the game, fish, and water safety account under Section 11.032</u>
- 23 shall remain in that account and be used only for:
- 24 (1) research, conservation, surveys, and management
- 25 for all species of doves designated as migratory game birds; and

- 2 Sec. 43.663. USE OF MONEY FROM ISSUANCE OF WATERFOWL STAMP.
- 3 (a) Any money deposited from the net receipts from waterfowl stamp
- 4 sales under former Subchapter K deposited in the game, fish, and
- 5 water safety account under Section 11.032 shall remain in that
- 6 account and be used only for:
- 7 (1) research, management, and conservation of
- 8 waterfowl;
- 9 (2) the acquisition, lease, or development of
- 10 waterfowl habitats in this state; and
- 11 (3) grants under Section 43.659.
- 12 (b) This section expires September 1, 2010.
- 13 Sec. 43.664. USE OF MONEY FROM ISSUANCE OF TURKEY STAMP.
- 14 (a) Any money deposited from the net receipts from turkey stamp
- 15 sales under former Subchapter J deposited in the game, fish, and
- 16 water safety account under Section 11.032 shall remain in that
- 17 account and be used only for:
- 18 <u>(1) research, management, and conservation of wild</u>
- 19 turkeys; and
- 20 (2) the acquisition, lease, or development of wild
- 21 <u>turkey habitats in this state.</u>
- 22 (b) This section expires September 1, 2010.
- Sec. 43.665. PENALTY. A person who violates Section 43.652
- 24 commits an offense that is a Class C Parks and Wildlife Code
- 25 misdemeanor.
- SECTION 2. Subchapters B, J, and K, Chapter 43, Parks and
- 27 Wildlife Code, are repealed.

SECTION 3. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2006.
