A BILL TO BE ENTITLED

1	AN ACT
2	relating to the creation of a driver safety program for holders of
3	provisional driver's licenses.
4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subchapter B, Chapter 521, Transportation Code,
6	is amended by adding Section 521.032 to read as follows:
7	Sec. 521.032. PROVISIONAL LICENSE HOLDER DRIVER SAFETY
8	PILOT PROGRAM. (a) In this section, "program partner" means an
9	organization such as the I Saw You Safety & Scholarship Foundation,
10	<pre>Inc., that is:</pre>
11	(1) exempt from federal income taxation under Section
12	501(a), Internal Revenue Code of 1986, as an organization described
13	by Section 501(c)(3) of that code; and
14	(2) created for the purpose of preventing injuries and
15	deaths caused by young drivers.
16	(b) The department shall create a driver safety pilot
17	program for provisional license holders in conjunction with a
18	program partner to determine whether a monitoring system will
19	reduce the number of accidents involving provisional license
20	holders. The pilot program shall:
21	(1) provide for voluntary participation and

bilingual call centers for a person to report the observed

(2) establish a toll-free telephone system with

enrollment in the program by a provisional license holder;

- 1 operation of a vehicle by a person who is participating or enrolled
- 2 in the pilot program; and
- 3 (3) commence on or before September 1, 2005.
- 4 (c) The department may solicit, accept, and administer
- 5 gifts and grants from any public or private source for the use and
- 6 benefit of the program. The department shall apply for grants from
- 7 the National Highway Traffic Safety Administration under 23 U.S.C.
- 8 Sections 403 and 407. The program partner shall prepare the
- 9 application for any grants for the pilot program at the expense of
- 10 the program partner. Money received by the department or the
- 11 program partner under this section and Section 521.421(i) shall be
- 12 deposited to the credit of the state highway fund and used by the
- department to benefit the pilot program.
- (d) The department shall appoint a project manager to
- 15 coordinate the pilot program and to facilitate the collection and
- 16 <u>analysis of accident data.</u>
- 17 (e) The legislature may appropriate money to the department
- 18 for support of the program in addition to any amounts allocated by
- 19 the General Appropriations Act.
- 20 (f) This section expires September 1, 2007.
- 21 SECTION 2. Section 521.421, Transportation Code, is amended
- 22 by adding Subsection (i) to read as follows:
- (i) The department shall collect an additional fee of \$1 for
- the issuance or renewal of a license under Subsection (a), (b), or
- 25 (c) to fund the Provisional License Holder Driver Safety Pilot
- 26 Program established under Section 521.032, unless the person
- 27 applying for or renewing a license chooses not to pay the additional

- 1 <u>fee. This subsection expires September 1, 2007.</u>
- 2 SECTION 3. This Act takes effect immediately if it receives
- 3 a vote of two-thirds of all the members elected to each house, as
- 4 provided by Section 39, Article III, Texas Constitution. If this
- 5 Act does not receive the vote necessary for immediate effect, this
- 6 Act takes effect September 1, 2005.
