4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Chapter 403, Government Code is amended by
6	adding Subchapter P to read as follows:
7	SUBCHAPTER O. DENIAL OF LICENSURE
8	Sec. 403.351. Definitions. In this subchapter:
9	(1) "License" means a license, certificate,
10	registration, permit, or other authorization that:
11	(A) is issued by a licensing authority;
12	(B) is subject before expiration to suspension,
13	revocation, forfeiture, or termination by the issuing licensing
14	authority; and
15	(C) a person must obtain to:
16	(i) practice or engage in a particular
17	business, occupation, or profession;
18	(ii) operate a motor vehicle; or
19	(iii) engage in any other regulated
20	activity, including hunting, fishing, or other recreational
21	activity for which a license or permit is required.
22	(2) "Licensing authority" means a department,
23	commission, board, office, or other agency of this state that
24	issues a license.

18	Sec. 403.353. DENIAL OF LICENSE. (a) A licensing agency
19	may not issue a license to an applicant for an original or renewal
20	license if the individual owes delinquent ad valorem taxes to a
21	taxing unit in this state as shown on a current or cumulative
22	delinquent tax roll.
23	Sec. 403.354. DELINQUENT TAX ROLLS. (a) The tax collector
24	for a taxing unit shall deliver to the comptroller a copy of each
25	delinquent tax roll prepared under Section 33.03, Tax Code.
26	(b) The comptroller shall prescribe the form and manner in
27	which the delinquent tax rolls must be submitted.

- Sec. 403.355. COMPUTER DATABASE. (a) From the delinquent
- 2 tax roll information provided by tax collectors, the comptroller
- 3 shall develop and maintain a computer database to be used in the
- 4 administration and enforcement of this subchapter.
- 5 (b) The comptroller shall develop procedures to enable
- 6 licensing agencies to have access to the information in the
- 7 <u>computer database.</u>
- 8 Sec. 403.355. APPEAL OF DENIAL. The denial of a license
- 9 under this subchapter is a final agency decision and is subject to
- 10 review as provided by Chapter 2001.
- 11 Sec. 403.356. EXEMPTION FROM LIABILITY. The comptroller,
- 12 the tax collector for a taxing unit, or a licensing authority is
- 13 exempt from liability to an applicant for an original or renewal
- 14 license for any act authorized under this chapter that is performed
- by the comptroller, the tax collector, or the licensing authority.
- Sec. 403.357. RULES AND FORMS. The comptroller shall adopt
- 17 rules and forms to implement and administer this subchapter.
- 18 SECTION 2. This Act takes effect September 1, 2005.
