	A BILL TO BE ENTITLED
1	AN ACT
2	relating to swimming pool safety.
3	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
4	SECTION 1. Subtitle A, Title 9, Health and Safety Code, is
5	amended by adding Chapter 761 to read as follows:
6	CHAPTER 761. POOL SAFETY AT SINGLE-FAMILY HOMES
7	Sec. 761.001. DEFINITIONS. In this chapter:
8	(1) "Manufacturer" includes a contractor that
9	constructs a pool at a single-family home.
10	(2) "Pool" means a permanent swimming pool, permanent
11	wading or reflection pool, or permanent hot tub or spa over 18
12	inches deep, located at ground level, above ground, below ground,
13	<u>or indoors.</u>
14	(3) "Pool yard" means an area that contains a pool.
15	(4) "Pool yard enclosure" or "enclosure" means a
16	fence, wall, or combination of fences, walls, or gates that
17	completely surround a pool.
18	(5) "Power safety cover" means a motor-powered barrier
19	that:
20	(A) completely covers the water area of the pool;
21	and
22	(B) conforms to the ASTM International Standard
23	F1346-91 "Standard Performance Specification for Safety Covers and
24	Labeling Requirements for All Covers for Swimming Pools, Spas and

1	Hot Tubs" as it existed on January 1, 2005.
2	(6) "Self-closing and self-latching device" means a
3	device that causes a gate to automatically close without human or
4	electrical power after it has been opened and to automatically
5	latch without human or electrical power when the gate closes.
6	Sec. 761.002. REQUIRED SAFETY EQUIPMENT. (a) In
7	accordance with rules adopted by the executive commissioner of the
8	Health and Human Services Commission, a person who sells or
9	manufactures a pool shall provide, with each pool sold or
10	manufactured for use at a single-family home, the following safety
11	equipment:
12	(1) a flotation device designed to be thrown to a
13	person in the pool;
14	(2) a pole designed to retrieve a person from the pool;
15	and
16	(3) a pool yard enclosure and gate that comply with the
17	specifications described by Sections 761.003 and 761.004 or a power
18	safety cover.
19	(b) A seller or manufacturer required to comply with this
20	chapter may charge the cost of the required safety equipment to the
21	person purchasing the pool.
22	(c) A seller or manufacturer is not required to provide the
23	safety equipment required by Subsection (a) if the person
24	purchasing the pool owns safety equipment that complies with this
25	chapter. The person purchasing the pool must submit proof to the
26	seller or manufacturer of the presence of the required safety
27	equipment in accordance with rules adopted by the executive

1	commissioner of the Health and Human Services Commission.
2	Sec. 761.003. ENCLOSURE FOR POOL YARD. (a) The height of
3	the pool yard enclosure must be at least 48 inches as measured from
4	the ground on the side away from the pool.
5	(b) Openings under the pool yard enclosure may not allow a
6	sphere four inches in diameter to pass under the pool yard
7	enclosure.
8	(c) If the pool yard enclosure is constructed with
9	horizontal and vertical members and the distance between the tops
10	of the horizontal members is at least 45 inches, the openings may
11	not allow a sphere four inches in diameter to pass through the
12	enclosure.
13	(d) If the pool yard enclosure is constructed with
14	horizontal and vertical members and the distance between the tops
15	of the horizontal members is less than 45 inches, the openings may
16	not allow a sphere 1-3/4 inches in diameter to pass through the
17	enclosure.
18	(e) A pool yard enclosure may not contain:
19	(1) chain link fencing materials; or
20	(2) diagonal fencing members that are lower than 49
21	inches above the ground.
22	(f) Decorative designs or cutouts on or in the pool yard
23	enclosure may not contain any openings greater than 1-3/4 inches in
24	any direction.
25	(g) Indentations or protrusions in a solid pool yard
26	enclosure without any openings may not be greater than normal
27	construction tolerances and tooled masonry joints on the side away

1	from the pool.
2	(h) Permanent equipment or structures may not be
3	constructed or placed in a manner that makes them readily available
4	for climbing over the pool yard enclosure.
5	Sec. 761.004. GATES. (a) A gate in a fence or wall
6	enclosing a pool yard as required by Section 761.003 must:
7	(1) have a self-closing and self-latching device;
8	(2) have hardware enabling the gate to be locked, at
9	the option of whoever controls the gate, by a padlock or a built-in
10	lock operated by key, card, or combination; and
11	(3) open outward away from the pool yard.
12	(b) Except as otherwise provided by Subsection (c), a gate
13	latch must be installed so that it is at least 60 inches above the
14	ground, except that it may be installed lower if:
15	(1) the latch is installed on the pool yard side of the
16	gate only and is at least three inches below the top of the gate; and
17	(2) the gate or enclosure has no opening greater than
18	one-half inch in any direction within 18 inches from the latch,
19	including the space between the gate and the gate post to which the
20	gate latches.
21	(c) A gate latch may be located 42 inches or higher above the
22	ground if the gate cannot be opened except by key, card, or
23	combination on both sides of the gate.
24	Sec. 761.005. ENFORCEMENT. (a) A person who purchases a
25	pool from a seller or manufacturer required to comply with this
26	chapter, a governmental entity, or the person's representative may
27	maintain an action against the seller or manufacturer of the pool

1	for failure to comply with the requirements of this chapter. In
2	that action, the person may obtain:
3	(1) a court order directing the seller or manufacturer
4	to comply with this chapter; and
5	(2) a judgment against the seller or manufacturer for
6	actual damages resulting from the failure to comply with the
7	requirements of this chapter.
8	(b) A seller and manufacturer are jointly and severally
9	liable for damages under this section. Chapter 33, Civil Practice
10	and Remedies Code, does not apply to an action maintained under this
11	section.
12	SECTION 2. The heading to Chapter 757, Health and Safety
13	Code, is amended to read as follows:
14	CHAPTER 757. POOL YARD ENCLOSURES <u>AT CERTAIN DWELLINGS</u>
15	SECTION 3. The change in law made by this Act applies only
16	to a pool sold on or after the effective date of this Act. A pool
17	sold before the effective date of this Act is covered by the law in
18	effect when the pool was sold, and the former law is continued in
19	effect for that purpose.
20	SECTION 4. This Act takes effect September 1, 2005.
