4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subtitle I, Title 6, Special District Local Laws
6	Code, is amended by adding Chapter 9004 to read as follows:
7	CHAPTER 9004. SOUTH BUDA WATER CONTROL AND IMPROVEMENT DISTRICT
8	<u>NO. 1</u>
9	SUBCHAPTER A. GENERAL PROVISIONS
10	Sec. 9004.001. DEFINITIONS. In this chapter:
11	(1) "Board" means the board of directors of the
12	district.
13	(2) "Director" means a member of the board.
14	(3) "District" means the South Buda Water Control and
15	Improvement District No. 1.
16	Sec. 9004.002. NATURE OF DISTRICT. The district is a water
17	control and improvement district in Hays County created under and
18	essential to accomplish the purposes of Section 59, Article XVI,
19	Texas Constitution.
20	Sec. 9004.003. CONFIRMATION ELECTION REQUIRED. If the
21	creation of the district is not confirmed at a confirmation
22	election held under Section 9004.021 before September 1, 2010:
23	(1) the district is dissolved September 1, 2010,
24	except that:

Τ	(A) any debts incurred shall be paid;
2	(B) any assets that remain after the payment of
3	debts shall be transferred to Hays County; and
4	(C) the organization of the district shall be
5	maintained until all debts are paid and remaining assets are
6	transferred; and
7	(2) this chapter expires September 1, 2013.
8	Sec. 9004.004. DISTRICT TERRITORY. (a) The district
9	includes the territory provided by Section 2 of the Act creating
10	this chapter, as that territory may have been modified under:
11	(1) Subchapter J, Chapter 49, Water Code; or
12	(2) other law.
13	(b) The boundaries and field notes contained in Section 2 of
14	the Act creating this chapter form a closure. A mistake made in the
15	field notes or in copying the field notes in the legislative process
16	does not affect:
17	(1) the organization, existence, or validity of the
18	district;
19	(2) the right of the district to impose taxes; or
20	(3) the legality or operation of the board.
21	Sec. 9004.005. APPLICABILITY OF OTHER LAW; CONFLICTS OF
22	LAW. (a) Except as otherwise provided by this chapter, the
23	following laws apply to the district:
24	(1) Chapters 30, 49, and 51, including Section 51.331,
25	Water Code; and
26	(2) Chapter 441, Transportation Code, applicable to
27	road utility districts created under Section 52, Article III,

- 1 Texas Constitution, to the extent those provisions can apply to the
- 2 district.
- 3 (b) If a provision of Chapter 441, Transportation Code,
- 4 relating to road utility districts, conflicts with this chapter or
- 5 Chapter 30, 49, or 51, Water Code, this chapter or Chapters 30, 49,
- 6 and 51, Water Code, prevail.

- 9 Sec. 9004.021. CONFIRMATION ELECTION. (a) The board shall
- 10 hold an election to confirm the validation of the creation of the

- 12 (b) The election shall be conducted as provided by Section
- 13 49.1<u>02, Water Code.</u>
- 14 Sec. 9004.022. EXPIRATION OF SUBCHAPTER. This subchapter
- expires September 1, 2013.

- SUBCHAPTER B. POWERS AND DUTIES
- 18 Sec. 9004.051. STREET OR SECURITY LIGHTING. The district
- 19 may purchase, install, operate, or maintain street lighting or
- 20 security lighting within public utility easements or public
- 21 rights-of-way in the district.

- 2 SECTION 4. (a) The legal notice of the intention to
- 3 introduce this Act, setting forth the general substance of this
- 4 Act, has been published as provided by law, and the notice and a
- 5 copy of this Act have been furnished to all persons, agencies,
- 6 officials, or entities to which they are required to be furnished
- 7 under Section 59, Article XVI, Texas Constitution, and Chapter 313,
- 8 Government Code.
- 9 (b) The governor, one of the required recipients, has
- 10 submitted the notice and Act to the Texas Commission on
- 11 Environmental Quality.
- 12 (c) The Texas Commission on Environmental Quality has filed
- 13 its recommendations relating to this Act with the governor, the
- 14 lieutenant governor, and the speaker of the house of
- 15 representatives within the required time.
- 16 (d) All requirements of the constitution and laws of this
- 17 state and the rules and procedures of the legislature with respect
- 18 to the notice, introduction, and passage of this Act are fulfilled
- 19 and accomplished.
- 20 SECTION 5. This Act takes effect immediately if it receives
- 21 a vote of two-thirds of all the members elected to each house, as
- 22 provided by Section 39, Article III, Texas Constitution. If this
- 23 Act does not receive the vote necessary for immediate effect, this
- 24 Act takes effect September 1, 2005.
