## A BILL TO BE ENTITLED

AN ACT

2	relating to the creation of The Lakes Fresh Water Supply District of
3	Denton County; providing authority to impose a tax and issue bonds;
4	granting the power of eminent domain.
5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Subtitle F, Title 6, Special District Local Laws
7	Code, is amended by adding Chapter 8125 to read as follows:
8	CHAPTER 8125. THE LAKES FRESH WATER SUPPLY
9	DISTRICT OF DENTON COUNTY
10	SUBCHAPTER A. GENERAL PROVISIONS
11	Sec. 8125.001. DEFINITIONS. In this chapter:
12	(1) "Board" means the board of directors of the
13	district.
14	(2) "Director" means a member of the board.
15	(3) "District" means The Lakes Fresh Water Supply
16	District of Denton County.
17	Sec. 8125.002. NATURE OF DISTRICT. The district is a fresh
18	water supply district in Denton County created under and essential
19	to accomplish the purposes of Section 52, Article III, and Section
20	59, Article XVI, Texas Constitution. The district is created to
21	serve a public use and benefit.
22	Sec. 8125.003. CONFIRMATION ELECTION REQUIRED. If the
23	creation of the district is not confirmed at a confirmation
24	election held under Section 8125.023 before September 1, 2007:

Τ	(1) the district is dissolved September 1, 2007,
2	<pre>except that:</pre>
3	(A) any debts incurred shall be paid;
4	(B) any assets that remain after the payment of
5	debts shall be transferred to Denton County; and
6	(C) the organization of the district shall be
7	maintained until all debts are paid and remaining assets are
8	transferred; and
9	(2) this chapter expires September 1, 2010.
10	Sec. 8125.004. INITIAL DISTRICT TERRITORY. (a) The
11	district is initially composed of the territory described by
12	Section 2 of the Act creating this chapter.
13	(b) The boundaries and field notes contained in Section 2 of
14	the Act creating this chapter form a closure. A mistake made in the
15	field notes or in copying the field notes in the legislative process
16	<pre>does not affect:</pre>
17	(1) the organization, existence, or validity of the
18	district;
19	(2) the right of the district to impose taxes; or
20	(3) the legality or operation of the board.
21	Sec. 8125.005. APPLICABILITY OF OTHER LAW; CONFLICTS OF
22	LAW. (a) Except as otherwise provided by this chapter, all
23	applicable laws including the following laws apply to the district:
24	(1) Chapters 49, 53, and 54, Water Code; and
25	(2) Chapter 257, Transportation Code, and other
26	general laws applicable to road districts created under Section 52,
27	Article III, Texas Constitution, to the extent those provisions can

2	(b) Sections 53.029(b), 53.030-53.034, and 53.040-53.043,
3	Water Code, do not apply to the district.
4	(c) If a provision of Chapter 53, Water Code, is in conflict
5	or inconsistent with this chapter or Chapter 54, Water Code, this
6	chapter and Chapter 54, Water Code, prevail.
7	Sec. 8125.006. PROHIBITION AGAINST IMPAIRMENT OF DISTRICT.
8	A county in which the district is located or a municipality in whose
9	extraterritorial jurisdiction the district is located may not adopt
10	an ordinance or resolution or take any other action that:
11	(1) impairs the ability of the district to exercise
12	its powers under this chapter or other law; or
13	(2) limits the ability of the district to finance,
14	construct, or operate its water, wastewater, drainage, or road
15	systems.

17	SUBCHAPTER A1. TEMPORARY PROVISIONS
18	Sec. 8125.021. TEMPORARY DIRECTORS. (a) The temporary
19	<pre>board consists of:</pre>
20	(1) Andrea Adcock;
21	(2) Chad Breaux;
22	(3) Brian Bryce, Jr.;
23	(4) Traci Pichon; and
24	(5) Crystal Taylor.
25	(b) If a temporary director fails to qualify for office, the
26	temporary directors who have qualified shall appoint a person to
27	fill the vacancy. If at any time there are fewer than three

- 1 qualified temporary directors, the Texas Commission on
- 2 Environmental Quality shall appoint the necessary number of persons
- 3 to fill all vacancies on the board.
- 4 (c) Temporary directors serve until the earlier of:

- 9 Sec. 8125.022. ORGANIZATIONAL MEETING OF TEMPORARY
- 10 DIRECTORS. As soon as practicable after all the temporary
- 11 directors have qualified under Section 49.055, Water Code, the
- 12 temporary directors shall convene the organizational meeting of the
- 13 district at a location in the district agreeable to a majority of
- 14 the directors. If a location cannot be agreed upon, the
- organizational meeting shall be at the Denton County Courthouse.
- 16 Sec. 8125.023. CONFIRMATION AND INITIAL DIRECTORS'
- 17 ELECTION. The temporary directors shall hold an election to
- 18 confirm the creation of the district and to elect five directors as
- 19 provided by Section 49.102, Water Code.
- Sec. 8125.024. INITIAL ELECTED DIRECTORS; TERMS. The
- 21 directors elected under Section 8125.023 shall draw lots to
- determine which two shall serve until the first regularly scheduled
- 23 election of directors under Section 8125.053 and which three shall
- 24 serve until the second regularly scheduled election of directors.
- Sec. 8125.025. EXPIRATION OF SUBCHAPTER. This subchapter
- 26 expires September 1, 2010.
- [Sections 8125.026-8125.050 reserved for expansion]

## 1 SUBCHAPTER B. BOARD OF DIRECTORS 2 Sec. 8125.051. DIRECTORS; TERMS. (a) The district is governed by a board of five directors. 3 4 (b) Directors serve staggered four-year terms. Sec. 8125.052. QUALIFICATIONS. Directors must meet only 5 6 the qualifications for directors provided by Chapters 49 and 54, 7 Water Code. 8 Sec. 8125.053. ELECTION OF DIRECTORS. On the uniform election date in May of each even-numbered year, the appropriate 9 number of directors shall be elected. 10 [Sections 8125.054-8125.100 reserved for expansion] 11 SUBCHAPTER C. POWERS AND DUTIES 12 Sec. 8125.101. ROAD PROJECTS. (a) The district may 13 construct, acquire, improve, maintain, or operate macadamized, 14 15 graveled, paved, or concreted streets, roads, or turnpikes, or improvements in aid of those streets, roads, or turnpikes, 16 17 including bridges, inside or outside the district. (b) The improvements may include drainage or landscaping 18 improvements, lights, signs, signals, sidewalks, or hiking or 19 biking trails that are incidental to the roads or turnpikes and 20 21 their construction, maintenance, or operation. (c) A project authorized by this section must meet only the 22 construction standards adopted by the North Central Texas Council 23 24 of Governments, or its successor agency. 25 (d) The district may, following approval of a construction 26 contract by the board, reimburse expenditures as provided by

Sections 257.003(a) and (b), Transportation Code, without any

27

- 1 additional approval under Section 257.003, Transportation Code.
- 2 Sec. 8125.102. JOINT ROAD PROJECTS. A district contract
- 3 for a joint project with a state agency, a political subdivision, or
- 4 a corporation created under Chapter 431, Transportation Code, may:
- 5 (1) provide for joint payment of project costs; or
- 6 (2) require the state agency or political subdivision
- 7 to design, construct, or improve a project, including landscaping
- 8 for the project, as provided by the contract.
- 9 Sec. 8125.103. ROAD CONTRACTS. The district may contract
- 10 for a road project in the same manner as a road district under
- 11 Chapter 257, Transportation Code, except that competitive bidding
- 12 for a contract is governed by Subchapter I, Chapter 49, Water Code.
- Sec. 8125.104. WATER CONTROL AND STORAGE PROJECTS. (a) The
- 14 district may construct, acquire, improve, enlarge, extend, repair,
- or maintain dams, levees, walls, dikes, embankments, canals,
- 16 reservoirs, lakes, or other improvements as necessary to control,
- 17 store, or preserve water in the district for any useful purpose.
- 18 (b) The district may overflow and inundate public lands and
- 19 other public property in the district.
- 20 (c) A project authorized by this section is subject to all
- 21 applicable permitting and regulatory requirements.
- Sec. 8125.105. CERTIFICATE OF CONVENIENCE AND NECESSITY.
- 23 (a) The district may pay out of bond proceeds or other available
- 24 district money all expenses, including legal, engineering, and
- other fees, related to obtaining a new certificate of convenience
- 26 and necessity under Chapter 13, Water Code, authorizing the
- 27 district to provide retail water or sewer service inside or outside

- 1 <u>the district.</u>
- 2 (b) The district may pay out of bond proceeds or other
- 3 available district money all expenses, including the purchase
- 4 price, related to acquiring certificate of convenience and
- 5 necessity rights from another retail public utility to allow the
- 6 district to provide retail water or sewer service in the district.
- 7 Sec. 8125.106. CONTRACT WITH POLITICAL SUBDIVISION FOR
- 8 WATER OR SEWER SERVICES. (a) The district may enter into a
- 9 contract to allow a political subdivision to provide retail water
- or sewer service in the district. The contract may contain terms
- 11 the board considers desirable, fair, and advantageous to the
- 12 district.
- 13 (b) The contract may provide that the district will
- 14 construct or acquire and convey to the political subdivision a
- 15 water supply or treatment system, a water distribution system, or a
- 16 <u>sanitary sewage collection or treatment system</u>, as necessary to
- 17 provide water or sewer service in the district.
- 18 (c) The district may use bond proceeds or other available
- 19 district money to pay for its obligations and for services and
- 20 facilities provided under the contract.
- 21 (d) If the contract requires the district to make payments
- from taxes other than operation and maintenance taxes, the contract
- is subject to Section 49.108, Water Code.
- Sec. 8125.107. EMINENT DOMAIN. The district may acquire by
- condemnation any land, easements, or other property:
- 26 (1) as provided by Chapter 49, Water Code; or
- 27 (2) inside the district for any road project or

4	Sec. 8125.151. OPERATION AND MAINTENANCE TAX. (a) The
5	district may impose a tax for any district operation and
6	maintenance purpose in the manner provided by Section 49.107, Water
7	Code.
8	(b) Section 49.107(f), Water Code, does not apply to
9	reimbursements for projects constructed or acquired under Section
10	<u>8125.101.</u>
11	Sec. 8125.152. TAX TO REPAY BONDS. The district may impose
12	a tax to pay the principal of and interest on bonds issued under
13	Section 8125.201.
14	[Sections 8125.153-8125.200 reserved for expansion]
15	SUBCHAPTER E. BONDS
16	Sec. 8125.201. AUTHORITY TO ISSUE BONDS AND OTHER
17	OBLIGATIONS; TAX. (a) The district may issue bonds or other
18	obligations as provided by Chapters 49, 53, and 54, Water Code, and
19	to finance:
20	(1) the construction, maintenance, or operation of
21	projects under Sections 8125.101, 8125.102, and 8125.104; or
22	(2) the district's contractual obligations under
23	Section 8125.106.
24	(b) The district may not issue bonds or other obligations
25	secured in whole or in part by ad valorem taxation to finance
26	projects authorized by Section 8125.101 or 8125.102 unless the
27	issuance is approved by a vote of a two-thirds majority of the

- 1 voters of the district voting at an election called for that
- 2 purpose.
- 3 (c) Bonds or other obligations issued or incurred to finance
- 4 projects authorized by Section 8125.101 or 8125.102 may not exceed
- 5 one-fourth of the assessed value of the real property in the
- 6 district.
- 7 (d) Sections 49.181 and 49.182, Water Code, do not apply to
- 8 a project undertaken by the district under Section 8125.101 or
- 9 8125.102 or to bonds issued by the district to finance the project.
- 10 SECTION 2. The Lakes Fresh Water Supply District of Denton
- 11 County initially includes all the territory contained in the

- 19 Act, has been published as provided by law, and the notice and a
- 20 copy of this Act have been furnished to all persons, agencies,
- 21 officials, or entities to which they are required to be furnished
- under Section 59, Article XVI, Texas Constitution, and Chapter 313,
- 23 Government Code.
- (b) The governor, one of the required recipients, has
- 25 submitted the notice and Act to the Texas Commission on
- 26 Environmental Quality.
- 27 (c) The Texas Commission on Environmental Quality has filed

- 1 its recommendations relating to this Act with the governor, the
- 2 lieutenant governor, and the speaker of the house of
- 3 representatives within the required time.
- 4 (d) All requirements of the constitution and laws of this
- 5 state and the rules and procedures of the legislature with respect
- 6 to the notice, introduction, and passage of this Act are fulfilled
- 7 and accomplished.
- 8 SECTION 4. This Act takes effect immediately if it receives
- 9 a vote of two-thirds of all the members elected to each house, as
- 10 provided by Section 39, Article III, Texas Constitution. If this
- 11 Act does not receive the vote necessary for immediate effect, this
- 12 Act takes effect September 1, 2005.
