10	Sec. 3838.001. DEFINITIONS. In this chapter:
11	(1) "Board" means the board of directors of the

13	(2) "District" means the Pearland Municipal
14	Management District No. 1.
15	(3) "Economic development corporation" means a
16	corporation created under the Development Corporation Act of 1979
17	(Article 5190.6, Vernon's Texas Civil Statutes).

- 18 Sec. 3838.002. PEARLAND MUNICIPAL MANAGEMENT DISTRICT NO.
- 19 1. The Pearland Municipal Management District No. 1 is a special
- 20 <u>district created under Section 59, Article XVI, Texas Constitution.</u>
- Sec. 3838.003. PURPOSE; DECLARATION OF INTENT. (a) The
- creation of the district is essential to accomplish the purposes of
- 23 Sections 52 and 52-a, Article III, and Section 59, Article XVI,
- 24 Texas Constitution, and other public purposes stated in this

- 1 chapter. By creating the district and in authorizing the City of
- 2 Pearland, Harris County, and other political subdivisions to
- 3 contract with the district, the legislature has established a
- 4 program to accomplish the public purposes set out in Section 52-a,
- 5 Article III, Texas Constitution.
- 6 (b) The creation of the district is necessary to promote,
- 7 develop, encourage, and maintain employment, commerce,
- 8 transportation, housing, tourism, recreation, the arts,
- 9 entertainment, economic development, safety, and the public
- 10 welfare in the district.
- 11 (c) This chapter and the creation of the district may not be
- 12 interpreted to relieve Harris County or the City of Pearland from

- 17 Sec. 3838.004. FINDINGS OF BENEFIT AND PUBLIC PURPOSE. (a)
- 18 The district is created to serve a public use and benefit.
- 19 (b) All land and other property included in the district
- 20 will benefit from the improvements and services to be provided by
- 21 the district under powers conferred by Sections 52 and 52-a,
- 22 Article III, and Section 59, Article XVI, Texas Constitution, and
- 23 <u>other powers granted under this chapter.</u>
- 24 (c) The creation of the district is in the public interest
- 25 and is essential to:
- 26 (1) further the public purposes of developing and
- 27 diversifying the economy of the state;

1	(2) eliminate unemployment and underemployment; and
2	(3) develop or expand transportation and commerce.
3	(d) The district will:
4	(1) promote the health, safety, and general welfare of
5	residents, employers, potential employees, employees, visitors,
6	and consumers in the district, and of the public;
7	(2) provide needed funding for the district to
8	preserve, maintain, and enhance the economic health and vitality of
9	the district territory as a community and business center; and

19	(f) The district will not act as the agent or
20	instrumentality of any private interest even though the district
21	will benefit many private interests as well as the public.
22	Sec. 3838.005. DISTRICT TERRITORY. (a) The district is
23	composed of the territory described by Section 2 of the Act enacting
24	this chapter, as that territory may have been modified under:
25	(1) Subchapter J, Chapter 49, Water Code; or
26	(2) other law.
27	(b) The boundaries and field notes of the district contained

- 1 in Section 2 of the Act enacting this chapter form a closure. A
- 2 mistake in the field notes or in copying the field notes in the
- 3 legislative process does not in any way affect the district's:
- 4 (1) organization, existence, or validity;
- 5 (2) right to issue any type of bond for a purpose for
- 6 which the district is created or to pay the principal of and
- 7 <u>interest on the bond;</u>
- 8 (3) right to impose or collect an assessment or tax; or
- 9 (4) legality or operation.
- 10 Sec. 3838.006. ELIGIBILITY FOR INCLUSION IN SPECIAL ZONES.
- 11 All or any part of the area of the district is eligible to be
- 12 included in:
- 13 (1) a tax increment reinvestment zone created by the
- 14 City of Pearland under Chapter 311, Tax Code;
- 15 (2) a tax abatement reinvestment zone created by the
- 16 <u>City of Pearland under Chapter 312, Tax Code; or</u>
- 17 (3) an enterprise zone created by the City of Pearland
- 18 under Chapter 2303, Government Code.
- 19 Sec. 3838.007. LIBERAL CONSTRUCTION OF CHAPTER. This
- 20 chapter shall be liberally construed in conformity with the
- 21 findings and purposes stated in this chapter.
- Sec. 3838.008. APPLICABILITY OF MUNICIPAL MANAGEMENT
- 23 DISTRICTS LAW. Except as otherwise provided by this chapter,
- 24 Chapter 375, Local Government Code, applies to the district.
- 25 [Sections 3838.009-3838.050 reserved for expansion]
- SUBCHAPTER B. BOARD OF DIRECTORS
- Sec. 3838.051. BOARD OF DIRECTORS; TERMS. The district is

- 1 governed by a board of five directors who serve staggered terms of
- 2 four years, with two or three directors' terms expiring June 1 of
- 3 each odd-numbered year.
- 4 Sec. 3838.052. APPOINTMENT OF DIRECTORS. The mayor and
- 5 members of the governing body of the City of Pearland shall appoint
- 6 directors from persons recommended by the board. A person is
- 7 appointed if a majority of the members of the governing body,
- 8 <u>including the mayor, vote to appoint that person.</u>
- 9 Sec. 3838.053. QUORUM. For purposes of determining the
- 10 requirements for a quorum, the following are not counted:
- 11 (1) a board position vacant for any reason, including
- death, resignation, or disqualification; or
- 13 (2) a director who is abstaining from participation in
- 14 a vote because of a conflict of interest.

4	Sec. 3838.101. ADDITIONAL POWERS OF DISTRICT. The district
5	may exercise the powers given to an economic development
6	corporation under Section 4B, Development Corporation Act of 1979
7	(Article 5190.6, Vernon's Texas Civil Statutes), including the
8	power to own, operate, acquire, construct, lease, improve, or
9	maintain a project described by that section.
10	Sec. 3838.102. NONPROFIT CORPORATION. (a) The board by
11	resolution may authorize the creation of a nonprofit corporation to
12	assist and act for the district in implementing a project or
13	providing a service authorized by this chapter.
14	(b) The nonprofit corporation:
15	(1) has each power of and is considered for purposes of
16	this chapter to be a local government corporation created under
17	Chapter 431, Transportation Code; and
18	(2) may implement any project and provide any service
19	authorized by this chapter.
20	(c) The board shall appoint the board of directors of the
21	nonprofit corporation. The board of directors of the nonprofit
22	corporation shall serve in the same manner as the board of directors

- 5 Sec. 3838.104. AUTHORITY TO CONTRACT FOR LAW ENFORCEMENT.
- 6 To protect the public interest, the district may contract with a
- 7 qualified party, including Harris County or the City of Pearland,
- 8 to provide law enforcement services in the district for a fee.
- 9 Sec. 3838.105. MEMBERSHIP IN CHARITABLE ORGANIZATIONS. The
- 10 district may join and pay dues to an organization that:
- 11 (1) enjoys tax-exempt status under Section 501(c)(3),
- 12 (4), or (6), Internal Revenue Code of 1986; and
- 13 (2) performs a service or provides an activity
- 14 consistent with the furtherance of a district purpose.
- Sec. 3838.106. ECONOMIC DEVELOPMENT PROGRAMS. (a) The
- 16 <u>district may establish and provide for the administration of one or</u>
- more programs to promote state or local economic development and to
- 18 stimulate business and commercial activity in the district,
- including programs to:
- 20 (1) make loans and grants of public money, including
- 21 bond proceeds; and
- 22 (2) provide district personnel and services.

- 3 Sec. 3838.107. NO EMINENT DOMAIN. The district may not
- 4 <u>exercise the power of eminent domain.</u>
- 5 [Sections 3838.108-3838.150 reserved for expansion]
- 6 SUBCHAPTER D. PARKING FACILITIES
- 7 Sec. 3838.151. PARKING FACILITIES AUTHORIZED; OPERATION BY
- 8 PRIVATE ENTITY; TAX EXEMPTION. (a) The district may acquire, lease
- 9 <u>as lessor or lessee, construct, develop, own, operate, and maintain</u>
- 10 parking facilities or a system of parking facilities, including:
- 11 (1) lots, garages, parking terminals, or other
- 12 structures or accommodations for parking motor vehicles off the
- 13 streets; and
- 14 (2) equipment, entrances, exits, fencing, and other

- 26 affect the use of the public right-of-way or a requirement for
- 27 off-street parking are subject to all applicable municipal charter,

- 1 code, and ordinance requirements.
- 2 Sec. 3838.153. PAYING COST OF PARKING FACILITIES. (a) The
- 3 district may use any of its resources, including revenue,
- 4 assessments, taxes, or grant or contract proceeds, to pay the cost
- of acquiring or operating a system of public parking facilities.
- 6 (b) The district may:
- 7 (1) set, charge, impose, and collect fees, charges, or
- 8 tolls for the use of the public parking facilities; and
- 9 (2) issue bonds or notes to finance the cost of these
- 10 <u>facilities.</u>
- 11 [Sections 3838.154-3838.200 reserved for expansion]
- 12 SUBCHAPTER E. FINANCIAL PROVISIONS
- 13 Sec. 3838.201. DISBURSEMENTS AND TRANSFERS OF MONEY. The
- 14 board by resolution shall establish the number of directors'
- 15 signatures and the procedure required for a disbursement or
- 16 transfer of the district's money.
- 17 Sec. 3838.202. AUTHORIZATION FOR IMPROVEMENTS OR SERVICES.
- 18 The district may acquire, construct, finance, operate, or maintain
- 19 any improvement or service authorized under this chapter or Chapter
- 20 375, Local Government Code.
- 21 Sec. 3838.203. PETITION REQUIRED FOR FINANCING SERVICES AND
- 22 IMPROVEMENTS. (a) The board may not finance a service or
- 23 <u>improvement project with assessments under this chapter unless a</u>
- 24 written petition requesting that service or improvement has been
- 25 filed with the board.
- 26 (b) A petition requesting a project financed by assessment
- 27 must be signed by the owners of a majority of the assessed value of

- 1 real property in the district subject to assessment according to
- 2 the most recent certified tax appraisal roll for Harris County.
- 3 Sec. 3838.204. AD VALOREM TAX. (a) If authorized at an
- 4 election held in accordance with Section 3838.208, the district may
- 5 impose an annual ad valorem tax on taxable property in the district
- 6 to:
- 7 (1) promote economic development;
- 8 (2) maintain and operate the district;
- 9 (3) construct or acquire improvements; or
- 10 <u>(4)</u> provide a service.
- 11 (b) The board shall determine the tax rate.
- 12 (c) Section 54.601, Water Code, applies to the district.
- Sec. 3838.205. ASSESSMENTS; LIENS FOR ASSESSMENTS. (a)
- 14 The board by resolution may impose and collect an assessment for any
- 15 purpose authorized by this chapter.
- 16 (b) An assessment, a reassessment, or an assessment
- 17 resulting from an addition to or correction of the assessment roll
- 18 by the district, penalties and interest on an assessment or
- 19 reassessment, an expense of collection, and reasonable attorney's
- 20 fees incurred by the district:
- 21 (1) are a first and prior lien against the property
- 22 assessed;
- 23 (2) are superior to any other lien or claim other than
- 24 a lien or claim for county, school district, or municipal ad valorem
- 25 <u>taxes; and</u>
- 26 (3) are the personal liability of and a charge against
- 27 the owners of the property even if the owners are not named in the

- 1 <u>assessment proceedings.</u>
- 2 (c) The lien is effective from the date of the board's
- 3 resolution imposing the assessment until the date the assessment is
- 4 paid. The board may enforce the lien in the same manner that the
- 5 board may enforce an ad valorem tax lien against real property.
- 6 (d) The board may make a correction to or deletion from the
- 7 <u>assessment roll that does not increase the amount of assessment of</u>
- 8 any parcel of land without providing notice and holding a hearing in
- 9 the manner required for additional assessments.
- Sec. 3838.206. UTILITY PROPERTY EXEMPT FROM IMPACT FEES AND
- 11 ASSESSMENTS. The district may not impose an impact fee or
- 12 assessment on the property, including the equipment,
- 13 rights-of-way, facilities, or improvements of:
- 14 (1) an electric utility or a power generation company
- as defined by Section 31.002, Utilities Code;
- 16 (2) a gas utility as defined by Section 101.003 or
- 17 121.001, Utilities Code;
- 18 (3) a telecommunications provider as defined by
- 19 Section 51.002, Utilities Code; or
- 20 (4) a person who provides to the public cable
- 21 <u>television or advanced telecommunications services.</u>
- Sec. 3838.207. BONDS AND OTHER OBLIGATIONS. (a) The
- 23 <u>district may issue bonds or other obligations</u>, by competitive bid
- 24 or negotiated sale, payable wholly or partly from taxes,
- 25 <u>assessments</u>, impact fees, revenue, grants, or other money of the
- 26 district, including economic development funds contributed to the
- 27 district by the municipality or by an economic development

- 1 corporation, or any combination of those sources of money, to pay
- 2 for any authorized purpose of the district.
- 3 (b) In exercising the district's power to borrow, the
- 4 district may issue a bond or other obligation in the form of a bond,
- 5 note, certificate of participation or other instrument evidencing a
- 6 proportionate interest in payments to be made by the district, or
- 7 other type of obligation. The term of a bond issued under this
- 8 chapter may not exceed 40 years from the date of issuance.

- 13 ad valorem taxes.
- 14 (b) The board may include more than one purpose in a single

- Sec. 3838.211. TAX AND ASSESSMENT ABATEMENTS. The district
- 27 may grant in the manner authorized by Chapter 312, Tax Code, an

- 1 abatement for a tax or assessment owed to the district.
- 2 [Sections 3838.212-3838.250 reserved for expansion]
- 3 SUBCHAPTER F. SALES AND USE TAX
- 4 Sec. 3838.251. MEANINGS OF WORDS AND PHRASES. Words and
- 5 phrases used in this subchapter that are defined by Chapters 151 and
- 6 321, Tax Code, have the meanings assigned by Chapters 151 and 321,
- 7 <u>Tax Code</u>.
- 8 Sec. 3838.252. APPLICABILITY OF CERTAIN TAX CODE
- 9 PROVISIONS. (a) Except as otherwise provided by this subchapter,
- 10 Subtitles A and B, Title 2, Tax Code, and Chapter 151, Tax Code,
- 11 apply to taxes imposed under this subchapter and to the
- 12 administration and enforcement of those taxes in the same manner
- 13 that those laws apply to state taxes.
- 14 (b) The provisions of Subchapters B, C, and D, Chapter 321,
- 15 Tax Code, relating to municipal sales and use taxes apply to the
- 16 application, collection, change, and administration of a sales and

- 18 this chapter, as if references in Chapter 321, Tax Code, to a

- 23 <u>Sec. 3838.253. AUTHORIZATION; ELECTION. (a) The district</u>
- 24 may adopt a sales and use tax to serve the purposes of the district
- 25 at an election in which a majority of the voters of the district
- voting in the election approve the adoption of the tax.
- 27 (b) The board by order may call an election to adopt a sales

- 1 and use tax. The election may be held with any other district
- 2 election.
- 3 (c) The district shall provide notice of the election and
- 4 shall hold the election in the manner prescribed by Section
- 5 3838.208.
- 6 (d) The ballots shall be printed to provide for voting for
- 7 or against the proposition: "Adoption of a one-half of one percent
- 8 <u>district sales and use tax in the Pearland Municipal Management</u>
- 9 District No. 1."
- 10 Sec. 3838.254. ABOLISHING SALES AND USE TAX. (a) Except as
- 11 provided in Subsection (b), the board, with the consent of the
- 12 governing body of the municipality where the district is located,
- 13 may abolish the sales and use tax without an election.
- 14 (b) The board may not abolish the sales and use tax if the
- district has outstanding debt secured by the tax.
- Sec. 3838.255. SALES AND USE TAX RATE. (a) On adoption of
- 17 the tax authorized by this subchapter, there is imposed a tax of
- one-half of one percent on the receipts from the sale at retail of
- 19 taxable items within the district, and an excise tax on the use,
- 20 storage, or other consumption within the district of taxable items
- 21 purchased, leased, or rented from a retailer within the district
- 22 during the period that the tax is in effect.
- 23 (b) The rate of the excise tax is the same as the rate of the
- 24 sales tax portion of the tax and is applied to the sales price of the
- 25 <u>taxable item.</u>
- 26 SECTION 2. As of the effective date of this Act, the
- 27 Pearland Municipal Management District No. 1 includes all territory

- 21 SECTION 3. The legislature finds that:
- (1) proper and legal notice of the intention to
- 23 introduce this Act, setting forth the general substance of this
- 24 Act, has been published as provided by law, and the notice and a
- 25 copy of this Act have been furnished to all persons, agencies,
- officials, or entities to which they are required to be furnished by
- 27 the constitution and laws of this state, including the governor,

- 1 who has submitted the notice and Act to the Texas Commission on
- 2 Environmental Quality;
- 3 (2) the Texas Commission on Environmental Quality has
- 4 filed its recommendations relating to this Act with the governor,
- 5 lieutenant governor, and speaker of the house of representatives
- 6 within the required time;
- 7 (3) the general law relating to consent by political
- 8 subdivisions to the creation of districts with conservation,
- 9 reclamation, and road powers and the inclusion of land in those
- 10 districts has been complied with; and
- 11 (4) all requirements of the constitution and laws of
- 12 this state and the rules and procedures of the legislature with
- 13 respect to the notice, introduction, and passage of this Act have
- 14 been fulfilled and accomplished.
- 15 SECTION 4. This Act takes effect immediately if it receives
- 16 a vote of two-thirds of all the members elected to each house, as
- 17 provided by Section 39, Article III, Texas Constitution. If this
- 18 Act does not receive the vote necessary for immediate effect, this
- 19 Act takes effect September 1, 2005.
