H.B. No. 3499

A BILL TO BE ENTITLED

AN ACT

relating to the creation of the Galveston County Municipal Utility District No. 53; providing authority to impose a tax and issue bonds; granting the power of eminent domain.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Subtitle F, Title 6, Special District Local Laws Code, is amended by adding Chapter 8131 to read as follows:

CHAPTER 8131. GALVESTON COUNTY MUNICIPAL UTILITY DISTRICT

NO. 53

SUBCHAPTER A. GENERAL PROVISIONS

Sec. 8131.001. DEFINITIONS. In this chapter:

(1) "Board" means the board of directors of the district.

(2) "Director" means a member of the board.

(3) "District" means the Galveston County Municipal Utility District No. 53.

Sec. 8131.002. NATURE OF DISTRICT. The district is a municipal utility district in Galveston County created under and essential to accomplish the purposes of Section 52, Article III, and Section 59, Article XVI, Texas Constitution.

Sec. 8131.003. CONFIRMATION ELECTION REQUIRED. If the creation of the district is not confirmed at a confirmation election held under Section 8131.023 before September 1, 2009:

(1) the district is dissolved September 1, 2009,

1 except that:

2 (A) any debts incurred shall be paid;

3 (B) any assets that remain after the payment of  
4 debts shall be transferred to Galveston County; and

5 (C) the organization of the district shall be  
6 maintained until all debts are paid and remaining assets are  
7 transferred; and

8 (2) this chapter expires September 1, 2010.

9 Sec. 8131.004. INITIAL DISTRICT TERRITORY. (a) The  
10 district is initially composed of the territory described by  
11 Section 2 of the Act creating this chapter.

12 (b) The boundaries and field notes contained in Section 2 of  
13 the Act creating this chapter form a closure. A mistake made in the  
14 field notes or in copying the field notes in the legislative process  
15 does not affect:

16 (1) the organization, existence, or validity of the  
17 district;

18 (2) the right of the district to impose taxes;

19 (3) the validity of the district's bonds, notes, or  
20 indebtedness; or

21 (4) the legality or operation of the district or the  
22 board.

23 Sec. 8131.005. APPLICABILITY OF OTHER LAW. Except as  
24 otherwise provided by this chapter, Chapters 49 and 54, Water Code,  
25 apply to the district.

1                   SUBCHAPTER A1. TEMPORARY PROVISIONS

2                   Sec. 8131.021. TEMPORARY DIRECTORS. (a) On or after  
3 September 1, 2005, a person who owns land inside the boundaries of  
4 the proposed district may petition the Texas Commission on  
5 Environmental Quality to appoint as temporary directors the five  
6 persons listed in the petition.

7                   (b) The commission shall appoint as temporary directors the  
8 persons listed in a petition received by the commission under  
9 Subsection (a). If the commission receives more than one petition,  
10 the commission shall appoint the directors listed in the first  
11 petition the commission receives.

12                   (c) If a temporary director fails to qualify for office, the  
13 commission shall appoint a person to fill the vacancy.

14                   (d) Temporary directors serve until the earlier of:

15                   (1) the date directors are elected under Section  
16 8131.023; or

17                   (2) the date this chapter expires under Section  
18 8131.003.

19                   Sec. 8131.022. ORGANIZATIONAL MEETING OF TEMPORARY  
20 DIRECTORS. As soon as practicable after all the temporary  
21 directors have qualified under Section 49.055, Water Code, the  
22 temporary directors shall meet at a location in the district  
23 agreeable to a majority of the directors. If a location cannot be  
24 agreed upon, the meeting shall be at the Galveston County  
25 Courthouse. At the meeting, the temporary directors shall elect  
26 officers from among the temporary directors and conduct any other  
27 district business.

1       Sec. 8131.023. CONFIRMATION AND INITIAL DIRECTORS'  
2 ELECTION. The temporary directors shall hold an election to  
3 confirm the creation of the district and to elect five directors as  
4 provided by Section 49.102, Water Code.

5       Sec. 8131.024. INITIAL ELECTED DIRECTORS; TERMS. The  
6 directors elected under Section 8131.023 shall draw lots to  
7 determine which two shall serve terms expiring June 1 following the  
8 first regularly scheduled election of directors under Section  
9 8131.052 and which three shall serve until June 1 following the  
10 second regularly scheduled election of directors.

11       Sec. 8131.025. EXPIRATION OF SUBCHAPTER. This subchapter  
12 expires September 1, 2010.

13       [Sections 8131.026-8131.050 reserved for expansion]

14               SUBCHAPTER B. BOARD OF DIRECTORS

15       Sec. 8131.051. DIRECTORS; TERMS. (a) The district is  
16 governed by a board of five directors.

17       (b) Directors serve staggered four-year terms that expire  
18 June 1 of even-numbered years.

19       Sec. 8131.052. ELECTION OF DIRECTORS. On the uniform  
20 election date in May of each even-numbered year, the appropriate  
21 number of directors shall be elected.

22       [Sections 8131.053-8131.100 reserved for expansion]

23               SUBCHAPTER C. POWERS AND DUTIES

24       Sec. 8131.101. ROAD PROJECTS. The district may construct,  
25 acquire, improve, maintain, or operate macadamized, graveled, or  
26 paved roads or turnpikes, or improvements in aid of those roads or  
27 turnpikes, inside or outside the district.

1       Sec. 8131.102. COMPLIANCE WITH MUNICIPAL CONSENT  
2 ORDINANCES OR RESOLUTIONS. Subject to the limitations of Section  
3 54.016, Water Code, the district shall comply with all applicable  
4 requirements of any ordinance or resolution adopted by the city  
5 council of the City of Texas City, including an ordinance or  
6 resolution adopted before September 1, 2005, that consents to the  
7 creation of the district or to the inclusion of lands within the  
8 district.

9       [Sections 8131.103-8131.150 reserved for expansion]

10       SUBCHAPTER D. GENERAL FINANCIAL PROVISIONS

11       Sec. 8131.151. TAX TO REPAY BONDS FOR ROAD PROJECTS. The  
12 district may impose a tax to pay the principal of or interest on  
13 bonds issued under Section 8131.201.

14       [Sections 8131.152-8131.200 reserved for expansion]

15       SUBCHAPTER E. BONDS

16       Sec. 8131.201. AUTHORITY TO ISSUE BONDS AND OTHER  
17 OBLIGATIONS FOR ROAD PROJECTS. (a) The district may issue bonds or  
18 other obligations as provided by Chapters 49 and 54, Water Code, to  
19 finance the construction, maintenance, or operation of projects  
20 under Section 8131.101.

21       (b) The district may not issue bonds under Subsection (a)  
22 unless the issuance is approved by a vote of a two-thirds majority  
23 of the voters of the district voting at an election called for that  
24 purpose.

25       (c) Bonds or other obligations issued or incurred to finance  
26 projects authorized by Section 8131.101 may not exceed one-fourth  
27 of the assessed value of the real property in the district.

1           (d) Sections 49.181 and 49.182, Water Code, do not apply to  
2 a project undertaken by the district under Section 8131.101 or to  
3 bonds issued by the district to finance the project.

4           SECTION 2. The Galveston County Municipal Utility District  
5 No. 53 initially includes all the territory contained in the  
6 following area:

7 TRACT I:

8           BEING a 299.300-acre (13,037,520 square foot) tract of land  
9 out of the W.G. BANK SURVEY, A-36, Galveston County, Texas, being  
10 out of Lots 2 through 4 and 6 through 21 of the J.F. DUGAT  
11 SUBDIVISION as recorded in Volume 141, Page 37 of the Galveston  
12 County Deed Records, being out of the remainder of a 249.2069-acre  
13 tract of land conveyed to B.C. Schroeder, Jr., Trustee, as recorded  
14 in Volume 1741, Pages 903 and 908 of the Galveston County Deed  
15 Records, being out of a 60.0-acre tract of land conveyed to B.C.  
16 Schroeder, Jr., Trustee, as recorded under Galveston County Clerk's

18 B.C. Schroeder, Jr., Trustee, as recorded under Galveston County

17           THENCE South 85° 56' 43" West, a distance of 790.67 feet with  
18 the Northerly line of a tract of land conveyed to Sylvia A. Cantu as  
19 recorded under Galveston County Clerk's File No. 2003019644 to a  
20 1-1/4-inch pipe found in the Northeasterly bank of Gum Bayou for the  
21 most Southwesterly corner of this tract;

22           THENCE in a Northwesterly direction with the meanders of the  
23 Northeasterly bank of Gum Bayou the following bearings and  
24 distances:

19 Coordinate System, South Central Zone:

21 Easterly line of the J.F. Dugat Subdivision as recorded in Volume  
22 141, Page 37 of the Galveston County Deed Records and in the  
23 Easterly line of the remainder of a 249.2069-acre tract of land  
24 conveyed to B.C. Schroeder, Jr., Trustee, as recorded in Volume  
25 1741, Page 903 of the Galveston County Deed Records for the  
26 Southwesterly corner of Lot G of said JONES SUBDIVISION, for the  
27 Northwesterly corner of said Lot H and for the Northwesterly corner

1 of this tract;

2           THENCE North 86 deg. 55 min. 39 sec. East, a distance of  
3 1,213.09 feet with the Southerly line of said Lot G to a 5/8-inch  
4 iron rod with cap stamped "Weisser Eng. Houston, Tx." set in the  
5 Westerly right-of-way line of F.M. Road No. 3436 (100 feet wide) for  
6 the Northeasterly corner of this tract, from which a 1/2-inch iron  
7 rod found bears South 78 deg. 26 min. 26 sec. West, a distance of  
8 0.38 feet;

9           THENCE South 03 deg. 04 min. 39 sec. East, a distance of  
10 1,705.00 feet with the Westerly right-of-way line of said FM. Road  
11 No. 3436 to a 5/8-inch iron rod with cap stamped "Weisser Eng.  
12 Houston, Tx." set for the Southeasterly corner of this tract;

13           THENCE South 86 deg. 55 min. 39 sec. West, a distance of  
14 1,213.24 feet over and across said Lot J to a 5/8-inch iron rod with  
15 cap stamped "Weisser Eng. Houston, TX." set for the Southwesterly  
16 corner of this tract;

17           THENCE North 03 deg. 04 min. 21 sec. West, a distance of  
18 1,705.00 feet with the Westerly line of said Lots H, I and J and with  
19 the Easterly line of said J.F. Dugat Subdivision to the POINT OF  
20 BEGINNING and CONTAINING 47.485 acres (2,068,447 square feet) of  
21 land.

22           SECTION 3. (a) The legal notice of the intention to  
23 introduce this Act, setting forth the general substance of this  
24 Act, has been published as provided by law, and the notice and a  
25 copy of this Act have been furnished to all persons, agencies,  
26 officials, or entities to which they are required to be furnished  
27 under Section 59, Article XVI, Texas Constitution, and Chapter 313,

1 Government Code.

2 (b) The governor, one of the required recipients, has  
3 submitted the notice and Act to the Texas Commission on  
4 Environmental Quality.

5 (c) The Texas Commission on Environmental Quality has filed  
6 its recommendations relating to this Act with the governor, the  
7 lieutenant governor, and the speaker of the house of  
8 representatives within the required time.

9 (d) All requirements of the constitution and laws of this  
10 state and the rules and procedures of the legislature with respect  
11 to the notice, introduction, and passage of this Act are fulfilled  
12 and accomplished.

13 SECTION 4. This Act takes effect September 1, 2005.
