A BILL TO BE ENTITLED

1	AN ACT
2	relating to the creation of the West Ranch Management District;
3	providing authority to impose a tax and issue a bond or similar
4	obligation and granting a limited power of eminent domain.
5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. WEST RANCH MANAGEMENT DISTRICT. Subtitle C,
7	Title 4, Special District Local Laws Code, is amended by adding
8	Chapter 3837 to read as follows:
9	CHAPTER 3837. WEST RANCH MANAGEMENT DISTRICT
10	SUBCHAPTER A. GENERAL PROVISIONS
11	Sec. 3837.001. DEFINITIONS. In this chapter:
12	(1) "Board" means the board of directors of the
13	district.
14	(2) "District" means the West Ranch Management
15	District.
16	Sec. 3837.002. WEST RANCH MANAGEMENT DISTRICT. The West
17	Ranch Management District is a special district created under
18	Section 59, Article XVI, Texas Constitution.
19	Sec. 3837.003. PURPOSE; DECLARATION OF INTENT. (a) The
20	creation of the district is essential to accomplish the purposes of
21	Sections 52 and 52-a, Article III, and Section 59, Article XVI,
22	Texas Constitution, and other public purposes stated in this
23	chapter. By creating the district and in authorizing the City of

Friendswood, Galveston and Harris Counties, and other political

- 1 subdivisions to contract with the district, the legislature has
- 2 established a program to accomplish the public purposes set out in
- 3 Section 52-a, Article III, Texas Constitution.
- 4 (b) The creation of the district is necessary to promote,
- 5 develop, encourage, and maintain employment, commerce,
- 6 transportation, housing, tourism, recreation, the arts,
- 7 entertainment, economic development, education, safety, and the
- 8 public welfare in the district.
- 9 (c) This chapter and the creation of the district may not be
- 10 <u>interpreted to relieve Galveston and Harris Counties and the City</u>
- of Friendswood from providing the level of services provided as of
- 12 the effective date of the Act enacting this chapter, to the area in
- 13 the district. The district is created to supplement and not to
- 14 supplant the county or city services provided in the area in the
- 15 <u>district.</u>
- Sec. 3837.004. FINDINGS OF BENEFIT AND PUBLIC PURPOSE. (a)
- 17 The district is created to serve a public use and benefit.
- (b) All land and other property included in the district
- 19 will benefit from the improvements and services to be provided by
- 20 the district under powers conferred by Sections 52 and 52-a,
- 21 Article III, and Section 59, Article XVI, Texas Constitution, and
- 22 other powers granted under this chapter.
- (c) The creation of the district is in the public interest
- 24 and is essential to:
- 25 (1) further the public purposes of developing and
- 26 diversifying the economy of the state;
- 27 (2) eliminate unemployment and underemployment; and

Τ	(3) develop or expand transportation and commerce.
2	(d) The district will:
3	(1) promote the health, safety, education, and general
4	welfare of residents, employers, potential employees, employees,
5	visitors, and consumers in the district, and of the public;
6	(2) provide needed funding for the district to
7	preserve, maintain, and enhance the economic health and vitality of
8	the district territory as a community and business center; and
9	(3) promote the health, safety, welfare, education,
10	and enjoyment of the public by providing pedestrian ways and by
11	landscaping and developing certain areas in the district, which are
12	necessary for the restoration, preservation, and enhancement of
13	scenic beauty.
14	(e) Pedestrian ways along or across a street, whether at
15	grade or above or below the surface, and street lighting, street
16	landscaping, parking, and street art objects are parts of and
17	necessary components of a street and are considered to be a street
18	or road improvement.
19	(f) The district will not act as the agent or
20	instrumentality of any private interest even though the district
21	will benefit many private interests as well as the public.
22	Sec. 3837.005. DISTRICT TERRITORY. (a) The district is
23	composed of the territory described by Section 2 of the Act enacting
24	this chapter, as that territory may have been modified under:
25	(1) Subchapter J, Chapter 49, Water Code; or
26	(2) other law.
27	(b) The boundaries and field notes of the district contained

- 1 in Section 2 of the Act enacting this chapter form a closure. A
- 2 mistake in the field notes or in copying the field notes in the
- 3 legislative process does not in any way affect the district's:
- 4 (1) organization, existence, or validity;
- 5 (2) right to issue any type of bond for a purpose for
- 6 which the district is created or to pay the principal of and
- 7 <u>interest on the bond;</u>
- 8 (3) right to impose or collect an assessment or tax; or
- 9 (4) legality or operation.
- Sec. 3837.006. ELIGIBILITY FOR INCLUSION IN SPECIAL ZONES.
- 11 All or any part of the area of the district is eligible to be
- 12 included in:
- 13 (1) a tax increment reinvestment zone created by a
- 14 municipality under Chapter 311, Tax Code;
- 15 (2) a tax abatement reinvestment zone created by a
- 16 <u>municipality under Chapter 312, Tax Code; or</u>
- 17 (3) an enterprise zone created by a municipality under
- 18 Chapter 2303, Government Code.
- 19 Sec. 3837.007. APPLICABILITY OF MUNICIPAL MANAGEMENT
- 20 DISTRICTS LAW. Except as otherwise provided by this chapter,
- 21 Chapter 375, Local Government Code, applies to the district.
- Sec. 3837.008. LIBERAL CONSTRUCTION OF CHAPTER. This
- 23 chapter shall be liberally construed in conformity with the
- 24 findings and purposes stated in this chapter.
- 25 [Sections 3837.009-3837.050 reserved for expansion]
- SUBCHAPTER B. BOARD OF DIRECTORS
- Sec. 3837.051. GOVERNING BODY. The district is governed by

- 1 a board of five directors who serve staggered terms of four years,
- 2 with two or three directors' terms expiring June 1 of each
- 3 odd-numbered year.
- 4 Sec. 3837.052. APPOINTMENT OF DIRECTORS. (a) The
- 5 governing body of the City of Friendswood shall appoint the
- 6 directors of the board. The governing body shall appoint:
- 7 (1) three directors from a list of persons nominated
- 8 by the board; and
- 9 (2) two directors chosen by the governing body.
- 10 (b) The board may nominate any eligible person for
- 11 appointment to the board. If a person owns 25 percent or more of the
- 12 land in the district, the board shall request that the person
- provide to the board a list of persons for the board to consider for
- 14 <u>nomination under this section. If the person does not provide a</u>
- 15 list of persons to the board for that purpose before the 31st day
- 16 after the date the board requests the list, the board is not
- 17 required to obtain a list from that person. If more than one person
- owns 25 percent or more of the land included in the district, only
- 19 the person who owns the greatest amount of land included in the
- 20 district is entitled to have the board request a list under this
- 21 <u>subsection</u>.
- Sec. 3837.053. REMOVAL OF DIRECTORS CHOSEN BY CITY. The
- 23 City of Friendswood for any reason may remove a director appointed
- under Section 3837.052(a)(2) and appoint a person to serve the
- 25 remainder of that director's term.
- Sec. 3837.054. VACANCY IN OFFICE OF DIRECTOR. (a) The
- 27 board may appoint a person to fill a vacancy in the office of a

- 1 director appointed under Section 3837.052(a)(1) for the remainder
- 2 of the director's term.
- 3 (b) The City of Friendswood may appoint a person to fill a
- 4 vacancy in the office of a director appointed under Section
- 5 3837.052(a)(2) for the remainder of the director's term.
- 6 Sec. 3837.055. QUORUM. Vacant director positions are not
- 7 counted for the purposes of establishing a board quorum.
- 8 Sec. 3837.056. CONFLICTS OF INTEREST; ONE-TIME AFFIDAVIT.
- 9 (a) Except as provided by this section:
- 10 (1) a director may participate in all board votes and
- 11 decisions; and
- 12 (2) Chapter 171, Local Government Code, governs
- 13 conflicts of interest for directors.
- 14 (b) Section 171.004, Local Government Code, does not apply
- 15 to the district. A director who has a substantial interest in a
- 16 <u>business or charitable entity that will receive a pecuniary benefit</u>
- from a board action shall file a one-time affidavit declaring the
- 18 interest. An additional affidavit is not required if the
- 19 director's interest changes. After the affidavit is filed with the
- 20 board secretary, the director may participate in a discussion or
- 21 vote on that action if:
- (1) a majority of the directors have a similar
- 23 <u>interest in the same entity; or</u>
- 24 (2) all other similar business or charitable entities
- in the district will receive a similar pecuniary benefit.
- 26 (c) A director who is also an officer or employee of a public
- 27 entity may not participate in the discussion of or vote on a matter

1 regarding a contract with that public entity. 2 (d) For purposes of this section, a director has a substantial interest in a charitable entity in the same manner that 3 4 a person would have a substantial interest in a business entity under Section 171.002, Local Government Code. 5 6 Sec. 3837.057. INITIAL DIRECTORS. (a) The initial board consists of two directors appointed by the governing body of the 7 City of Friendswood to serve in positions 1 and 2 and the following 8 persons to serve in positions 3-5: 9 10 Pos. No. Name of Director 11 J<u>oe Stunja</u> 3 12 4 Jeff Anderson 13 5 Doug Konopka (b) Of the initial directors, the terms of the directors 14 15 appointed for positions 1 and 3 expire June 1, 2007, and the terms of the directors appointed for positions 2, 4, and 5 expire June 1, 16 17 2009. (c) Section 3837.052 does not apply to this section. 18 19 (d) The governing body of the City of Friendswood may remove a director the governing body appoints under this section and may 20 21 appoint a person to serve the remainder of the director's term. (e) This section expires September 1, 2009. 22

- 5 Sec. 3837.102. DRAINAGE OR DETENTION FACILITY; EMINENT
- 6 DOMAIN POWER. (a) The district may exercise the power of eminent
- 7 domain to provide for a drainage or detention facility to serve the
- 8 district in the same manner as provided by Chapter 54, Water Code,
- 9 for a district operating under that chapter.
- 10 (b) The district may not exercise the power of eminent
- 11 domain to acquire property owned by the City of Friendswood,
- 12 Galveston County, or Harris County.
- (c) The district may not exercise the power of eminent
- domain for any other purpose.
- Sec. 3837.103. AGREEMENTS; GRANTS. (a) The district may
- 16 make an agreement with or accept a gift, grant, or loan from any
- 17 person.
- 18 (b) The implementation of a district project is a
- 19 governmental function or service for the purposes of Chapter 791,
- 20 Government Code.
- 21 Sec. 3837.104. AUTHORITY TO CONTRACT FOR LAW ENFORCEMENT.
- 22 To protect the public interest, the district may contract with the
- 23 City of Friendswood for the city to provide law enforcement
- 24 services in the district that exceed the services that would
- otherwise be provided in the district by the city.
- 26 Sec. 3837.105. MEMBERSHIP IN CHARITABLE ORGANIZATIONS. The
- 27 district may join and pay dues to an organization that:

1	(1) enjoys tax-exempt status under Section 501(c)(3),
2	(4), or (6), Internal Revenue Code of 1986; and
3	(2) performs a service or provides an activity
4	consistent with the furtherance of a district purpose.
5	Sec. 3837.106. ECONOMIC DEVELOPMENT PROGRAMS. (a) The
6	district may establish and provide for the administration of one or
7	more programs to promote state or local economic development and to
8	stimulate business and commercial activity in the district,
9	<pre>including programs to:</pre>
10	(1) make loans and grants of public money; and
11	(2) provide district personnel and services.
12	(b) For purposes of this section, the district has all of
13	the powers of a municipality under Chapter 380, Local Government
14	Code.
15	[Sections 3837.107-3837.150 reserved for expansion]
16	SUBCHAPTER D. FINANCIAL PROVISIONS
17	Sec. 3837.151. DISBURSEMENTS AND TRANSFERS OF MONEY. The
18	board by resolution shall establish the number of directors'
19	signatures and the procedure required for a disbursement or
20	transfer of the district's money.
21	Sec. 3837.152. PETITION REQUIRED FOR FINANCING SERVICES AND
22	IMPROVEMENTS WITH ASSESSMENTS. (a) The board may not finance a
23	service or improvement project with assessments under this chapter
24	unless a written petition requesting that service or improvement
25	has been filed with the board.
26	(b) A petition filed under Subsection (a) must be signed by
27	the owners of a majority of the assessed value of real property in

- 1 the district subject to assessment according to the most recent
- 2 certified tax appraisal rolls for Harris County and Galveston
- 3 County, as applicable.
- 4 Sec. 3837.153. AD VALOREM TAX. (a) If authorized at an
- 5 election held in accordance with Section 3837.157, the district may
- 6 impose an annual ad valorem tax on taxable property in the district
- 7 <u>for any district purpose, including to:</u>
- 8 <u>(1) maintain and operate the district;</u>
- 9 (2) construct or acquire improvements, sites, or
- 10 appurtenances; or
- 11 (3) provide a service.
- 12 (b) The board shall determine the tax rate.
- 13 Sec. 3837.154. UTILITY PROPERTY EXEMPT FROM IMPACT FEES AND
- 14 ASSESSMENTS. The district may not impose an impact fee or
- 15 assessment on the property, including the equipment,
- 16 rights-of-way, facilities, or improvements, of:
- 17 (1) an electric utility or a power generation company
- 18 as defined by Section 31.002, Utilities Code;
- 19 (2) a gas utility as defined by Section 101.003 or
- 20 <u>121.001</u>, <u>Utilities Code</u>;
- 21 (3) a telecommunications provider as defined by
- 22 Section 51.002, Utilities Code; or
- 23 (4) a person who provides to the public cable
- television or advanced telecommunications services.
- Sec. 3837.155. BONDS AND OTHER OBLIGATIONS; APPROVAL BY
- 26 CITY OF FRIENDSWOOD. (a) The district may issue bonds or other
- 27 obligations payable wholly or partly from taxes, assessments,

- 1 impact fees, revenue, grants, or other money of the district, or any
- 2 combination of those sources of money, to pay for any authorized
- 3 purpose of the district.
- 4 (b) The district may issue a bond or other obligation in the
- 5 form of a bond, note, certificate of participation or other
- 6 instrument evidencing a proportionate interest in payments to be
- 7 made by the district, or other type of obligation.
- 8 (c) The district must obtain the approval of the City of
- 9 Friendswood for the issuance of bonds or other obligations for any
- 10 improvement project.
- 11 Sec. 3837.156. TAXES FOR BONDS AND OTHER OBLIGATIONS. At
- the time bonds or other obligations payable wholly or partly from ad
- 13 valorem taxes are issued:
- 14 (1) the board shall impose a continuing direct annual
- 15 ad valorem tax, without limit as to rate or amount, for each year
- that all or part of the bonds are outstanding; and
- 17 (2) the district annually shall impose the continuing
- 18 direct ad valorem tax on all taxable property in the district in an
- 19 amount sufficient to:
- 20 (A) pay the interest on the bonds or other
- 21 <u>obligations as the interest becomes due;</u>
- 22 (B) create a sinking fund for the payment of the
- 23 principal of the bonds or other obligations when due or the
- redemption price at any earlier required redemption date; and
- 25 (C) pay the expenses of imposing the taxes.
- Sec. 3837.157. TAX AND BOND ELECTIONS. (a) The district
- 27 shall hold an election in the manner provided by Subchapter L,

- 1 Chapter 375, Local Government Code, to obtain voter approval before
- 2 the district imposes a maintenance tax or issues bonds payable from
- 3 ad valorem taxes.
- 4 (b) The board may include more than one purpose in a single
- 5 proposition at an election.
- 6 (c) Section 375.243, Local Government Code, does not apply
- 7 to the district.
- 8 Sec. 3837.158. CITIES NOT REQUIRED TO PAY DISTRICT
- 9 OBLIGATIONS. Except as provided by Section 375.263, Local
- 10 Government Code, a municipality is not required to pay a bond, note,
- 11 or other obligation of the district.
- Sec. 3837.159. COMPETITIVE BIDDING. (a) The competitive
- 13 bidding provisions of Subchapter I, Chapter 49, Water Code, apply
- 14 to the district for a contract to acquire or construct a water, a
- 15 wastewater, or a drainage or detention improvement.
- (b) Subchapter K, Chapter 375, Local Government Code, does
- 17 not apply to the district.
- 18 [Sections 3837.160-3837.200 reserved for expansion]
- 19 SUBCHAPTER E. DISSOLUTION
- Sec. 3837.201. DISSOLUTION OF DISTRICT WITH OUTSTANDING
- 21 DEBT. (a) The board may dissolve the district regardless of
- 22 whether the district has debt. Section 375.264, Local Government
- 23 Code, does not apply to the district.
- 24 (b) If the district has debt when it is dissolved, the
- 25 district shall remain in existence solely for the purpose of
- 26 discharging its debts. The dissolution is effective when all debts
- 27 have been discharged.

- 4 that:
- 5 (1) proper and legal notice of the intention to

- 23 respect to the notice, introduction, and passage of this Act have

- 25 SECTION 4. EFFECTIVE DATE. This Act takes effect
- 26 immediately if it receives a vote of two-thirds of all the members
- 27 elected to each house, as provided by Section 39, Article III, Texas

- 1 Constitution. If this Act does not receive the vote necessary for
- 2 immediate effect, this Act takes effect September 1, 2005.
