A BILL TO BE ENTITLED

2	relating to the creation, administration, powers, duties,
3	functions, operations, and financing of the Parker County Special
4	Utility District; providing authority to issue bonds.
5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Subtitle C, Title 6, Special District Local Laws
7	Code, is amended by adding Chapter 7202 to read as follows:
8	CHAPTER 7202. PARKER COUNTY SPECIAL UTILITY DISTRICT
9	SUBCHAPTER A. GENERAL PROVISIONS
LO	Sec. 7202.001. DEFINITION. In this chapter, "district'
L1	means the Parker County Special Utility District.
L2	Sec. 7202.002. NATURE OF DISTRICT. The district is a
L3	special utility district in Parker and Palo Pinto Counties created
L4	under and essential to accomplish the purposes of Section 59,
L5	Article XVI, Texas Constitution.
L6	Sec. 7202.003. CONFIRMATION ELECTION REQUIRED. If the
L7	creation of the district is not confirmed at a confirmation and
L8	initial directors' election held before September 1, 2007:
L9	(1) the district is dissolved on September 1, 2007,
20	<pre>except that:</pre>
21	(A) any debts incurred shall be paid;
22	(B) any assets that remain after the payment of
23	debts shall be transferred to Parker or Palo Pinto County as

appropriate; and

- 1 (C) the organization of the district shall be
- 2 maintained until all debts are paid and remaining assets are
- 3 transferred; and
- 4 (2) this chapter expires September 1, 2010.
- 5 Sec. 7202.004. APPLICABILITY OF OTHER SPECIAL UTILITY
- 6 DISTRICT LAW. Except as otherwise provided by this chapter,
- 7 Chapters 49 and 65, Water Code, apply to the district.
- 8 Sec. 7202.005. DISTRICT SUPERVISION. The rights, powers,
- 9 privileges, authority, functions, and duties of the district are
- 10 subject to the continuing right of supervision of the state to be
- 11 <u>exercised</u> by and through the Texas Commission on Environmental
- 12 Quality.
- 13 Sec. 7202.006. INITIAL DISTRICT TERRITORY. (a) The
- 14 district is initially composed of the territory described by
- 15 Section 2 of the Act creating this chapter.
- 16 (b) The boundaries and field notes contained in Section 2 of
- 17 the Act creating this chapter form a closure. A mistake made in the
- 18 field notes or in copying the field notes in the legislative process
- 19 does not affect:
- (1) the organization, existence, or validity of the
- 21 <u>district;</u>
- 22 (2) the right of the district to issue any type of
- 23 bond, including a refunding bond, for a purpose for which the
- 24 district is created or to pay the principal of and interest on a
- 25 bond; or
- 26 (3) the legality or operation of the district or the
- 27 board of directors of the district.

2	SUBCHAPTER A-1. TEMPORARY PROVISIONS
3	Sec. 7202.021. TEMPORARY DIRECTORS. (a) The temporary
4	board of directors of the district is composed of:
5	(1) Jennifer Edwards;
6	(2) Bob Elder;
7	(3) James Estes;
8	(4) Bonnie Finch;
9	(5) Mike Hooten;
10	(6) Skip Queen; and
11	(7) George Wootten.
12	(b) Each temporary director shall qualify for office as
13	provided by Section 49.055, Water Code.
14	(c) If a temporary director fails to qualify for office, the
15	temporary directors who have qualified shall appoint a person to
16	fill the vacancy. If at any time there are fewer than four
17	qualified temporary directors, the Texas Commission on
18	Environmental Quality shall appoint the necessary number of
19	directors to fill all vacancies on the board.
20	(d) Temporary directors serve until initial directors are
21	elected under Section 7202.022.
22	Sec. 7202.022. CONFIRMATION AND INITIAL DIRECTORS'
23	ELECTION. (a) The temporary directors shall hold an election to
24	confirm the creation of the district and to elect seven initial
25	directors in accordance with Chapters 49 and 65, Water Code, on or
26	before September 1, 2007.
27	(b) The temporary board of directors shall determine the

- 1 method for determining the initial term of each person on the
- 2 initial board of directors. The terms must be clearly stated on the
- 3 ballot for the confirmation and directors' election.
- (c) Section 41.001(a), Election Code, does not apply to a
- 5 confirmation election held as provided by this section.
- 6 (d) Initial directors serve until the first regularly
- 7 scheduled election of directors under Subchapter C, Chapter 65,
- 8 <u>Water Code</u>.
- 9 Sec. 7202.023. TRANSFER OF ASSETS; DISSOLUTION. (a) If the
- 10 <u>district's creation is confirmed under Section 7202.022</u>, the Parker
- 11 County Water Supply Corporation shall transfer the assets, debts,
- 12 and contractual rights and obligations of the corporation to the
- 13 district.
- 14 (b) Not later than the 30th day after the date of the
- transfer under Subsection (a), the board of directors of the Parker
- 16 <u>County Water Supply Corporation shall commence dissolution</u>
- 17 proceedings of the corporation.
- 18 (c) On dissolution of the Parker County Water Supply
- 19 Corporation, Certificate of Convenience and Necessity No. 12313 is
- 20 considered to be held by the district.
- 21 (d) The board of directors of the Parker County Water Supply
- 22 Corporation shall notify the Texas Commission on Environmental
- 23 Quality of the dissolution of the corporation and of the transfer of
- 24 <u>Certificate of Conveni</u>ence and Necessity No. 12313 to the district.
- (e) On receipt of notice under Subsection (d), the Texas
- 26 Commission on Environmental Quality shall note in its records that
- 27 Certificate of Convenience and Necessity No. 12313 is held by the

- 1 district and shall re-issue the certificate in the name of the
- 2 district without further application or notice.
- 3 Sec. 7202.024. EXPIRATION OF SUBCHAPTER. This subchapter
- 4 expires September 1, 2010.

- 6 SUBCHAPTER B. BOARD OF DIRECTORS
- 7 Sec. 7202.051. DIRECTORS: TERM OF OFFICE. (a) The
- 8 district is governed by a board of not fewer than five and not more
- 9 than 11 directors.
- 10 (b) A member of the board of directors of the district
- 11 serves a three-year term of office and may serve consecutive terms.
- 12 [Sections 7202.052-7202.100 reserved for expansion]
- SUBCHAPTER C. POWERS AND DUTIES
- 14 Sec. 7202.101. WATER SERVICE IMPACT FEE. (a) The district
- 15 may charge a water service impact fee that is equal to the equity
- 16 buy-in fee and connection fee charged by the Parker County Water
- 17 Supply Corporation on November 1, 2004, under that corporation's
- 18 tariff.
- 19 (b) Chapter 395, Local Government Code, does not apply to
- 20 the initial water service impact fee set under this section.
- 21 (c) The district may increase the water service impact fee
- 22 only as provided by Chapter 395, Local Government Code, or as
- 23 approved by the Texas Commission on Environmental Quality.
- 24 SECTION 2. The Parker County Special Utility District
- 25 initially includes all the territory contained in the following

- 26 THENCE South approximately 9,216 feet cross-country;
- 27 THENCE W17° 6' 56"S, approximately 6,375 feet cross-country to a

- 1 point 500 feet north of the centerline of Cougar Road;
- 2 THENCE westerly approximately 2,883 feet along Cougar Road, 500
- 3 feet north of the centerline of Cougar Road;
- 4 THENCE southerly across Cougar Road to a point 500 feet south of the
- 5 centerline of Cougar Road;
- 6 THENCE easterly along Cougar Road, 500 feet south of the centerline
- 7 of Cougar Road, to a point 500 feet west of the centerline of
- 8 Kickapoo Falls Road;
- 9 THENCE southerly approximately 1,586 feet along Kickapoo Falls
- 10 Road, 500 feet west of the centerline of Kickapoo Falls Road;

- 19 THENCE southerly approximately 3,105 feet along Combs Bend Road,
- 20 500 feet west of the centerline of Combs Bend Road;
- 21 THENCE E29 $^{\circ}$ 29' 36"S approximately 3,833 feet cross-country to the
- 22 centerline of Kickapoo Creek;
- 23 THENCE northerly approximately 17,400 feet along the centerline of
- 24 Kickapoo Creek;
- 25 THENCE South approximately 2,787 feet cross-country;
- 26 THENCE East approximately 4,485 feet cross-country;
- 27 THENCE North approximately 6,350 feet cross-country to a point 200

- 1 feet south of the centerline of Big Valley Circle;

- THENCE easterly approximately 4,250 feet along Old Brock Road, 200

- 24 THENCE northerly 200 feet, to the centerline of Old Brock Road;
- 25 THENCE easterly along the centerline of Old Brock Road, to a point
- 26 200 feet east of the intersection of Old Brock Road and Dean Road;

- 17 centerline of U.S. Highway 80, to a point 1,500 east of the
- 18 centerline of Windmill Road;
- 19 THENCE northerly along Windmill Road, 1,500 feet east of the
- 20 centerline of Windmill Road, to a point 1,000 feet north of the
- 21 centerline of Greenwood Road;

- 25 THENCE northerly across Bennett Road, to a point 500 feet west of

- 27 THENCE southerly along Bennett Road, 500 feet west of the

- 1 centerline of Bennett Road, to a point 500 feet north of the
- 2 centerline of Dobbs Valley Road;
- 3 THENCE westerly along Dobbs Valley Road, 500 feet north of the
- 4 centerline of Dobbs Valley Road, to the Palo Pinto/Parker County
- 5 line;
- 6 THENCE South approximately 500 feet and back to the point of
- 7 beginning.
- 8 SECTION 3. (a) The legal notice of the intention to
- 9 introduce this Act, setting forth the general substance of this
- 10 Act, has been published as provided by law, and the notice and a
- 11 copy of this Act have been furnished to all persons, agencies,
- officials, or entities to which they are required to be furnished
- under Section 59, Article XVI, Texas Constitution, and Chapter 313,
- 14 Government Code.
- 15 (b) The governor has submitted the notice and Act to the
- 16 Texas Commission on Environmental Quality.
- 17 (c) The Texas Commission on Environmental Quality has filed
- 18 its recommendations relating to this Act with the governor,
- 19 lieutenant governor, and speaker of the house of representatives
- 20 within the required time.
- 21 (d) All requirements of the constitution and laws of this
- 22 state and the rules and procedures of the legislature with respect
- 23 to the notice, introduction, and passage of this Act are fulfilled
- 24 and accomplished.
- 25 SECTION 4. This Act takes effect immediately if it receives
- 26 a vote of two-thirds of all the members elected to each house, as
- 27 provided by Section 39, Article III, Texas Constitution. If this

- 1 Act does not receive the vote necessary for immediate effect, this
- 2 Act takes effect September 1, 2005.
