8	SUBCHAPTER A. GENERAL PROVISIONS	
9	Sec. 3852.001. DEFINITIONS. In this chapter:	
10	(1) "Board" means the board of directors of the	
11	district.	
12	(2) "District" means the Pflugerville Municipal	
13	Management District No. 1.	

- 14 Sec. 3852.002. PFLUGERVILLE MUNICIPAL MANAGEMENT DISTRICT
- 15 NO. 1. The Pflugerville Municipal Management District No. 1 is a
- 16 special district created under Section 59, Article XVI, Texas
- 17 Constitution.
- 18 Sec. 3852.003. PURPOSE; DECLARATION OF INTENT. (a) The
- 19 <u>creation of the district is essential to accomplish the purposes of</u>
- 20 Sections 52 and 52-a, Article III, and Section 59, Article XVI,
- 21 Texas Constitution, and other public purposes stated in this
- 22 chapter. By creating the district and in authorizing Travis
- 23 County, the City of Pflugerville, and other political subdivisions
- 24 to contract with the district, the legislature has established a

- 1 program to accomplish the public purposes set out in Section 52-a,
- 2 Article III, Texas Constitution.
- 3 (b) The creation of the district is necessary to promote,
- 4 develop, encourage, and maintain employment, commerce,
- 5 transportation, housing, tourism, recreation, the arts,
- 6 entertainment, economic development, safety, and the public
- 7 welfare in the district.
- 8 (c) This chapter and the creation of the district may not be
- 9 interpreted to relieve Travis County or the City of Pflugerville
- 10 from providing the level of services provided as of September 1,
- 11 2005, to the area in the district or to release the county or the
- 12 city from the obligations of each entity to provide services to that
- 13 area. The district is created to supplement and not to supplant the
- 14 county or city services provided in the area in the district.
- 15 Sec. 3852.004. FINDINGS OF BENEFIT AND PUBLIC
- 16 PURPOSE. (a) The district is created to serve a public use and
- 17 benefit.
- (b) All land and other property included in the district
- 19 will benefit from the improvements and services to be provided by
- 20 the district under powers conferred by Sections 52 and 52-a,
- 21 Article III, and Section 59, Article XVI, Texas Constitution, and
- 22 other powers granted under this chapter.
- (c) The creation of the district is in the public interest
- 24 and is essential to:
- 25 (1) further the public purposes of developing and
- 26 diversifying the economy of the state;
- 27 (2) eliminate unemployment and underemployment; and

1	(3) develop or expand transportation and commerce.
2	(d) The district will:
3	(1) promote the health, safety, and general welfare of
4	residents, employers, employees, visitors, and consumers in the
5	district and of the public;
6	(2) provide needed funding to preserve, maintain, and
7	enhance the economic health and vitality of the area as a community
8	and business center; and
9	(3) promote the health, safety, welfare, and enjoyment
10	of the public by providing pedestrian ways and by landscaping and
11	developing certain areas in the district, which are necessary for
12	the restoration, preservation, and enhancement of scenic and
13	aesthetic beauty.
14	(e) Hike and bike trails, pedestrian ways along or across a
15	street, whether at grade or above or below the surface, and street
16	lighting, street landscaping, and street art objects are parts of
17	and necessary components of a street and are considered to be a
18	street or road improvement in accordance with Section 52, Article
19	III, Texas Constitution.
20	(f) The district may not act as the agent or instrumentality
21	of any private interest even though the district will benefit many
22	private interests as well as the public.
23	Sec. 3852.005. DISTRICT TERRITORY. (a) The district is
24	composed of the territory described by Section 2 of the Act enacting
25	this chapter, as that territory may have been modified under:
26	(1) Section 3852.110;
27	(2) Subchapter J, Chapter 49, Water Code; or

1	(3) other law.
2	(b) The boundaries and field notes of the district contained
3	in Section 2 of the Act enacting this chapter form a closure. A
4	mistake in the field notes or in copying the field notes in the
5	legislative process does not affect the district's:
6	(1) organization, existence, or validity;
7	(2) right to issue any type of bond for a purpose for
8	which the district is created or to pay the principal of and
9	interest on the bond;
10	(3) right to impose or collect an assessment or tax; or
11	(4) legality or operation.
12	Sec. 3852.006. ELIGIBILITY FOR INCLUSION IN SPECIAL ZONES.
13	All or any part of the area of the district is eligible to be
14	included in:
15	(1) a tax increment reinvestment zone created by the
16	City of Pflugerville under Chapter 311, Tax Code;
17	(2) a tax abatement reinvestment zone created by the
18	City of Pflugerville under Chapter 312, Tax Code; or
19	(3) an enterprise zone created by the City of
20	Pflugerville under Chapter 2303, Government Code.
21	Sec. 3852.007. APPLICABILITY OF MUNICIPAL MANAGEMENT
22	DISTRICTS LAW. Except as otherwise provided by this chapter,
23	Chapter 375, Local Government Code, applies to the district.
24	Sec. 3852.008. LIBERAL CONSTRUCTION OF CHAPTER. This
25	chapter shall be liberally construed in conformity with the
26	findings and purposes stated in this chapter.

SUBCHAPTER B. BOARD OF DIRECTORS 1 2 Sec. 3852.051. GOVERNING BODY; TERMS. The district is 3 governed by a board of five directors who serve staggered terms of 4 four years. Sec. 3852.052. COMPENSATION. A director is entitled to 5 6 compensation as provided by Section 49.060, Water Code. Sec. 3852.053. ADDITIONAL QUALIFICATIONS. (a) A person is 7 8 eligible for appointment to the board if: 9 (1) the person: 10 (A) owns land in the City of Pflugerville subject 11 to taxation; or 12 (B) is registered to vote in the City of 13 Pflugerville; and 14 (2) the appointment of the person under this section 15 does not result in more than two directors who were eligible solely 16 under this section and not Section 375.063, Local Government Code. (b) Section 375.063, Local Government Code, does not apply 17 to a director appointed under Subsection (a). 18 Sec. 3852.054. APPOINTMENT OF DIRECTORS. (a) The mayor and 19 members of the governing body of the City of Pflugerville shall 20 21 appoint directors from persons recommended by the board. A person 22 is appointed if a majority of the members and the mayor vote to 23 appoint the person.

- Sec. 3852.103. NONPROFIT CORPORATION. (a) The board by
- 16 resolution may authorize the creation of a nonprofit corporation to
- 17 assist and act for the district in implementing a project or
- 18 providing a service authorized by this chapter.
- 19 (b) The nonprofit corporation:
- 20 (1) has each power of and is considered for purposes of
- 21 this chapter to be a local government corporation created under

- 8 grant, or loan from any person.
- 9 (b) A municipality, county, or other political subdivision
- 10 of this state, or a nonprofit corporation, without further
- 11 authorization, may contract with the district for:
- 12 (1) the acquisition, construction, improvement,
- implementation, maintenance, and operation of a district project;
- 14 or
- 15 (2) the provision of a service authorized under this
- 16 <u>chapter.</u>
- 17 (c) A contract under Subsection (b) may:

- 21 revenue that may be available for that purpose; and

- 2 (e) To the extent of any conflict between this section and
- 3 any other law, including a charter of a home-rule municipality,

- 5 (f) The district, the City of Pflugerville, Travis County,
- 6 or another political subdivision may use another law to the extent
- 7 convenient or necessary to carry out any power or authority,
- 8 express or implied, granted by this section.
- 9 (g) This section is wholly sufficient authority for the
- 10 <u>execution of a contract, the imposition and pledging of taxes and</u>
- 11 revenues to the contract, and the performance of other acts and
- 12 procedures authorized by this section, or by the district, the City
- of Pflugerville, Travis County, and any other political subdivision
- 14 without reference to any other provision of law or any restriction
- or limitation contained in those provisions, except as specifically
- 16 provided by this section.
- 17 Sec. 3852.106. ECONOMIC DEVELOPMENT PROGRAMS AND OTHER
- 18 POWERS RELATED TO PLANNING AND DEVELOPMENT. (a) The district may
- 19 establish and provide for the administration of one or more
- 20 programs to promote state or local economic development and to
- 21 stimulate business and commercial activity in the district,
- 22 including programs to:
- (1) make loans and grants of public money; and
- 24 (2) provide district personnel and services.
- 25 (b) The district has all of the powers of a municipality
- 26 under Chapter 380, Local Government Code.

- 1 To protect the public interest, the district may contract with
- 2 Travis County or the City of Pflugerville for the county or city to

- 4 Sec. 3852.108. COMPETITIVE BIDDING. Section 375.221, Local
- 5 Government Code, does not apply to a district contract for \$25,000
- 6 or less.
- 7 Sec. 3852.109. APPROVAL BY CITY OF PFLUGERVILLE. (a)
- 8 Except as provided by Subsection (b), the district must obtain
- 9 <u>approval from the City of Pflugerville's governing body:</u>
- 10 (1) for the issuance of a bond other than a refunding
- 11 bond;
- 12 (2) of the plans and specifications of a project to be
- 13 financed by the bond; and
- 14 (3) of the plans and specifications of any district

3	Sec. 3852.151. PETITION REQUIRED FOR FINANCING SERVICES AND
4	IMPROVEMENTS. (a) The board may not finance a service or an
5	improvement project with assessments under this chapter unless a
6	written petition requesting that service or improvement is filed
7	with the board.
8	(b) The petition must be signed by the owners of a majority
9	of the assessed value of real property in the area of the district
10	that will be subject to the assessment according to the most recent
11	certified tax appraisal roll for Travis County.
12	Sec. 3852.152. DISBURSEMENTS AND TRANSFERS OF MONEY. The
13	board by resolution shall establish the number of directors'
14	signatures and the procedure required for a disbursement or
15	transfer of the district's money.
16	Sec. 3852.153. MAINTENANCE TAX. (a) The district may
17	impose an annual ad valorem tax on taxable property in the district
18	to maintain and operate the district and the improvements and
19	projects constructed or acquired by the district or to provide a
20	service only if:
21	(1) two-thirds of the directors vote in favor of
22	imposing the tax; and
23	(2) the tax is authorized at an election held in
24	accordance with Section 3852.156.
25	(b) The board shall determine the tax rate.
26	Sec. 3852.154. ASSESSMENTS; LIENS FOR ASSESSMENTS. (a)
27	The board by resolution may impose and collect an assessment for any

- 1 purpose authorized by this chapter only if two-thirds of the
- 2 directors vote in favor of imposing the assessment.
- 3 (b) The board may adjust an annual assessment for a service
- 4 in accordance with an annual budget adopted by the board to provide
- 5 those services. The annual adjustment may not be more than the
- 6 original assessment unless the board provides notice and hearing.
- 7 (c) An assessment, a reassessment, or an assessment
- 8 resulting from an addition to, deletion from, or correction of the
- 9 assessment roll by the district, penalties and interest on an
- 10 <u>assessment or reassessment</u>, an expense of collection, and

- Sec. 3852.155. UTILITY PROPERTY EXEMPT FROM IMPACT FEES AND
- 25 ASSESSMENTS. The district may not impose an impact fee or
- 26 assessment on the property of a person who provides to the public
- 27 gas, electric, telephone, sewage, or water service.

- Sec. 3852.156. ELECTIONS REGARDING TAXES OR TAX BONDS. (a)
- 2 In addition to the elections required under Subchapter L, Chapter
- 3 375, Local Government Code, the district must hold an election in
- 4 the manner provided by that subchapter to obtain voter approval
- 5 before the district may:
- 6 (1) impose a maintenance tax;
- 7 (2) issue a bond payable from ad valorem taxes; or
- 8 (3) secure an agreement wholly or partly from a pledge
- 9 of ad valorem taxes.
- 10 (b) The board may submit multiple purposes in a single

- 12 (c) Section 375.243, Local Government Code, does not apply

- 16 partly from taxes, assessments, impact fees, revenue, grants,
- 17 contracts, or other money of the district, or any combination of
- 18 those sources of money, to pay for any authorized purpose of the
- 19 district.
- 20 (b) The district may issue a bond or other obligation in the
- 21 form of a bond, note, certificate of participation or other
- 22 <u>instrument evidencing a proportionate interest in payments to be</u>
- 23 made by the district, or other type of obligation.
- 24 (c) The district may issue a bond to refinance a public
- 25 security issued by the City of Pflugerville or to finance a district
- 26 project located outside the boundaries of the district if the board
- 27 finds that the refinancing or project wholly or partly furthers the

- 1 purposes of and benefits the district.
- 2 (d) Sections 375.208 and 375.243, Local Government Code, do
- 3 not apply to bonds or other obligations issued under this section
- 4 solely to pay for a project constructed by the City of Pflugerville
- 5 and payable wholly or partly from payments made by the City of
- 6 Pflugerville under an agreement authorized under Section 3852.105.
- 7 (e) The district may issue bonds in accordance with terms
- 8 and provisions as determined by the board, including the sale of
- 9 bonds in a manner and with terms as determined by the board. As
- 10 provided by Section 3852.007, Sections 375.202, 375.203, 375.205,
- and 375.206, Local Government Code, apply to bonds issued under
- 12 this section.
- (f) A bond issued under this section may be refunded or
- 14 otherwise refinanced by the issuance of refunding bonds under terms
- or conditions determined by board order or resolution. A refunding
- 16 bond may be issued in an amount necessary to pay the principal and
- 17 any interest and redemption premium of bonds to be refunded, at
- 18 maturity or on any redemption date, and issued to provide for the
- 19 payment of costs incurred in connection with the refunding. A
- 20 refunding bond may be issued in any manner provided by law.
- 21 Sec. 3852.158. ECONOMIC DEVELOPMENT BONDS. The district
- 22 may issue bonds for economic development projects in accordance
- with Section 52-a, Article III, Texas Constitution.
- Sec. 3852.159. MUNICIPALITY NOT OBLIGATED TO PAY DISTRICT
- OBLIGATIONS. Except as provided by Sections 3852.105 and 3852.157
- of this code and Section 375.263, Local Government Code, a
- 27 municipality is not obligated to pay a bond, note, or other

- 1 <u>obligation of the district.</u>

- 3 <u>SUBCHAPTER E. DISSOLUTION</u>
- 4 Sec. 3852.201. DISSOLUTION OF DISTRICT WITH OUTSTANDING
- 5 DEBT. (a) The board may dissolve the district regardless of
- 6 whether the district has debt. Section 375.264, Local Government
- 7 Code, does not apply to the district.
- 8 (b) If the district has debt when it is dissolved, the
- 9 district shall remain in existence solely for the purpose of
- 10 discharging its debts. The dissolution is effective when all debts
- 11 have been discharged.

- 27 SECTION 3. The Pflugerville Municipal Management District

- 1 No. 1 may hold the first election under Section 3852.156, Special
- 2 District Local Laws Code, as added by this Act, on a date other than
- 3 a uniform election date.
- 4 SECTION 4. The legislature finds that:
- 5 (1) proper and legal notice of the intention to
- 6 introduce this Act, setting forth the general substance of this
- 7 Act, has been published as provided by law, and the notice and a
- 8 copy of this Act have been furnished to all persons, agencies,
- 9 officials, or entities to which they are required to be furnished by
- 10 the constitution and laws of this state, including the governor,
- 11 who has submitted the notice and Act to the Texas Commission on
- 12 Environmental Quality;
- 13 (2) the Texas Commission on Environmental Quality has
- 14 filed its recommendations relating to this Act with the governor,
- 15 lieutenant governor, and speaker of the house of representatives
- 16 within the required time;
- 17 (3) the general law relating to consent by political
- 18 subdivisions to the creation of districts with conservation,
- 19 reclamation, and road powers and the inclusion of land in those
- 20 districts has been complied with; and
- 21 (4) all requirements of the constitution and laws of
- 22 this state and the rules and procedures of the legislature with
- 23 respect to the notice, introduction, and passage of this Act have
- 24 been fulfilled and accomplished.
- 25 SECTION 5. This Act takes effect immediately if it receives
- 26 a vote of two-thirds of all the members elected to each house, as
- 27 provided by Section 39, Article III, Texas Constitution. If this

- 1 Act does not receive the vote necessary for immediate effect, this
- 2 Act takes effect September 1, 2005.
