## A BILL TO BE ENTITLED

1	AN ACT
2	relating to the creation of the Ellis County Municipal Utility
3	District No. 1; providing authority to impose a tax and issue bonds;
4	granting the power of eminent domain.
5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Subtitle F, Title 6, Special District Local Laws
7	Code, is amended by adding Chapter 8121 to read as follows:
8	CHAPTER 8121. ELLIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 1
9	SUBCHAPTER A. GENERAL PROVISIONS
10	Sec. 8121.001. DEFINITIONS. In this chapter:
11	(1) "Board" means the board of directors of the
12	district.
13	(2) "Director" means a member of the board.
14	(3) "District" means the Ellis County Municipal
15	Utility District No. 1.
16	Sec. 8121.002. NATURE OF DISTRICT. The district is a
17	municipal utility district in Ellis County created under and
18	essential to accomplish the purposes of Section 52, Article III,
19	and Section 59, Article XVI, Texas Constitution.
20	Sec. 8121.003. CONFIRMATION ELECTION REQUIRED. If the
21	creation of the district is not confirmed at a confirmation
22	election held under Section 8121.022 before September 1, 2007:
23	(1) the district is dissolved September 1, 2007,

except that:

1	(A) any debts incurred shall be paid;
2	(B) any assets that remain after the payment of
3	debts shall be transferred to Ellis County; and
4	(C) the organization of the district shall be
5	maintained until all debts are paid and remaining assets are
6	transferred; and
7	(2) this chapter expires September 1, 2010.
8	Sec. 8121.004. INITIAL DISTRICT TERRITORY. (a) The
9	district is initially composed of the territory described by
10	Section 2 of the Act creating this chapter.
11	(b) The boundaries and field notes contained in Section 2 of
12	the Act creating this chapter form a closure. A mistake made in the
13	field notes or in copying the field notes in the legislative process
14	<pre>does not affect:</pre>
15	(1) the organization, existence, or validity of the
16	district;
17	(2) the right of the district to impose taxes; or
18	(3) the legality or operation of the board.
19	Sec. 8121.005. APPLICABILITY OF OTHER LAW. Except as
20	otherwise provided by this chapter, Chapters 49 and 54, Water Code,
21	apply to the district.
22	[Sections 8121.006-8121.020 reserved for expansion]
23	SUBCHAPTER A-1. TEMPORARY PROVISIONS
24	Sec. 8121.021. TEMPORARY DIRECTORS. (a) On or after
25	September 1, 2005, a person who owns land in the proposed district
26	may submit a petition to the Texas Commission on Environmental
27	Quality requesting that the commission appoint as temporary

- 1 <u>directors the five persons named in the petition.</u>
- 2 (b) The commission shall appoint as temporary directors the
- 3 five persons named in the first petition received by the commission
- 4 under Subsection (a).
- 5 (c) If a temporary director fails to qualify for office, the
- 6 commission shall appoint a person to fill the vacancy.
- 7 (d) As soon as practicable after all of the temporary
- 8 directors have qualified, the temporary directors shall meet and
- 9 elect officers from among their membership.
- 10 (e) Temporary directors serve until the earlier of:
- 11 (1) the date directors are elected under Section
- 12 8121.022; or
- 13 (2) the date this chapter expires under Section
- 14 8121.003.
- 15 Sec. 8121.022. CONFIRMATION AND INITIAL DIRECTORS'
- 16 ELECTION. The temporary directors shall hold an election to
- 17 confirm the creation of the district and to elect five initial
- directors as provided by Section 49.102, Water Code.
- 19 Sec. 8121.023. INITIAL ELECTED DIRECTORS; TERMS. The
- 20 directors elected under Section 8121.022 shall draw lots to
- 21 <u>determine which two shall serve until the first regularly scheduled</u>
- 22 election of directors under Section 8121.052 and which three shall
- 23 <u>serve until the second regularly scheduled election of directors.</u>
- Sec. 8121.024. EXPIRATION OF SUBCHAPTER. This subchapter
- 25 expires September 1, 2010.
- 26 [Sections 8121.025-8121.050 reserved for expansion]

On the uniform 5 6 election date in May of each even-numbered year, the appropriate number of directors shall be elected. 7 8 [Sections 8121.053-8121.100 reserved for expansion] SUBCHAPTER C. POWERS AND DUTIES 9 Sec. 8121.101. COMPLIANCE CITY ORDINANCE 10 WITH OR RESOLUTION. Subject to the limitations of Section 54.016, Water 11 Code, the district shall comply with all valid and applicable 12 requirements of an ordinance or resolution adopted by the city 13 council of the City of Ferris, including an ordinance or resolution 14 15 adopted before September 1, 2005, that consents to the creation of the district or to the inclusion of lands within the district. 16 SECTION 2. - 8 officials, or entities to which they are required to be furnished
- 9 under Section 59, Article XVI, Texas Constitution, and Chapter 313,
- 10 Government Code.
- 11 (b) The governor, one of the required recipients, has
- 12 submitted the notice and Act to the Texas Commission on
- 13 Environmental Quality.
- 14 (c) The Texas Commission on Environmental Quality has filed
- 15 its recommendations relating to this Act with the governor, the
- 16 lieutenant governor, and the speaker of the house of
- 17 representatives within the required time.
- 18 (d) All requirements of the constitution and laws of this
- 19 state and the rules and procedures of the legislature with respect
- 20 to the notice, introduction, and passage of this Act are fulfilled
- 21 and accomplished.
