23	creation of a district is not confirmed at a confirmation election

16	closure. A mistake made in the field notes or in copying the field
17	notes in the legislative process does not affect:
18	(1) the organization, existence, or validity of the

20	(2) the right of the district to impose taxes;
21	(3) the validity of the district's bonds, notes, or
22	indebtedness; or
23	(4) the legality or operation of the district or the
