5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Subtitle F, Title 6, Special District Local Laws
7	Code, is amended by adding Chapter 8140 to read as follows:
8	CHAPTER 8140. EAST MONTGOMERY COUNTY MUNICIPAL UTILITY DISTRICTS
9	NOS. 5, 6, AND 7
10	SUBCHAPTER A. GENERAL PROVISIONS
11	Sec. 8140.001. DEFINITIONS. In this chapter:
12	(1) "Board" or "boards" means, as appropriate, the
13	board of directors of one or all of the districts.
14	(2) "Director" means a member of a board.
15	(3) "District" or "districts" means, as appropriate,
16	one or all of the East Montgomery County Municipal Utility
17	Districts Nos. 5, 6, and 7.
18	Sec. 8140.002. NATURE OF DISTRICT. Each district is a
19	municipal utility district in Montgomery County created under and
20	essential to accomplish the purposes of Section 52, Article III,
21	and Section 59, Article XVI, Texas Constitution.
22	Sec. 8140.003. CONFIRMATION ELECTION REQUIRED. If the
23	creation of a district is not confirmed at a confirmation election
24	held under Section 8140.023 before September 1, 2007:

1	(1) the district is dissolved September 1, 2007,
2	<pre>except that:</pre>
3	(A) any debts incurred shall be paid;
4	(B) any assets that remain after the payment of
5	debts shall be transferred to Montgomery County; and
6	(C) the organization of the district shall be
7	maintained until all debts are paid and remaining assets are
8	transferred; and
9	(2) the provisions of this chapter relating to that
LO	district expire September 1, 2010.
L1	Sec. 8140.004. INITIAL DISTRICT TERRITORY. (a) Each
L2	district is initially composed of the territory described by
L3	Section 2 of the Act creating this chapter.
L4	(b) The boundaries and field notes of each district, as
L5	described by Section 2 of the Act creating this chapter, form a
L6	closure. A mistake made in the field notes or in copying the field
L7	notes in the legislative process does not affect:
L8	(1) the organization, existence, or validity of the
L9	district;
20	(2) the right of the district to impose taxes;
21	(3) the validity of the district's bonds, notes, or
22	indebtedness; or
23	(4) the legality or operation of the district or the
24	board.
25	Sec. 8140.005. APPLICABILITY OF OTHER LAW. Except as
26	otherwise provided by this chapter, Chapters 49 and 54, Water Code,

apply to the districts.

3	Sec. 8140.021. TEMPORARY DIRECTORS. (a) On or after

6	to appoint as temporary directors of that district the five persons
7	listed in the petition.
8	(b) The commission shall appoint as temporary directors the
9	persons listed in a petition received by the commission under
10	Subsection (a). If the commission receives more than one petition
11	for a district, the commission shall appoint the directors listed
12	in the first petition the commission receives.
13	(c) If a temporary director fails to qualify for office, the
14	commission shall appoint a person to fill the vacancy.
15	(d) Temporary directors serve until the earlier of:

20	Sec. 8140.022. ORGANIZATIONAL MEETING OF TEMPORARY
21	DIRECTORS. As soon as practicable after all the temporary
22	directors of a district have qualified under Section 49.055, Water
23	Code, the temporary directors of that district shall meet at a
24	location in the district agreeable to a majority of the directors of
25	that district. If a location cannot be agreed upon, the meeting
26	shall be at the Montgomery County Courthouse. At the meeting, the

temporary directors shall elect officers from among the temporary

1 directors and conduct any other district business. 2 Sec. 8140.023. CONFIRMATION AND INITIAL DIRECTORS' ELECTION. The temporary directors of each district shall hold an 3 4 election to confirm the creation of the district and to elect five 5 directors as provided by Section 49.102, Water Code. 6 Sec. 8140.024. INITIAL ELECTED DIRECTORS; TERMS. The directors of each district elected under Section 8140.023 shall 7 draw lots to determine which two shall serve until the first 8 9 regularly scheduled election of directors under Section 8140.052 and which three shall serve until the second regularly scheduled 10 election of directors. 11 Sec. 8140.025. EXPIRATION OF SUBCHAPTER. This subchapter 12 expires September 1, 2010. 13 14 [Sections 8140.026-8140.050 reserved for expansion] 15 SUBCHAPTER B. BOARD OF DIRECTORS Sec. 8140.051. DIRECTORS; TERMS. (a) Each district is 16 17 governed by a board of five directors. (b) Directors serve staggered four-year terms. 18 Sec. 8140.052. ELECTION OF DIRECTORS. On the uniform 19 election date in May of each even-numbered year, the appropriate 20 21 number of directors of each district shall be elected. 22 [Sections 8140.053-8140.100 reserved for expansion] SUBCHAPTER C. POWERS AND DUTIES 23 Sec. 8140.101. GENERAL POWERS. Each district has all of the 24 rights, powers, privileges, authority, functions, and duties 25

provided by the general law of this state, including Chapters 49 and

54, Water Code, applicable to municipal utility districts created

under Section 59, Article XVI, Texas Constitution. 1 2 Sec. 8140.102. ROAD PROJECTS. To the extent authorized by Section 52, Article III, Texas Constitution, each district may 3 4 construct, maintain, or operate macadamized, graveled, or paved roads or turnpikes, or works, facilities, or improvements in aid of 5 6 those roads or turnpikes, inside or outside the district. Sec. 8140.103. COMPLIANCE WITH MUNICIPAL CONSENT 7 ORDINANCES OR RESOLUTIONS. Subject to the limitations of Section 8 54.016, Water Code, each district shall comply with all applicable 9 requirements of any ordinance or resolution adopted by the city 10 council of the City of Houston, including an ordinance or 11 resolution adopted before September 1, 2005, that consents to the 12 creation of the district or to the inclusion of lands within the 13 14 district. 15 [Sections 8140.104-8140.150 reserved for expansion] SUBCHAPTER D. GENERAL FINANCIAL PROVISIONS 16 Sec. 8140.151. TAX TO REPAY BONDS. Each district may impose 17 a tax to pay the principal of or interest on bonds issued to finance 18 19 projects under Section 8140.102. [Sections 8140.152-8140.200 reserved for expansion] 20 21 SUBCHAPTER E. BONDS Sec. 8140.201. AUTHORITY TO ISSUE BONDS AND OTHER 22 OBLIGATIONS. (a) Each district may issue bonds or other 23 24 obligations as provided by Chapters 49 and 54, Water Code, to

finance the construction, maintenance, or operation of projects

(b) A district may not issue bonds to finance projects

under Sections 8140.101 and 8140.102.
