16	District No. 4 of Kaufman County.
17	Sec. 8138.002. NATURE OF DISTRICT. The district is a
18	municipal utility district in Kaufman County created under and
19	essential to accomplish the purposes of Section 59, Article XVI,
20	Texas Constitution.
21	Sec. 8138.003. CONFIRMATION ELECTION REQUIRED. If the
22	creation of the district is not confirmed at a confirmation
23	election held under Section 8138.023 before September 1, 2007:
24	(1) the district is dissolved September 1, 2007,

1	<pre>except that:</pre>
2	(A) any debts incurred shall be paid;
3	(B) any assets that remain after the payment of
4	debts shall be transferred to Kaufman County; and
5	(C) the organization of the district shall be
6	maintained until all debts are paid and remaining assets are
7	transferred; and
8	(2) this chapter expires September 1, 2010.
9	Sec. 8138.004. INITIAL DISTRICT TERRITORY. (a) The
10	district is initially composed of the territory described by
11	Section 2 of the Act creating this chapter.
12	(b) The boundaries and field notes contained in Section 2 of
13	the Act creating this chapter form a closure. A mistake made in the
14	field notes or in copying the field notes in the legislative process
15	<pre>does not affect:</pre>
16	(1) the organization, existence, or validity of the
17	district;

- 14 Sec. 8138.101. MUNICIPAL UTILITY DISTRICT POWERS AND
- 15 DUTIES. The district has the powers and duties provided by the
- 16 general law of this state, including Chapters 49 and 54, Water Code,
- applicable to municipal utility districts created under Section 59,
- 18 Article XVI, Texas Constitution.
- 19 Sec. 8138.102. ROAD PROJECTS. (a) To the extent authorized
- 20 by Section 52, Article III, Texas Constitution, the district may
- 21 construct, acquire, improve, maintain, or operate macadamized,
- 22 graveled, or paved roads or turnpikes, or improvements in aid of
- 23 those roads or turnpikes, inside the district.
- 24 (b) A project authorized by this section must meet or exceed
- 25 the construction standards adopted by the North Central Texas
- 26 Council of Governments, or its successor agency.
- 27 (c) The district may not undertake a road project unless

- 1 each municipality in whose corporate limits or extraterritorial
- 2 jurisdiction the district is located consents by ordinance or
- 3 resolution. If the district is located outside the
- 4 <u>extraterritorial jurisdiction of a municipality</u>, the district may
- 5 not undertake a road project unless each county in which the
- 6 district is located consents by ordinance or resolution.

- 8 (a) The district may pay out of bond proceeds or other available

- 10 other fees, related to obtaining a new certificate of convenience

- 12 district to provide retail water or sewer service inside or outside
- 13 the district.
- 14 (b) The district may pay out of bond proceeds or other
- 15 available district money all expenses, including the purchase
- 16 price, related to acquiring certificate of convenience and
- 17 necessity rights from another retail public utility to allow the

Section 9 522; or 10 (5) a person who provides to the public advanced telecommunications services. 11 12 [Sections 8138.154-8138.200 reserved for expansion] SUBCHAPTER E. BONDS 13 Sec. 8138.201. AUTHORITY TO ISSUE BONDS AND OTHER 14 15 OBLIGATIONS. (a) The district may issue bonds or other obligations 16 as provided by Chapters 49 and 54, Water Code, and to finance:

- under Section 59, Article XVI, Texas Constitution, and Chapter 313,
- 21 Government Code.
- 22 (b) The governor, one of the required recipients, has
- 23 submitted the notice and Act to the Texas Commission on
- 24 Environmental Quality.
- 25 (c) The Texas Commission on Environmental Quality has filed
- 26 its recommendations relating to this Act with the governor, the
- 27 lieutenant governor, and the speaker of the house of

- 1 representatives within the required time.
- 2 (d) All requirements of the constitution and laws of this 3 state and the rules and procedures of the legislature with respect 4 to the notice, introduction, and passage of this Act are fulfilled
- 5 and accomplished.
- 6 SECTION 4. This Act takes effect immediately if it receives
- 7 a vote of two-thirds of all the members elected to each house, as
- 8 provided by Section 39, Article III, Texas Constitution. If this
- 9 Act does not receive the vote necessary for immediate effect, this
- 10 Act takes effect September 1, 2005.
