A BILL TO BE ENTITLED

AN ACT

relating to the creation of the Rockwall County Municipal Utility Districts Nos. 6, 7, 8, and 9; providing authority to impose a tax and issue bonds; granting the power of eminent domain.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Subtitle F, Title 6, Special District Local Laws Code, is amended by adding Chapter 8136 to read as follows:

CHAPTER 8136. ROCKWALL COUNTY MUNICIPAL UTILITY DISTRICTS

NOS. 6, 7, 8, and 9

SUBCHAPTER A. GENERAL PROVISIONS

Sec. 8136.001. DEFINITIONS. In this chapter:

(1) "Board" or "boards" means, as appropriate, the board of directors of one or all of the districts.

(2) "Director" means a member of the board.

(3) "District" or "districts" means, as appropriate, one or all of the Rockwall County Municipal Utility Districts Nos. 6, 7, 8, and 9.

Sec. 8136.002. NATURE OF DISTRICT. Each district is a municipal utility district in Rockwall County created under and essential to accomplish the purposes of Section 52, Article III, and Section 59, Article XVI, Texas Constitution.

Sec. 8136.003. CONFIRMATION ELECTION REQUIRED. If the creation of a district is not confirmed at a confirmation election held under Section 8136.023 before September 1, 2007:

1 (1) the district is dissolved September 1, 2007,
2 except that:

3 (A) any debts incurred shall be paid;

4 (B) any assets that remain after the payment of
5 debts shall be transferred to Rockwall County; and

6 (C) the organization of the district shall be
7 maintained until all debts are paid and remaining assets are
8 transferred; and

9 (2) the provisions of this chapter relating to that
10 district expire September 1, 2010.

11 Sec. 8136.004. INITIAL DISTRICT TERRITORY. (a) Each
12 district is initially composed of the territory described by
13 Section 2 of the Act creating this chapter.

14 (b) The boundaries and field notes of each district, as
15 described in Section 2 of the Act creating this chapter, form a
16 closure. A mistake made in the field notes or in copying the field
17 notes in the legislative process does not affect:

18 (1) the organization, existence, or validity of the
19 district;

20 (2) the right of the district to impose taxes; or

21 (3) the legality or operation of the district or the
22 board.

23 Sec. 8136.005. APPLICABILITY OF OTHER LAW. Except as
24 otherwise provided by this chapter, Chapters 49 and 54, Water Code,
25 apply to the districts.

2 Sec. 8136.021. TEMPORARY DIRECTORS. (a) The temporary
3 board of each district consists of the following persons:

4 (1) Rockwall County Municipal Utility District No. 6:

1 (b) If a temporary director fails to qualify for office, the
2 remaining temporary directors of that district shall appoint a
3 person to fill the vacancy.

4 (c) Temporary directors serve until the earlier of:

5 (1) the date directors are elected under Section
6 8136.023; or

7 (2) the date the provisions of this chapter relating
8 to that district expire under Section 8136.003.

9 Sec. 8136.022. ORGANIZATIONAL MEETING OF TEMPORARY
10 DIRECTORS. As soon as practicable after all the temporary
11 directors of a district have qualified under Section 49.055, Water
12 Code, the temporary directors of that district shall meet at a
13 location in the district agreeable to a majority of the directors of
14 that district. If a location cannot be agreed upon, the meeting
15 shall be at the Rockwall County Courthouse. At the meeting, the
16 temporary directors shall elect officers from among the temporary
17 directors and conduct any other district business.

18 Sec. 8136.023. CONFIRMATION AND INITIAL DIRECTORS'
19 ELECTION. The temporary directors of each district shall hold an
20 election to confirm the creation of the district and to elect five
21 directors as provided by Section 49.102, Water Code.

22 Sec. 8136.024. INITIAL ELECTED DIRECTORS; TERMS. The
23 directors of each district elected under Section 8136.023 shall
24 draw lots to determine which two shall serve until the first
25 regularly scheduled election of directors under Section 8136.052
26 and which three shall serve until the second regularly scheduled
27 election of directors.

1 Sec. 8136.025. EXPIRATION OF SUBCHAPTER. This subchapter
2 expires September 1, 2010.

3 [Sections 8136.026-8136.050 reserved for expansion]

4 SUBCHAPTER B. BOARD OF DIRECTORS

5 Sec. 8136.051. DIRECTORS; TERMS. (a) Each district is
6 governed by a board of five directors.

7 (b) Directors serve staggered four-year terms.

8 Sec. 8136.052. ELECTION OF DIRECTORS. On the uniform
9 election date in May of each even-numbered year, the appropriate
10 number of directors of each district shall be elected.

11 [Sections 8136.053-8136.100 reserved for expansion]

12 SUBCHAPTER C. POWERS AND DUTIES

13 Sec. 8136.101. GENERAL POWERS. Each district has all of the
14 rights, powers, privileges, authority, functions, and duties
15 provided by the general law of this state, including Chapters 49 and
16 54, Water Code, applicable to municipal utility districts created
17 under Section 59, Article XVI, Texas Constitution.

18 Sec. 8136.102. ROAD PROJECTS. (a) To the extent authorized
19 by Section 52, Article III, Texas Constitution, each district may
20 construct, maintain, or operate paved roads or works, facilities,
21 or improvements in aid of those roads, inside the district.

22 (b) A road project must meet or exceed all applicable
23 construction standards, zoning and subdivision requirements, and
24 regulatory ordinances of each municipality in whose corporate
25 limits or extraterritorial jurisdiction the district is located.
26 If the district is located outside the extraterritorial
27 jurisdiction of a municipality, a road project must meet all

1 applicable construction standards, zoning and subdivision
2 requirements, and regulatory ordinances of each county in which the
3 district is located.

4 (c) The district may not undertake a road project unless
5 each municipality in whose corporate limits or extraterritorial
6 jurisdiction the district is located consents by ordinance or
7 resolution. If the district is located outside the
8 extraterritorial jurisdiction of a municipality, the district may
9 not undertake a road project unless each county in which the
10 district is located consents by ordinance or resolution.

11 Sec. 8136.103. ADDING LAND BY PETITION OF LANDOWNER. Each
12 district may only add land to the district in the manner provided by
13 Section 49.301, Water Code, if a landowner petitions for the
14 addition of land that is:

- 15 (1) adjacent to the boundaries of the district; or
16 (2) separated from the district by public land or
17 right-of-way.

18 Sec. 8136.104. EMINENT DOMAIN. (a) Each district may
19 exercise the power of eminent domain within the boundaries of the
20 district for all public purposes.

21 (b) Each district may exercise the power of eminent domain
22 outside the boundaries of the district only for the purpose of
23 constructing, acquiring, operating, repairing, or maintaining
24 water supply lines or sanitary sewer lines.

25 (c) Each district shall exercise the power of eminent domain
26 in the same manner as required for a county.

1 SUBCHAPTER D. GENERAL FINANCIAL PROVISIONS

2 Sec. 8136.151. TAX TO REPAY BONDS. Each district may impose
3 a tax to pay the principal of or interest on bonds issued to finance
4 projects under Section 8136.102.

5 [Sections 8136.152-8136.200 reserved for expansion]

6 SUBCHAPTER E. BONDS

7 Sec. 8136.201. AUTHORITY TO ISSUE BONDS AND OTHER
8 OBLIGATIONS. (a) Each district may issue bonds or other
9 obligations as provided by Chapters 49 and 54, Water Code, to
10 finance the construction, maintenance, or operation of projects
11 under Sections 8136.101 and 8136.102.

12 (b) A district may not issue bonds to finance projects
13 authorized by Section 8136.102 unless the issuance is approved by a
14 vote of a two-thirds majority of the voters of the district voting
15 at an election called for that purpose.

16 (c) Bonds or other obligations issued or incurred to finance
17 projects authorized by Section 8136.102 may not exceed one-fourth
18 of the assessed value of the real property in the district.

19 (d) Sections 49.181 and 49.182, Water Code, do not apply to
20 a project undertaken by a district under Section 8136.102 or to
21 bonds issued by the district to finance the project.

22 SECTION 2. Each district initially includes, respectively,
23 the territory contained in the following areas as indicated:

24 (1) Rockwall County Municipal Utility District No. 6:
25 BEING a tract of land situated in the S.B. Crabtree Survey, Abstract

27 Survey, Abstract No. 178, in the Town of Fate, Rockwall County,

1 Texas, and being part of a tract of land described in a deed to Fate
2 Land, L.P., a Texas Limited Partnership, recorded in Volume 02919,
3 Page 00099 of the Deed Records of Rockwall County, Texas
4 (D.R.R.C.T.), and being all of a called 15.004 acre tract of land
5 described in a deed to Fate Land, L.P., recorded in Volume 02859,
6 Page 00029, D.R.R.C.T., and being more particularly described as
7 follows:

8 BEGINNING at a point in the east right-of way line of State Highway
9 No. 66 (60' right-of-way) for the southmost corner of 119.39 acre
10 tract of land described as Tract III in a deed to The Crown Hill

21 THENCE North 88 degrees 11 minutes 50 seconds East, along the south
22 line of said Gibbs tract and generally along a fence part-way, a
23 distance of 435.15 feet to a point for the southeast corner of said
24 Gibbs tract;

25 THENCE North 01 degree 48 minutes 10 seconds West, along the east
26 line of said Gibbs tract, a distance of 100.00 feet to a point for
27 the northeast corner thereof;

1 THENCE South 88 degrees 11 minutes 50 seconds West, along the north
2 line of said Gibbs tract and generally along a fence part-way, a
3 distance of 435.15 feet to a point in the east right-of-way line of
4 State Highway No. 66 for the northwest corner of said Gibbs tract;
5 THENCE North 01 degree 48 minutes 07 seconds West, along the east
6 right-of-way line of State Highway No. 66, a distance of 709.10 feet
7 to a point for the beginning of a tangent curve to the right, from
8 which a TxDOT concrete monument is located South 01 degree 48
9 minutes 07 seconds East, a distance of 1.41 feet;
10 THENCE Northeasterly, continuing along the east right-of-way line
11 of State Highway No. 66 and along the curve to the right which has a
12 chord that bears North 16 degrees 29 minutes 34 seconds East for
13 440.72 feet, a central angle of 36 degrees 35 minutes 22 seconds and
14 a radius of 702.00 feet, for an arc distance of 448.30 feet to a
15 point for the end of said curve, from which a TxDot concrete
16 monument is located South 03 degrees 50 minutes 05 seconds West, a
17 distance of 1.41 feet;
18 THENCE North 34 degrees 47 minutes 15 seconds East, continuing
19 along the easterly right-of-way line of State Highway No. 66, a
20 distance of 986.53 feet to a point for the beginning of a tangent
21 curve to the left, from which a TxDOT concrete monument is located
22 South 01 degree 40 minutes 43 seconds East, a distance of 1.69 feet;
23 THENCE Northeasterly, continuing along the easterly right-of-way
24 line of State Highway No. 66 and along the curve to the left which
25 has a chord that bears North 16 degrees 59 minutes 08 seconds East
26 for 486.72 feet, a central angle of 35 degrees 36 minutes 15 seconds
27 and a radius of 796.00 feet, for an arc distance of 494.64 feet to

1 the end of said curve;
2 THENCE North 00 degrees 49 minutes 00 seconds West, along the east
3 right-of-way line of State Highway No. 66, a distance of 1270.15
4 feet to a 1/2-inch iron rod found for the northwest corner of said
5 50.44 acre tract and the southwest corner of Luby Acres, an addition
6 to the Town of Fate according to the plat thereof recorded in
7 Cabinet B, Page 2 of the Map Records of Rockwall County, Texas;
8 THENCE North 88 degrees 12 minutes 44 seconds East, along the south
9 line of Luby Acres, a distance of 1739.21 feet to the southeast
10 corner of said Luby Acres;
11 THENCE North 01 degree 11 minutes 30 seconds West, along the west
12 line of said Fate Land tract, and the east line of said Luby Acres, a
13 distance of 750.20 feet to a 1/2-inch iron rod found for the
14 northeast corner of said Luby Acres;
15 THENCE North 01 degree 20 minutes 58 seconds West, continuing along
16 the west line of said Fate Land tract, a distance of 1327.26 feet to
17 a 1/2-inch iron rod found for the northwest corner thereof;
18 THENCE North 88 degrees 42 minutes 34 seconds East, along the north
19 line of said Fate Land tract, a distance of 2111.82 feet to a point
20 for the northeast corner of said Fate Land tract;
21 THENCE South 01 degree 20 minutes 57 seconds East, a distance of
22 2869.76 feet to a point in the northwest right-of-way of the Union
23 Pacific Railway (100' right-of-way);
24 THENCE South 46 degrees 07 minutes 06 seconds West, along the
25 northwest right-of-way line of the Union Pacific Railway, a
26 distance of 1290.89 feet to a point for corner;
27 THENCE North 89 degrees 57 minutes 29 seconds West, a distance of

1 1167.48 feet to a 5/8-inch iron rod found for corner, said rod being
2 the southeast corner of said 15.004 acre tract;

3 THENCE South 01 degree 11 minutes 30 seconds East, along the east
4 line of said 119.34 acre tract, a distance of 1101.83 feet to a
5 point in the northwest right-of-way line of the Union Pacific
6 Railway (100' right-of-way) for the southeast corner of said 119.34

23 under Section 59, Article XVI, Texas Constitution, and Chapter 313,
24 Government Code.

25 (b) The governor, one of the required recipients, has
26 submitted the notice and Act to the Texas Commission on
27 Environmental Quality.

1 (c) The Texas Commission on Environmental Quality has filed
2 its recommendations relating to this Act with the governor, the
3 lieutenant governor, and the speaker of the house of
4 representatives within the required time.

5 (d) All requirements of the constitution and laws of this
6 state and the rules and procedures of the legislature with respect
7 to the notice, introduction, and passage of this Act are fulfilled
8 and accomplished.

9 SECTION 4. This Act takes effect immediately if it receives
10 a vote of two-thirds of all the members elected to each house, as
11 provided by Section 39, Article III, Texas Constitution. If this
12 Act does not receive the vote necessary for immediate effect, this
13 Act takes effect September 1, 2005.
