- (b) At the confirmation and initial directors' election, the temporary directors shall have placed on the ballot the name of any candidate filing for an initial director's position and blank spaces to write in the names of other persons. A temporary director who is eligible to be a candidate may file for an initial director's position.
- (C) Section 41.001(a), Election Code, does not apply to a confirmation election held as provided by this section.
- (d) Except as provided by this section, a confirmation election must be conducted as provided by Sections 36.017(b)-(i), Water Code, and the Election Code.
- (e) If the district is confirmed at the election, temporary directors, at the time the vote is canvassed, shall declare the qualified person who receives the most votes for each position to be elected as an initial director for that position and shall include the results of the initial directors' election in the district's election report to the Texas Commission on Environmental Quality.
- FIRST ELECTION OF PERMANENT DIRECTORS. Sec. 8817.023. On the first uniform election date prescribed by Section 41.001, Election Code, in November of an even-numbered year that is at least six months after the date on which the district is authorized to be created at a confirmation election, an election shall be held in the district for the election of three permanent directors to serve a term expiring November 15 following the first election under Section 8817.052 and four permanent directors to serve a term expiring November 15 following the second election under that section.
- Sec. 8817.024. EXPIRATION OF SUBCHAPTER. This subchapter expires September 1, 2010.

SUBCHAPTER B. BOARD OF DIRECTORS

SUBCHAPTER C. POWERS AND DUTIES
Sec. 8817.101. GENERAL POWERS AND DUTIES. Except as provided by Section 8817.006, the district has all of the rights, powers, privileges, authority, functions, and duties provided by the general law of this state, including Chapter 36, Water Code, applicable to groundwater conservation districts created under Section 59, Article XVI, Texas Constitution.

Sec. 8817.151. LIMITATION ON TAXES. The district may not levy ad valorem taxes at a rate that exceeds five cents on each \$100 of assessed valuation of taxable property in the district.

SECTION 2. (a) The legal notice of the intention to introduce this Act, setting forth the general substance of this Act, has been published as provided by law, and the notice and a copy of this Act have been furnished to all persons, agencies, officials, or entities to which they are required to be furnished under Section 59, Article XVI, Texas Constitution, and Chapter 313, Government Code.

- (b) The governor has submitted the notice and Act to the Texas Commission on Environmental Quality.
- (c) The Texas Commission on Environmental Quality has filed its recommendations relating to this Act with the governor, lieutenant governor, and speaker of the house of representatives within the required time.
- (d) All requirements of the constitution and laws of this state and the rules and procedures of the legislature with respect to the notice, introduction, and passage of this Act are fulfilled and accomplished.

SECTION 3. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2005.
