

HOUSE CONCURRENT RESOLUTION

1 WHEREAS, The passing of Dr. John Larry Walker on October 6,
2 2004, at the age of 64, brought a great loss to all those who knew
3 and loved this esteemed Paris physician; and

4 WHEREAS, Born on February 14, 1940, in Blossom, Dr. Walker
5 was Blossom High School valedictorian and earned a basketball
6 scholarship to Tyler Junior College, where he was a member of the
7 Phi Theta Kappa honor society and received the Watson Wise trophy
8 for distinguished service; he went on to graduate cum laude from
9 Austin College and then attended The University of Texas
10 Southwestern Medical School in Dallas, graduating in 1966 and
11 earning the Alumni Association Scholarship award; and

12 WHEREAS, He served this nation as a captain in the U.S. Air
13 Force at Kelly Air Force Base, San Antonio, and with a Red Horse
14 engineering unit in Thailand during the Vietnam War; and

15 WHEREAS, In 1969, he began his medical practice in Paris and
16 became one of the city's most distinguished physicians over the
17 course of his nearly 40 years of service as a practitioner of
18 general medicine and as chief of staff at St. Joseph's Hospital; and

19 WHEREAS, A dynamic presence in the medical field, Dr. Walker
20 demonstrated outstanding leadership and judgment as president of
21 the Lamar-Delta Medical Society and as a delegate to the Texas
22 Medical Association; in addition, he maintained membership in the
23 Paris Family Physicians group and was certified by the American
24 Board of Family Practice; and

1 WHEREAS, Dr. Walker also devoted his time and energy to a
2 number of worthy civic organizations, serving on the founding
3 boards of Lamar County Young Life, the Paris Education Foundation,
4 and the Lamar National Bank and as director of the Lamar County
5 Chamber of Commerce, as a member of the Rotary Club, and as a
6 volunteer physician at Agape House; and

7 WHEREAS, He was a valued congregant at the First United
8 Methodist Church, where he taught Sunday school classes, served on
9 the administrative board and the finance committee, and was a
10 member of the Methodist Men and the chancel choir; and

11 WHEREAS, Dr. Walker was a man of compassion and
12 understanding; although his warmth and wisdom are gone from us now,
13 his remarkable spirit will surely live on in the hearts of the many
14 people whose lives he touched during his time on this earth; now,
15 therefore, be it

16 RESOLVED, That the 79th Legislature of the State of Texas
17 hereby honor the life of Dr. John Larry Walker and extend deepest
18 sympathy to the members of his family: to his wife of more than four
19 decades, Ginna Walker; to his daughters, Callie Walker Thompson and
20 her husband, Bobby, and Jennifer Walker McDonald and her husband,
21 Don; to his son, Steve Walker and his wife, Christie; to his
22 grandchildren, Matt and Lauren Thompson and Sarah Kathryn and
23 Elizabeth Walker; to his mother, Allene Walker; to his brothers,
24 Mike Walker and his wife, Marty, and Tim Walker and his wife, Karen;
25 and to the many other friends and relatives of this beloved
