1 WHEREAS, Memories of a life filled with joyful moments and 2 meaningful accomplishments may help to comfort the family and 3 friends of Frances Ellis, who passed away on December 25, 2004, at 4 the age of 91; and

WHEREAS, Born on January 8, 1913, in Greenville, Mrs. Ellis 5 6 attended Wesley Junior College and earned her bachelor's degrees in Latin and English from East Texas State Teachers College and in home 7 economics from Texas State College for Women; for several years, 8 she was a home demonstration agent in Red River, Cass, and Lamar 9 Counties; she eventually became a news columnist for The Paris 10 News, and initiated the first weekly radio broadcast by a home 11 12 demonstration agent in Texas; and

13 WHEREAS, For more than 45 years, this esteemed Texan devoted 14 herself to beautifying and improving Lamar County; she was instrumental in landscaping the front lawn of Paris Junior College, 15 the downtown plaza, Bywaters Park, and numerous other sites around 16 the city; she was also actively involved in community projects and 17 18 organizations, including the YWCA, the Paris Rotary Club, the Garden Club, the Lamar County Home Economics Association, the Maxey 19 Museum, First Methodist Church, the Mary Emma Bible Study Club, the 20 21 public library, and county health and advisory boards; moreover, 22 she served on the Texas Governor's Committee on Aging and as a delegate to the National White House Conference on Aging in 1971; 23 24 and
