RESOLUTION

1 WHEREAS, The passing of Dr. Charles Trevathan of Abilene on 2 October 12, 2004, brought a great loss to the family and friends of 3 this trusted and admired gentleman, and it is most appropriate to 4 remember him at this time; and

5 WHEREAS, Dr. Trevathan was born to Clara and Norman Trevathan 6 in St. Louis, Missouri, on April 17, 1936; he graduated from David 7 Lipscomb University in 1958 and earned a law degree from the 8 University of Louisville School of Law in 1961; while attending law 9 school, he married the former Phyllis Murray at East Main Street 10 Church of Christ in Murfreesboro, Tennessee; and

11 WHEREAS, Following a brief stint in the U.S. Army in the early 12 1960s, Dr. Trevathan began a 25-year career practicing law in 13 Kentucky; his interests later turned toward the field of education, 14 and in 1987 he was named associate general counsel at Abilene 15 Christian University; and

16 WHEREAS, From 1991 to 1997, Dr. Trevathan served ACU as vice 17 president for campus life, while maintaining his position as 18 associate general counsel; he joined the faculty as professor of 19 sociology in 1997, and his skill in the classroom was later 20 evidenced by his selection as ACU's Teacher of the Year in 2001; and

21 WHEREAS, Throughout his distinguished career as a lawyer and 22 educator, Dr. Trevathan enjoyed the love and support of his wife, 23 Phyllis, and his daughters, Carol, Julie, and Karen; he found 24 additional strength and sense of purpose through his affiliation
