RESOLUTION

WHEREAS, The certain knowledge of a life well lived may

2 temper the profound sadness brought by the passing of Walter Fred 3 Johnson, Sr., of Abilene on December 21, 2004, at the age of 88; and WHEREAS, Mr. Johnson was born on November 15, 1916, in the Rio 4 5 Grande Valley, and throughout his rich life, the Lone Star spirit of 6 hard work and independence guided him to leave a lasting mark on the 7 Texas banking industry and the Abilene area; and WHEREAS, After graduating from Lyford High School, Mr. 8 Johnson began his career in banking as a bookkeeper with the First 9 National Bank of Raymondville; his career was temporarily 10 interrupted by the outbreak of World War II, and this Army Air Corps 11 12 bombardier flew 44 combat missions in the European Theater, earning 13 the Distinguished Flying Cross for his heroism; and 14 WHEREAS, In 1954, Mr. Johnson arrived in his adopted home of Abilene, where he became the youngest president of Farmers and 15 Merchants National Bank, later renamed First National Bank of 16 Abilene; over the next two decades, he led that venerable 17 institution with great wisdom and vision, and many credit his 18 steady guidance for keeping the Texas banking industry on solid 19 footing during the postwar boom of the 1950s, 1960s, and 1970s; and 20 21 WHEREAS, This respected civic leader kept abreast of local 22 business affairs and encouraged prosperity in the community as president of the Abilene Chamber of Commerce; he also served as vice 23 24 president and director of the Texas Research League, campaign chair

- 1 for the Abilene Intercollegiate School of Nursing, and chair of an
- 2 important Taylor County citizen's committee that championed the
- 3 building of Abilene's city hall, civic center, airport, and zoo;
- 4 and
- 5 WHEREAS, Mr. Johnson shared his vast knowledge and expertise
- 6 with his colleagues as president of the Texas Bankers Association
- 7 and as a member of the National Advisory Committee of Comptroller of
- 8 the Currency, and he committed time to helping the less fortunate as
- 9 campaign chair of the Abilene United Way and as a member of the
- 10 board of the Hendrick Home for Children; and
- 11 WHEREAS, In 1973, Mr. Johnson helped to establish First
- 12 Abilene Bankshares, now known as First Financial Bankshares, a
- 13 multibank holding company; he served as board chairman until his
- 14 retirement in 1986 and remained on the board until 1992; and
- 15 WHEREAS, The keen business acumen and dedication
- 16 demonstrated by this notable Texan earned him a host of accolades,
- including recognition as the 1958 Abilene Citizen of the Year and as
- 18 the most-influential Abilenian, as well as honors from the United
- 19 Way and the local chamber of commerce; and
- WHEREAS, Above all else, Mr. Johnson was devoted to his large
- 21 and close-knit family, and his time on this earth was greatly
- 22 enriched by his inspirational partnership with his wife of 60
- 23 years, Virginia; and
- 24 WHEREAS, Those fortunate enough to have known Walter Johnson
- 25 will long remember him not only as one of Abilene's most influential
- 26 businessmen and civic leaders but also as a true Texas gentleman;
- 27 although he is greatly missed, his legacy lives on in the
