- 6 graduated from Texas Tech University and served with the U.S. Army
- 7 before earning a master's degree from Texas A&I University in 1971;

- 9 WHEREAS, This national debate champion began his career as an
- 10 educator, teaching in Edinburg, Weslaco, and Lubbock public
- schools, and at Houston Community College; he returned to school to
- 12 study law at Bates College of Law and the University of Houston and
- 13 received his license to practice in 1975; and
- 14 WHEREAS, That same year, Mr. Oxford re-established his
- 15 father's law firm, Oxford & Oxford, in Edinburg and began a
- 16 distinguished career that would earn him the lasting respect of his
- 17 clients and colleagues; a champion of the disenfranchised, he
- 18 became known throughout his community for his pro bono work and was
- 19 recognized by his peers as a skilled communicator and formidable
- 20 opponent in the courtroom; and
- 21 WHEREAS, Admitted to practice law before the U.S. Supreme
- 22 Court, the U.S. Court of Appeals, Fifth Circuit, and the U.S.
- 23 District Court and Southern District of Texas, Mr. Oxford was a
- 24 member of a host of organizations, including the American Bar

- 2 the Hidalgo County Appraisal District; he also served as the city
- 3 and school attorney for many area communities and was instrumental
- 4 in the incorporation of the city of Granjeno and his hometown,
- 5 Alton; he was a history buff and political enthusiast and was active
- 6 in the Democratic Party; a man of diverse interests, he also greatly
- 7 enjoyed sports and gardening; and
- 8 WHEREAS, Those fortunate enough to have known Brinkley Oxford
- 9 will remember his love of family and community, his admiration for
- 10 the law, and his delightful sense of humor; although he will be
- 11 greatly missed, he leaves behind a legacy of good works that will
- 12 continue to make a positive difference in the lives of innumerable
- 13 Hidalgo County citizens for years to come; and
