Vaca officially assumed the role of chair of 2 the board of directors of the Greater Dallas Hispanic Chamber of 3 Commerce (GDHCC) on March 1, 2005, marking only the sixth time that a woman has occupied that position in the chamber's 65-year 4 5 history; and 6 WHEREAS, A passionate advocate for education, Ms. Vaca led the GDHCC's scholarship fund-raising efforts for three consecutive 7 years, and in 2004, her work helped to generate a record \$325,000 8 for more than 150 local college-bound Hispanic students; she has 9 also previously served the chamber as vice chair, technology 10 11 committee chair, and procurement pavilion chair; and 12 WHEREAS, The chief executive officer of Pinnacle Technical 13 Resources, Inc., Ms. Vaca founded the company in 1996 as an 14 information technology services provider to the Fortune 500; today, Pinnacle's client base includes such industry leaders as Verizon, 15 AT&T, Citigroup, IBM, EDS, AOL, Pepsico, and Motorola; under Ms. 16 Vaca's able leadership, Pinnacle ranks among the fastest-growing 17 18 technology services firms in the Dallas-Fort Worth Metroplex, with approximately 350 employees across 15 major cities in the United 19 States; and 20 21 WHEREAS, Pinnacle has garnered innumerable awards, including 22 being named the top minority-owned, the top Hispanic-owned, and the 23 top female-owned business enterprise in the Dallas-Fort Worth area;

moreover, Ms. Vaca was named the National Hispanic Business Woman

- 11 Dallas, and she will undoubtedly be a strong advocate for the
