## RESOLUTION

WHEREAS, The family and friends of Luciano Flores were deeply
saddened by the passing of the distinguished former mayor of San
Marcos on June 27, 2004, at the age of 81; and

WHEREAS, Born on December 30, 1922, in San Marcos, Mr. Flores served in the United States Army during World War II in the Pacific theater, and while stationed in New Guinea, he was injured and then hospitalized in Manila; after returning to the United States, he cofounded the American G.I. Forum in San Marcos to help improve social and economic situations for Mexican Americans as well as give support to local military veterans; and

WHEREAS, Mr. Flores continued to work tirelessly to give a 11 12 voice to the underrepresented in his community, both as a city 13 council member from 1967-1973 and as the first Mexican American mayor for the City of San Marcos with his election in 1972; during 14 his mayoral tenure, Mr. Flores fought to bring about positive 15 social change and better educational opportunities for all members 16 of the community; he also helped to build streets in the south side 17 of town as well as a fire station, a sewage treatment plant, police 18 and court buildings, and a city hall; and 19

20 WHEREAS, In addition to being an exemplary public servant, 21 Mr. Flores was a devoted family man; he was married to Herminia 22 "Minnie" Lucio Flores for 57 years, and their enduring union was 23 blessed with two sons and two daughters as well as three 24 grandchildren; he was also a successful insurance agent with

3 WHEREAS, Dedicated to his hometown of San Marcos, Luciano 4 Flores worked diligently to promote the highest ideals of equality, 5 education, and social justice; although he will long be profoundly 6 missed by his family and friends, Mr. Flores has left behind a 7 legacy of good works that will endure for many generations to come; 8 now, therefore, be it
