RESOLUTION

1 WHEREAS, David Gockley is stepping down as general director 2 of Houston Grand Opera, ending a remarkable tenure that began in 3 1972 when he was 27 years old and has resulted in the development of 4 one of the nation's premiere opera companies; this occasion offers 5 a truly fitting opportunity to sing the praises of this talented 6 visionary; and

7 WHEREAS, Mr. Gockley joined the staff of HGO in 1970 as 8 business manager; two years later, he accepted the post of general 9 director and began the challenging, but rewarding, task of 10 elevating HGO from a relatively unknown regional opera company to 11 one of the country's most prestigious and progressive companies; 12 and

13 WHEREAS, Mr. Gockley came to Houston after pursuing vocal 14 studies at the renowned New England Conservatory; he studied conducting and composition at Brown University, and went on to earn 15 a master's degree from Columbia University Business School, which 16 presented him with the first Dean's Award for Distinguished 17 Professional Achievement; he has since received an honorary 18 doctorate of humane letters from the University of Houston and an 19 honorary doctorate of fine arts from Brown University, as well as 20 21 Brown University's William Rogers Award for professional achievement and extraordinary service to humanity; and 22

23 WHEREAS, Since he assumed its directorship, HGO has become 24 the nation's leading commissioner and producer of new works,

staging 30 world premieres and six American premieres; the company has garnered numerous accolades during his tenure, including a Tony Award, two Emmy Awards, and two Grammy Awards, and radio broadcasts of HGO performances are heard by more than five million listeners each year; and

6 WHEREAS, Mr. Gockley has dedicated himself to broadening the 7 market for opera in the greater Houston area, leading him to launch 8 the Community Connections Initiative and to develop an array of 9 innovations, such as OperaVision and the Multimedia Modular Stage; 10 he is also the co-founder of the Houston Grand Opera Studio, a 11 training program that has fostered the careers of several renowned 12 and beloved opera stars; and

WHEREAS, In addition to accepting the myriad challenges that 13 14 come with the directorship, Mr. Gockley has found time to serve as 15 president of OPERA America and as chairman of Houston's Theater District; he was also instrumental in the 1987 opening of the 16 17 Wortham Theater Center, the \$72 million state-of-the-art performing arts center that is home to Houston Grand Opera; and 18

WHEREAS, By combining his love of music, his keen business acumen, and his infectious enthusiasm, David Gockley has created a legacy of achievement of which he can be proud, and we wish him well in his new role as general director of San Francisco Opera; now, therefore, be it

RESOLVED, That the House of Representatives of the 79th Texas Legislature hereby commend David Gockley for his distinguished tenure as general director of Houston Grand Opera and extend to him best wishes for the future; and, be it further
