WHEREAS, Passionate about music, this talented Texan began playing the trumpet at the age of six and continued into his retirement years; he played in the Grand Prairie, Irving, and Garland Symphony Orchestras and served as the first president of the Richardson Community Band, of which he was a member for more than 20 years; and
