23 induction into the Texas Radio Hall of Fame; named Broadcaster of

2 Distinguished Service Award from the Rotary Club of El Paso, a 1999
3 Champion of Caring Award from United Way, and a 1996 LULAC
4 Humanitarian Award, among others; and

5 WHEREAS, The husband of Nita Bentley and proud father of
6 J. R. Phillips, Jim Phillips has earned the respect and admiration
7 of countless people for his exemplary service to the broadcasting
8 profession and his community, and he is most deserving of special
9 recognition; now, therefore, be it
