3 four decades, and their achievements have set a high standard of
4 civic engagement to which all may aspire; and

5 WHEREAS, Mr. and Mrs. David first arrived in their adopted
6 hometown in 1959, and since that time, this remarkable couple have
7 raised three sons, Darrell, Allen, and Earle Wade, and amassed a
8 record of public service that has earned them the respect and
9 admiration of all who know them; and

10 WHEREAS, Prominent in the field of real estate, S. D. David
11 has lent his time and talent to serve his fellow citizens in myriad
12 ways, having shared his leadership as president of the Canyon Dam
13 Area Chamber of Commerce, the New Braunfels Rotary Club, the
14 Wurstfest Association, the Greater New Braunfels Chamber of
15 Commerce, and more; he has also played a vital role in the economic
16 and civic development of this Central Texas town as a member of the
17 Charter Study Commission, as chairman of the Board of Equalization
18 for the New Braunfels Independent School District and the Comal
19 County Central Appraisal District, and as a director of the New
20 Braunfels First National Bank; and

3 Planned Parenthood, and the New Braunfels PTA; a life member of the

6 has been a fund-raiser for such worthy institutions as the
7 Sophienburg-New Braunfels Archives and Museum of History and the
8 Museum of Texas Handmade Furniture and Heritage Society, and her
9 nurturing wisdom and counsel have positively affected the lives of
10 countless artists, musicians, and young women; and

11 WHEREAS, For all she does in behalf of local organizations
12 and institutions, Mrs. David has been recognized with the Hall of
13 Honor Award and the Chair of the Board's Award for community
14 service; and

16 the Davids are valued members of St. Joseph's Anglican Church,
17 where he has served the congregation as a senior warden; and
