WHEREAS, The Texas Academy of General Dentistry (AGD) plays a 1 2 vital role in advancing excellence in dental care through its support and promotion of high-quality continuing dental education 3 (CE); and 4 5 WHEREAS, Established in 1961 as a constituent of the national 6 Academy of General Dentistry, the Texas AGD is the second-largest 7 dental organization in the state, with more than 2,400 members; and WHEREAS, The Texas academy provides outstanding educational 8 programs to its members through its 14 local components, through 9 the Lone Star Dental Conference, which it instituted in 1991, and 10 11 through its cosponsorship of speakers at the annual meetings of the 12 Texas Dental Association and the Southwest Dental Conference at 13 Dallas; the organization also reviews program providers and 14 approves those that meet the "14 Standards of Quality Continuing 15 Education"; and WHEREAS, Each year, in addition, the Texas AGD confers one of 16 the most prestigious awards a Texas dentist can receive, 17 18 designation as Texas Dentist of the Year; and

19 WHEREAS, Dentists who belong to the state academy are
20 required to meet the high standards set by the national AGD, which
21 mandates that members maintain 75 CE hours over a three-year
22 period, more than double the number of hours required by the State
23 Board of Dental Examiners for relicensure; and

24 WHEREAS, The AGD also bestows two distinctions on members who

- 1 meet the rigorous criteria of those ranks: Fellowship, for those
- 2 who have belonged to the AGD for at least three years, who have
- 3 completed 500 CE hours, and who have passed a rigorous examination;
- 4 and Mastership, for Fellows who have gone on to complete a
- 5 challenging course of hands-on study, totaling 600 CE hours, in 16
- 6 dental disciplines; and
- WHEREAS, At the annual meeting of the national academy in
- 8 2004, the admirable efforts of the Texas AGD and its members were
- 9 recognized with the Constituent of the Year Award; Website of the
- 10 Year Award; Public Information Award; and Continuing Education
- 11 Award of Excellence, Honorable Mention; and
- 12 WHEREAS, For more than four decades, the Texas AGD has
- 13 encouraged and facilitated the continuing education of general
- 14 dentists in Texas and contributed immeasurably to the outstanding
- 15 quality of oral health care in the Lone Star State; and
- 16 WHEREAS, Representative Aaron Pena has justly recognized the
- 17 Texas AGD by authoring this resolution in its behalf during the
- 18 Regular Session of the 79th Texas Legislature; now, therefore, be
