1 WHEREAS, The first graduation ceremony for Ed Brune Charter 2 School is taking place on May 24, 2005, providing a most welcome 3 opportunity to recognize the school's graduating seniors and the 4 Hill Country Youth Ranch; and

5 WHEREAS, The Ed Brune School and the Big Springs Ranch for 6 Children are part of the legacy of the late Oma Bell Perry and her 7 family, who settled the Upper Frio Canyon north of Leakey in 1930; 8 the great-grandniece of Stephen F. Austin, Ms. Perry envisioned a 9 place of healing for children in need to live alongside older, 10 retired citizens, fostering a grandparent-type relationship and a 11 reconnection between generations; and

12 WHEREAS, Ms. Perry deeded her beloved 7,000-acre ranch to the 13 Hill Country Youth Ranch in 1996, and three years later, the 14 intergenerational village, with grandparents' cottages adjoining each children's homestead, welcomed its first young residents; the 15 Ed Brune Charter School opened in the fall of 2001; perched on the 16 banks of the Frio River in the "country of 1,100 springs," the 17 18 school offers a beautiful and tranquil setting for the 65 students, grades six through 12, who are currently enrolled there; and 19

20 WHEREAS, Based in Ingram, the Hill Country Youth Ranch is a 21 nonprofit residential facility for children from across Texas who 22 have met with difficult obstacles in their lives; since its 23 inception, the ranch has been home to more than 700 boys and girls; 24 and
