

R E S O L U T I O N

1           WHEREAS, Glen Huse of Arlington retired from the Office of  
2 the Comptroller of Public Accounts on February 28, 2005, after a  
3 distinguished career that spanned nearly three decades; and

4           WHEREAS, Serving in the position of auditor in the Fort Worth  
5 field office, Mr. Huse earned the respect and admiration of his  
6 coworkers and of all those in the business community with whom he  
7 worked; and

8           WHEREAS, This graduate of Texas Tech University chose to  
9 dedicate his professional life to public service, a responsibility  
10 he assumed and carried with distinction; his commitment to the work  
11 of this state was evidenced daily by his unstinting diligence in the  
12 fair and equitable application of state tax laws and by his adamant  
13 belief that taxpayers be treated with dignity and respect; and

14           WHEREAS, A longtime resident of Arlington, Mr. Huse is a  
15 native of Lamesa, where his keen intelligence and strength of  
16 character were shaped by loving parents, Felix and Gertrude Huse,  
17 and by South Plains ideals that still favor hard work, honesty, and  
18 individual accomplishment; and

19           WHEREAS, Mr. Huse has maintained, and values, the friendships  
20 of his youth, when sweltering summer days were defined by cotton  
21 fields, hay bales, and roofing hammers, and cool summer nights were  
22 spent at the SkyVue outdoor theater in a Rambler station wagon that  
23 made innumerable circuits around the courthouse square; and

24           WHEREAS, In all of his endeavors, this devoted family man has

1 enjoyed the love and support of his son, Matt, and daughter, Lisa;  
2 he is known by friends, family, and colleagues for his unflagging  
3 work ethic, abiding honesty, generosity of spirit, and gentle sense  
4 of humor; and

5 WHEREAS, His outstanding personal assets and his memorable  
6 contributions to the work of the comptroller's office identify Glen  
7 Huse as an outstanding Texan and provide a true testament of a good  
8 man whose legacy will endure far beyond his tenure as a public  
9 servant; now, therefore, be it

10 RESOLVED, That the House of Representatives of the 79th Texas  
11 Legislature hereby commend Felix Glen Huse for his years of  
12 dedicated service in the Office of the Comptroller of Public  
13 Accounts and extend to him sincere best wishes for continued
