October 4, 1978, and graduated from Madison High School in San

12 Antonio; he enlisted in the Marine Corps Reserve on February 26,

14 before attending the School of Infantry at Camp Pendleton,

15 California, and the Combat Service Support School at Camp Lejeune,

WHEREAS, Assigned to Headquarters and Service Company, 4th

Reconnaissance Battalion, in San Antonio in December 2003, he was

activated in January 2005 and completed predeployment training at

20 Twentynine Palms, California; and

21 WHEREAS, Lance Graham's warm smile and gentle nature endeared

22 him to his family and a host of friends, and his thoughtfulness and

23 concern for others touched many hearts; following his deployment,

24 he became a pen pal of a third grade class, and rather than writing

- 3 WHEREAS, Standing six feet, five inches, Corporal Graham was
- 4 also known for his tremendous strength, an asset that stood him in
- 5 good stead during his volunteer work with the Selma and Bracken fire
- 6 departments; endowed as well with a joyful, adventurous spirit, he
- 7 was always ready to try something new, from painting water towers to
- 8 working on a fishing boat off the coast of Alaska; and
- 9 WHEREAS, Following a service attended by hundreds at
- 10 Northeast Bible Church, Corporal Graham was laid to rest in Fort Sam
- 11 Houston National Cemetery; his military awards include the Global
- 12 War on Terrorism Expeditionary Medal, the Global War on Terrorism
- 13 Service Medal, the Armed Forces Reserve Medal with Mobilization
- 14 Device, the National Defense Service Medal, and the Purple Heart;

- 17 assignment, Corporal Graham performed his mission with dedication
- and professionalism; his unfaltering devotion to duty, honor, and
