- 3 Management District. The board shall name the new district in the
- 4 resolution.
- 5 (b) The new district has the same powers and duties as the
- 6 Greater Sharpstown Management District.
- 7 (c) The territory of the new district is the territory
- 8 described by Section 2(2) of this Act. As of the date a resolution
- 9 under this section is adopted, that territory is not part of the
- 10 Greater Sharpstown Management District.
