8	holders who are required to complete continuing education under
9	Subsection (a) and to establish the content of that continuing

11	section, including rules under Section 301.303(c) for the approval

13	SECTION 3. Not later than June 1, 2006, the Texas State
14	Board of Medical Examiners shall adopt the rules required by

17	Nurse Examiners shall adopt the rules required by Section 301.306,
