2	relating to authorizing the use of approved nonsurgical methods to
3	sterilize dogs and cats.
4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subdivision (3), Section 828.001, Health and
6	Safety Code, is amended to read as follows:
7	(3) "Sterilization" means the surgical removal of the
8	reproductive organs of a dog or cat <u>or the use of nonsurgical</u>
9	methods and technologies approved by the United States Food and
10	Drug Administration or the United States Department of Agriculture
11	to <u>permanently</u> render the animal unable to reproduce.
12	SECTION 2. Chapter 828, Health and Safety Code, is amended
13	by adding Section 828.0035 to read as follows:
14	Sec. 828.0035. STATE BOARD OF VETERINARY MEDICAL EXAMINERS.
15	The State Board of Veterinary Medical Examiners shall:
16	(1) develop information sheets regarding surgical or
17	nonsurgical sterilization to be distributed by a releasing agency
18	to a new owner; and
19	(2) adopt rules requiring an animal that has been
20	sterilized under this chapter to receive an identification marker
21	in a manner authorized by the board.
22	SECTION 3. Subsection (c), Section 828.004, Health and
23	Safety Code, is amended to read as follows:
24	(c) A releasing agency may extend the deadline for 30 days

on presentation of a written report from a licensed veterinarian stating that the life or health of the adopted animal may be jeopardized by <u>sterilization</u> [surgery]. There is no limit on the number of extensions that may be granted under this subsection.

5 SECTION 4. Chapter 828, Health and Safety Code, is amended 6 by adding Section 828.0045 to read as follows:

Sec. 828.0045. NONSURGICAL STERILIZATION. A licensed veterinarian may use nonsurgical methods and technologies as labeled and approved by the United States Food and Drug Administration or the United States Department of Agriculture for use by veterinarians to humanely and permanently render a dog or cat unable to reproduce.

SECTION 5. Subsection (a), Section 828.005, Health and Safety Code, is amended to read as follows:

(a) Except as provided by Section 828.006 or 828.007, each new owner who signs a sterilization agreement under Section 828.002 shall deliver to the releasing agency from which the animal was adopted a letter signed by the veterinarian who performed the <u>sterilization</u> [surgery].

20 SECTION 6. Section 828.012, Health and Safety Code, is 21 amended by amending Subsection (a) and adding Subsection (c) to 22 read as follows:

(a) Surgery <u>or nonsurgical sterilization</u> performed in
accordance with this chapter must be performed by a veterinarian or
a full-time student of an accredited college of veterinary medicine
as provided by Chapter 801, Occupations Code.

27 (c) A person associated with a releasing agency may not

1	interfere with the independent professional judgment of a
2	veterinarian employed by or under contract with the releasing
3	agency.
4	SECTION 7. The State Board of Veterinary Medical Examiners
5	shall adopt rules as required by Section 828.0035, Health and
6	Safety Code, as added by this Act, not later than January 1, 2006.
7	SECTION 8. This Act takes effect immediately if it receives
8	a vote of two-thirds of all the members elected to each house, as
9	provided by Section 39, Article III, Texas Constitution. If this
10	Act does not receive the vote necessary for immediate effect, this
11	Act takes effect September 1, 2005.
